Introduction

Thank you to everyone who weathered the storm with us over the last several months.

Q2 has presented a lot of challenges. We experienced turnover, our financials dipped very low, and we experienced some board conflict. I am committed to righting the ship. I set three serious goals for us last quarter and we met two out of three: We worked towards ballot access (1) and defended our name and likeness (2), but our financial performance was not where it should be. We've instituted some major changes to fix things.

Major Changes

- 1) More fundraising activity. Many of you will be pleased to know that the Development Director and I have instituted direct mail appeals again. Our editorial calendar is jam-packed full of email appeals, news and events. We are planning two in person fundraisers and we've expanded the development team.
- 2) Staffing up. We've expanded our staff considerably. We've expanded development, operations, and PR, and we're about to expand tech support, too.
- 3) Customer Service. Many of the changes I've implemented are in response to the myriad of complaints we've gotten from affiliates and members about Civi problems, membership renewals, information, etc. I hear you. Staff has worked to answer as many of your requests as possible but we simply didn't have the manpower. That is about to change.

At the time of this report, we are no longer taking applications for the Operations Director position, but we are still in the interview process. We are not actively seeking a new Executive Director yet, but we have had a few casual interviews. We will not be filling that role until the rest

of staff is filled out and everyone is comfortable with their roles and feels good about how they are working and what they are trying to accomplish. As of now, we are off to a good start.

As we implement these changes, I want to reiterate my appreciation for the hard work that our staff and volunteers put in. We're running a large operation and it takes a lot of effort to keep things running.

National Party Activism

We've been busy making our voice heard:

Independent National Convention & United Independents: We co-sponsored the INC 2023 and met with many other liberty-minded individuals in Austin, TX. This relationship has turned into an opportunity to utilize their candidate and activism training courses, beginning Sep. 16 & 17.

Freedomfest: We shared the main stage with Hannah Frankman, Bret Weinstein and Maj Toure. We met with RFK Jr. to discuss libertarianism, and we held a fundraiser event where we announced Operation Warhawk Removal.

Porcfest: We networked with the broader liberty community in the home of the Free State Project, and provided a secondary stage to our presidential candidates and activists.

Platform Committee: The LNC needs to make its five (5) appointments plus ranked alternates if any by 12/31/23 as do the following states: Alaska, California, Florida, Illinois, Michigan, Nevada, New Hampshire, New York, Ohio, Pennsylvania, Texas, and Wyoming. The LNC appoints the interim Chair, and the Committee then elects its own Chair.

Upcoming Critical Dates

The calendar of critical dates leading up to the 2024 National Libertarian Party Convention is attached. The next critical date was May 2023 to make Bylaws Committee appointments, which we have already done. The next following critical date is 10/31/23 and notification of delegation allocation numbers. Resolution of the Libertarian National Committee Concerning the World Health Organization's Proposed Pandemic Treaty

WHEREAS the World Health Organization (WHO), an unelected global entity, has proposed a pandemic treaty that imposes upon individual sovereignty, personal freedoms, and the spirit of scientific inquiry;

WHEREAS this proposed treaty enables the WHO to dictate quarantine measures, enforce border closures, and mandate vaccine passports, undermining personal choice and liberty;

WHEREAS the WHO has shown a propensity to label dissenting viewpoints as "misinformation," threatening the core of scientific debate and discovery;

WHEREAS the WHO, through its flawed response to the COVID-19 pandemic, has demonstrated a serious lack of competence and transparency, thereby losing its credibility as a reliable health authority;

WHEREAS the lack of democratic accountability within the WHO creates a conducive environment for undue influence, corruption, and bureaucratic overreach;

WHEREAS the WHO's significant sponsorship from nations such as China, which have demonstrated different perspectives on human rights and individual liberties, poses a significant risk to the unbiased and efficient operation of the organization;

Report with Recommendations from the Investigatory Committee of the Libertarian Party on the Subject of Miguel Duque and the Divulgence of Distribution of Confidential Information

Presented to the LNC August 19, 2023

SECTION I - CONCLUSIONS/RECOMMENDATIONS

The investigatory committee finds that Miguel Duque did intentionally release confidential information to non-LNC members.

Given that Region 1 has already rendered a vote of "no confidence" against him, we recommend that the LNC censure Mr. Duque for the release of the memo "Confidential Memo to LNC," among other evidence gathered by this committee.

In the event that Mr. Duque has not or will not resign from the LNC, the investigatory committee recommends that Mr. Duque be excluded from all confidential matters until the end of his present LNC term.

SECTION II – GENERAL BACKGROUND

On August 14, 20023, an investigatory committee was formed by the National Libertarian Party Executive Committee by the following resolution:

"The appointment of an investigatory committee comprising Andrew Watkins and the regional representatives (excluding Miguel Duque) regarding potential preferral of charges for allegations of intentional violations of confidentiality by Miguel Duque to meet immediately

prior to the Saturday portion of the LNC Meeting in DC and report back to the LNC as the first item of business."

The content of this report contains our findings on the specifics of this matter, and recommendation for the LNC.

SECTION III – NDA INFORMATION

All members of the Libertarian National Committee sign an NDA titled "Mutual Confidentiality and Non-Disclosure Agreement," which prohibits them from sharing information labeled confidential.

As our NDA document puts it:

"Confidential Information" means any information concerning the Stated Purpose of this Agreement (whether tangible or intangible, printed, electronic, or otherwise) and items embodying such information (including graphics, photographs, samples, working models, and prototypes) at any time furnished by Discloser to Recipient or to which Recipient is otherwise exposed, whether before or during the term of this Agreement, including, without limitation, (a) electronic mail; (b) telephone and computer based conference calls; (c) files and information from LNC's "Raiser's Edge" database; (d) lists of, and the identities of, or information concerning votes, prospects, Discloser's customers, members, suppliers, or other business partners; (e) information concerning Discloser's business and business plans; (f) Discloser's marketing plans and materials,; (g) financial information concerning Discloser and its affiliates; (h) information concerning Discloser's trade secrets; (i) information from third parties that Discloser is obligated to treat as confidential,; and (j) information that is derived from Confidential Information (for example through testing, analysis or processing).

Miguel Duque submitted his signed NDA, agreeing to the above on November 27, 2022

All LNC members are bound to Article 7, Section 15 of the LP bylaws, which prohibit discussions of personnel, staff, and legal issues outside of executive session:

"The National Committee and all of its committees shall conduct all votes and actions in open session; executive session may only be used for discussion of personnel matters, contractual negotiations, pending or potential litigation, or political strategy requiring confidentiality."

This is a document to Angela McArdle from General Counsel on Oliver Hall regarding Fidicuary Duties of LNC Members and Management of LNC Staff. It contains information related to fiduciary duties under District of Columbia Law and LNC Bylaws and Rules Relating to the Management of LNC Staff.

Exhibit C (area for more information on item above):

Anonymous Member text from a party member asking LNC Secretary Caryn Ann Harlos, "Did you see this thing going around from Miguel yet"

Linked within the text message is a folder containing Exibit D, Exibit, E, Exhibit I, and Exibit J.

Confidential Memo from Angela McArdle, which contains a multitude of confidential information. The memo was marked as "Confidential" in the subject line, with the heading "Confidential - Off List - Staff."

Exhibit E (area for more information on item above):

In our interview with Mr. Duque, he admitted to having drafted this document.

This document, entitled ""START HERE The Takeover Has Failed SUMMARY by Miguel and Anna Duque," contains personnel information and direct quotes from executive session and other confidential information, including:

- Information under the header "The Special Meeting May 16" contains information from executive session:
 - O Staff information, including board concerns and performance matters
 - o Direct quotes from the meeting

- Information under the header "What's the Deal With Lainie?" contains general information on Executive Director Lainie Huston and the author's thoughts on her performance
- Information under the header "So What's Happening Now and What's the Deal With Angela" contains general staff/chair relationship information
- Under many headers, there are direct quotes taken from a combination of private conversations and confidential information in the other folders, such as verbatim quotes from Signal chats, tying the author of this document to the one privy to the information in those Signal chats.

Exhibit F (area for more information on item above):

The investigatory committee gained access to Mr. Duque's archived party inbox. We did not find any evidence that Mr. Duque used his email to forward any known confidential information directly, including the Confidential Memo to LNC (Exibit D). To arrive at this conclusion, we searched Mr. Duque's Sent Items folder, Trash, and attempted to run the Gmail Mail Recovery process.

Rather than forwarding the confidential email directly, we believe Mr. Duque used a different method to place the confidential email into the proton drive that was shared, such as saving it onto a storage medium and uploading it afterward.

Exhibit G:

At the beginning of the interview, Mr. Duque asked what the point of this interview/committee was. One committee member told him that it was to give him ample opportunity to give his side of the story, in accordance with Robert's Section 63, and to determine whether he had in fact shared confidential information."

In our verbal interview with Mr. Duque, he began by saying that many members of the LNC are guilty of leaking confidential information, and that the investigatory committee was a "kangaroo court." He noted that he disputed the existence of the committee. He also added that it was up to the members to judge the words and deeds of each board member. All of the proceedings, he said, should just be "instantly dismissed."

When asked whether his cell phone had been stolen at any point during the last year, Mr. Duque answered that it had not been.

Throughout the interview, Mr. Duque responded to many questions about whether he released classified information to non-LNC members with, "I don't recall."

Some examples:

Question: "Did you at any point release to any non-LNC members, including your wife, any confidential information that was marked confidential by this party?"

Answer: "I don't recall."

Question: "Do you feel remorseful?"

Answer: "I don't recall."

Question: "Did you distribute the proton URL to us to region chairs at any point?"

Answer: "I don't recall."

However, at other times, Mr. Duque gave indirect admissions that he did in fact build the proton folder that contained the confidential information.

However, several answer in particular implicated Mr. Duque in the release of the confidential information in question. Mr. Duque directly confirmed authoring the document entitled "START HERE The Takeover Has Failed SUMMARY by Miguel and Anna Duque" (Exibit E) by answering "yes." Within said document is various classified information, including confidential quotes from executive session meetings (see Exibit E for more details).

Secondly, in response to whether his cell phone had been stolen in the last year, Mr. Duque answered "no." However, Signal message screenshots between Mr. Duque/Angela McArdle and Mr. Duque/Kathy Yesincavich (Exibit I and Exibit J, respectively) clearly indicate that they have been taken from an Android phone of some kind with the cell service/battery indicator in the upper-right and a phone notification icon in the upper-left. They are also oriented in portrait mode.

At the end of the interview, Mr. Duque stressed that he bore no ill will toward the investigatory committee members.

 - I CONTACTED 3308 EXPIRED MEMBERS FROM THE YEAR 2022
 - 952 PEOPLE RESPONDED TO MY TEXT MESSAGES AND PHONE CALLS
 - 400 PEOPLE COMMITTED TO RENEW THEIR MEMBERSHIPS MANY OF WHICH SAID THEY WOULD UPGRADE THEIR MEMBERSHIP. EARLIER IN AUGUST I LOOKED THESE 400 PEOPLE UP TIN CIVI TO SEE WHO FOLLOWED THROUGH ON RENEWING, I FOUND THAT ONLY 80 OUT OF THE 400 HAD RENEWED SINCE OUR CONVERSATION. THIS IS WHAT I AM WORKING ON NOW.
 - 132 PEOPLE SAID THAT THEY SUPPORT THE LP BUT AS OF THE TIME OF CONTACT COULD NOT RENEW AT THAT TIME, MOSTLY DIE TO FINANCIAL CIRCUMSTANCES.
 - 39 PEOPLE CLAIMED TO CONSIDER RENEWING/RE-JOINING BUT TAKE ISSUE WITH SOCIAL MEDIA MESSAGING.

- 365 PEOPLE HAVE REFUSED TO RENEW THEIR MEMBERSHIPS. THE NOTES THAT I COULD COMPILE FROM EACH CONVERSATION I DID SO BUT MANY SIMPLY HUNG UP. WHILE A LOT OF THIS NUMBER AND THEIR CRITICISMS COULD BE CONSIDERED AS EXPECTED RAGE QUITS FROM LEFT AND BELT WAY LIBERTARIANS I WOULDN'T DEEM IT ALL THAT WAY. SEVERAL PEOPLE WHO WERE ON BOARD WITH THE MISES CAUCUS PRIOR TO RENO THAT RAILED AGAINST, FROM THEIR VIEW, IMMATURITY FROM THE TWITTER ACCOUNT. This report provides information concerning efforts to build and support Libertarian campus organizations.

1) I continue to respond to inquiries from people who want information about the LP campus outreach effort. As I mentioned in a previous report, I received very few inquiries about starting/supporting LP campus organizations during the 2022-2023 academic year. I have received no inquiries in advance of the start of the 2023-2024 academic year.

For many years I had the ability to edit the LP campus organizations webpage on LP.org. This ability allowed me to make changes quickly in response to requests by campus organizations and state party leaders.

In May I discovered that I no longer had this ability. After making inquiries, I was recently informed that access to the website is now limited to a small number of people, apparently out of a concern for website security.

While I understand the need for such security, I believe that restoring my ability to edit the campus organization webpage would improve response time to requests without compromising security.

- 2) I continue to assist state affiliates in their efforts to conduct outreach to high school and college students.
- 3) I continue to work with Students For Liberty (SFL) to build libertarian groups at high schools and colleges. (I am a member of the SFL Board of Advisors.) As usual, we must be careful in working with SFL to avoid jeopardizing SFL's 501c(3) status. I also continue to look for ways to work with Young Americans for Liberty (YAL).

As an aside, former LNC executive director Lauren Daugherty is no longer the YAL CEO. Jeff Frazee, YAL founder, now serves as CEO.

4) I have not heard recently from the Libertarian Youth Caucus. I hope to speak with Theodore Gercken (LYC chair) soon to discuss LYC activities for the upcoming school year.

5) The Association of Libertarian Educators (ALE) is planning various activities for the 2023-2024 academic year. In particular, we are considering participation in a "Professor to student funnel" program under development by Students For Liberty.

In addition, we intend to serve as a cosponsor of the 2024 LibertyCon organized by Students For Liberty. We are working with LibertyCon organizers to determine the financial commitment ALE will make and the associated benefits ALE and the LP will receive.

On behalf of the ALE Board of Directors, I wish to recognize the fine work of Andrew Hreha in providing assistance to ALE.
