CALL TO ORDER

The meeting of the Libertarian National Committee (LNC) was called to order at 9:07am on April 16, 2011 at the Sheraton Suites in Alexandria, VA.

ATTENDANCE

LNC Counsel Gary Sinawski was present for the April 16 proceedings.

LNC Executive Director Wes Benedict, Operations Director Robert Kraus, and Candidate and Affiliate Support Specialist Bob Johnston were in attendance.

CREDENTIALS REPORT AND PAPERWORK CHECK

There have been several changes in the makeup of the LNC since the previous LNC meeting:

- Region 3 Representative Rebecca Sink-Burris automatically vacated her seat on November 20, 2010 in accordance with LP Bylaws, Article 8.6, which state, "A National Committee member who fails to attend two consecutive regular sessions of the National Committee shall be deemed to have vacated his or her seat. The appointing body shall be free to reappoint the member who vacated the seat." Ms. Sink-Burris declined the option to be reappointed by her region. On 12/06/10 the LNC was notified that Region 3 had named Andy Wolf as their Regional Representative and Sam Goldstein as their Regional Alternate. Ms. Sink-Burris had been serving on the Advertising and Publication Review Committee as well.
- At-Large Representative David Nolan passed away on November 21, 2010, creating an At-Large vacancy which has not yet been filled. Mr. Nolan had been serving as chair of the Convention Oversight Committee and as a member of the Advertising and Publication Review Committee.
- Treasurer James Oaksun resigned on 12/30/2010, creating a vacancy in that position. Bill Redpath, who was already serving on the board as an At-Large Representative, was appointed by the LNC Executive Committee to fill the Treasurer vacancy on 12/30/2010. Mr. Redpath was already serving on the Executive Committee by prior appointment of the LNC, and he now continues to do so by virtue of his position as Treasurer. Mr. Redpath was the non-officer LNC member serving on the Audit Committee. When Mr. Redpath became an officer, he became ineligible to serve on the Audit Committee, automatically vacating that seat. The ineligibility arises from LP Bylaws Article 10.2, a portion of which states, "The non-officer members of the National Committee shall appoint a standing Audit Committee of three members with power to select the independent auditor. One member shall be a non-officer member of the National Committee and the other two shall not be members of the National Committee."
- Region 4 Alternate Don Wills resigned from his position on 01/15/11, creating a vacancy which has not yet been filled.

ADOPTION OF THE AGENDA

With an implied motion to adopt the Chair's proposed agenda, the following agenda amendments were offered:

- Without objection at Chairman Hinkle's request, the item regarding filling the at-large vacancies was repositioned from the New Business With Previous Notice category to become the first item after adoption of the agenda.
- Mr. Wiener moved to reposition the Ballot Access Petitioning Requirements item until after the 2011 Budget. After discussion, the motion was withdrawn with unanimous consent.
- Mr. Olsen moved to add an item as the last item in the New Business With Previous Notice category for Alternative Leasing Options. The motion was adopted without objection.
- Dr. Ruwart moved to delete the LP of Oregon item, but after discussion the motion was withdrawn with unanimous consent.
- Secretary Mattson moved to reposition the Executive Session item from the New Business Without Previous Notice category to immediately before the 2011 Budget item. The motion was adopted without objection.
- Mr. Wiener moved to insert a new Appointing Additional APRC Members item after the Filling At-Large Vacancies item. The motion was adopted without objection.
- Secretary Mattson moved to reposition the LP of Oregon item and the Affiliate Petition Form item from the Items Postponed From Previous Meeting category to the New Business With Previous Notice category. The motion was adopted without objection.

Mr. Karlan formally moved to adopt the agenda as amended, and it was adopted without objection.

FILLING AT-LARGE VACANCIES

Nominations were opened for filling the two At-Large vacancies on the board.

Ms. Visek nominated Randy Eshelman.

Mr. Craig nominated John Jay Myers.

Mr. Wolf nominated Rebecca Sink-Burris.

Mr. Wiener nominated Jim Gray.

Dr. Lark nominated Ross Scalise.

Mr. Flood moved to use approval voting for this election, and the motion was adopted without objection.

Without objection each candidate was allotted two minutes to address the board. Candidates Rebecca Sink-Burris, John Jay Myers, and Randy Eshelman spoke briefly regarding their nominations. Mr. Wiener spoke on behalf of Jim Gray. Dr. Lark, Mr. Flood, and Mr. McLendon each spoke on behalf of Ross Scalise.

After tabulation, Secretary Mattson announced the results. 16 ballots were cast, so 9 votes were required for election with a majority vote. The vote totals were:

Therefore, Rebecca Sink-Burris and Randy Eshelman were elected.

APPOINTMENT OF ADDITIONAL APRC MEMBERS

Advertising and Publication Review Committee (APRC) Chair Dan Wiener requested that the board appoint two additional members to the APRC. Mr. Wiener moved to appoint Ms. Sink-Burris and Mr. Karlan to the APRC. Mr. Eshelman volunteered to serve as well. There were no further nominations. With three candidates for two positions, the election was conducted with approval voting.

After tabulation, Secretary Mattson announced the results. 18 ballots were cast, so 10 votes were necessary to elect with a majority vote. The vote totals were:

Rebecca Sink-Burris 13 Dan Karlan 11 Randy Eshelman 13

All three candidates received a majority, but Ms. Sink-Burris and Mr. Eshelman were elected as the top two having received a majority.

REPORT OF POTENTIAL CONFLICTS OF INTEREST

Secretary Mattson reported that since the previous meeting, the following potential conflicts of interest were submitted:

<u>Wes Benedict:</u> I am a monthly pledger to the Libertarian Party of Texas and the Travis County, Texas Libertarian Party. I am also a monthly pledger to Marijuana Policy Project, and have made a contribution to the Randolph Bourne Institute (publisher of AntiWar.com), the Coalition for Free and Open Elections (publisher of Ballot Access News), and the Advocates for Self-Government.

<u>Guy McLendon:</u> is no longer the Vice-Chair of the Libertarian Party of Texas. He is a co-owner of a small web hosting company (CyberSquad) that has on occasion built websites for LP candidates on a for-profit basis.

<u>Stewart Flood:</u> is the chairman of the membership committee for The Bastiat Society, a member of the South Carolina Libertarian Party's State Executive Committee (representing Charleston County), and the current chairman of the Charleston County Libertarian Party, as well as the Secretary.

Mary Ruwart: is the acting Treasurer of the International Society for Individual Liberty.

Bill Redpath: In December 2010, he contributed \$1,000 to the Our America Initiative.

<u>Bill Redpath:</u> My wife & I attended an event, and took two guests, to an Our America Initiative event on February 12, paying \$100 for admission.

<u>Jim Lark:</u> On Feb. 6, 2011, I was elected to serve as Secretary of the Board of Directors of the International Society for Individual Liberty. (I served in the capacity as Acting Secretary from August 2010 until the election of ISIL Board officers on Feb. 6.)

Marakay Rogers: I am a county delegate to the Libertarian Party of Pennsylvania. I am also a former LPPA statewide candidate. I am the Pennsylvania coordinator of Outright Libertarians and am on the Outright ex comm. I am a former chair of the Green Party of Pennsylvania (yes I had a major shift on economic issues when I grew up and when I also discovered that the national GP ran on Stalinist lines) and a former PA delegate to the Green Party of the United States national committee. I left the Green Party in 2007.

Sam Goldstein: is Chair of the Libertarian Party of Indiana.

Kevin Knedler: is Chair of the Ohio affiliate.

Wayne Root: is Vice Chair of the Nevada Libertarian Party.

Without objection, the following reports of potential conflicts of interest were made verbally at this meeting rather than by email to the Secretary:

Rebecca Sink-Burris: has donated to Young Americans for Liberty at Indiana University.

<u>Dianna Visek:</u> is the Legislative Director of the Libertarian Party of Illinois and is Chair of the Champaign County Libertarian Party in Illinois.

<u>Stewart Flood:</u> reported that next week he will be filing 501(c)(3) paperwork for an organization that repurposes discarded government and military computers, refurbishing them, and putting them in labs in disadvantaged neighborhoods.

Andy Wolf: was recently elected Chair of the Libertarian Party of LaPorte County in Indiana.

Vicki Kirkland: is currently the Chair of the Libertarian Party of Florida and Vice-Chair of her county party.

OFFICER REPORTS

CHAIR'S REPORT

The Chair and board members discussed yesterday's tour of available real estate for a potential new headquarters office and progress on fundraising for a potential building purchase. The Chair reported about his recent media interview activity and planned future endeavors. The FEC lawsuit regarding the Barrington estate has been filed, and Orrin Grover continues his work against the Top-Two law in the state of Washington. The Chair is working with the Advocates for Self-Government to implement a plan to redirect people who take the World's Smallest Political Quiz on the Advocates' website and score in the libertarian quadrant to a screen asking if they'd like more information about the Libertarian Party.

TREASURER'S REPORT

Treasurer Redpath presented financial statements through March 31, 2011.

Dr. Ruwart moved to postpone 10 minutes of additional financial discussion until immediately before the Executive Session agenda item. The motion was adopted without objection.

No later than 45 days after each calendar quarter, The the Treasurer shall prepare a quarterly Treasurer's Report to be mailed to any sustaining member who either was a delegate at the most recent regular convention or requests such report.

No later than the end of each calendar month, the Treasurer shall prepare a monthly Treasurer's Report to the LNC reflecting the Party's financial position and the results of its operations through the previous calendar month. The report shall include at least the following:

- Statement of Net Assets with balances measured in dollars for each month of the current year and comparative year end balances for each of the past four years.
- Statement of Operations with activity measured in dollars for each month of the current year for each of the budgeted categories of revenue and expense, a projection or extrapolation to the end of the current calendar year, and comparative annual activity for the past four years
- Statement of Operations with activity measured in percentages for each month of the current year for each of the budgeted categories of revenue and expense and comparative annual activity for each of the past four years
- Statement of Operations with activity measured year-to-date in dollars for each of the
 <u>budgeted categories of revenue and expense</u>, a projection or extrapolation to the end of
 <u>the current calendar year</u>, a comparison with the current year budget, and comparative
 <u>annual activity for the past four years</u>
- Statement of Cash Flows with activity measured in dollars for each month of the current year and comparative annual activity for the past four years
- Statement showing average per donor metrics of revenue and cost of revenue for new donors versus existing donors for each month of the current year compared with at least one previous year. Fundraising effectiveness and efficiency measurements should be disclosed for each of the common methods of solicitation (i.e. direct mail, online, telephone, pledges, events, board solicitation, ED/chair solicitation, bequests, and other)
- Charts displaying monthly trends in cash balances net of liabilities, number of new donors and their average first contribution, and revenues by source
- A narrative analyzing the current financial state of the Party compared with the same time four years previous, variances with the adopted budget, prospects for the near future, and the financial aspects of goals being pursued by the LNC.

The Executive Committee shall exercise all powers of the LNC between LNC meetings except for the addition, deletion, or amendment of the LNC policy manual or amendment of the budget beyond the limits specified elsewhere in this Policy Manual. Notwithstanding, the LNC reserves the right to exercise its authority through electronic mail ballots.

Amend Section 1.04.1 <u>ELECTRONIC</u> MAIL BALLOT PROCEDURES: <u>Electronic</u> Mail Ballots ⁱⁱ

Mail-Electronic mail ballots shall not include an accompanying argument for or against passage of the motion. Notification of an electronic mail ballot shall be made by the Secretary by mail or by email electronic mail (if the recipient has provided the Secretary with an email address). An LNC Member may change his or her vote on an electronic mail ballot, provided that the change is signed, dated, and received by the Secretary by the deadline for return of ballots.

Amend Section 2.07.4 PARTY RECORDS: Electronic Mail Ballot Results

The Secretary shall report the results of <u>electronic</u> mail ballots at each LNC meeting immediately following those ballots.^{III}

The motion failed by a vote of 0-12.

The Secretary reported she has been working to facilitate the LNC goal of having all affiliate bylaws on file with the national party. The bylaws of many affiliates are readily available on their websites, but others require more effort to obtain. So far the Secretary has something from all affiliates except Arizona, Hawaii, Montana, and New Hampshire, though a few of those already received are known to be out of date. As we're at the end of affiliate convention season, it is likely that many affiliates have

¹ LNC is delegating its authority in accordance with Bylaw Article 8.1, which states "The National Committee may delegate its authority in any manner it deems necessary." In the absence of this rule, all authority would be retained by the LNC.

ⁱⁱ RONR page 2 footnote states: "Efforts to conduct the deliberative process by postal or electronic mail or facsimile (fax) transmission – which are not recommended – must be expressly authorized by the bylaws and should be supported by special rules of order and standing rules as appropriate, since so many situations unprecedented in parliamentary law may arise and since many procedures common to parliamentary law are not applicable."

LNC legal counsel Gary Sinawski had submitted a written report of his activities since the last LNC meeting and verbally addressed a few additional guestions from LNC members. No LNC action was taken.

At the Chair's suggestion, without objection at 12:08pm the LNC adjourned to 1:15pm for lunch.

STAFF REPORTS

Executive Director Wes Benedict presented his previously-submitted written staff report (included as Appendix A) and fielded questions from the board.

Dr. Lark moved to adopt the following resolution:

REPORTS OF STANDING COMMITTEES

AFFILIATE SUPPORT COMMITTEE

Vice-Chair Rutherford, as Chair of the Affiliate Support Committee (ASC) presented a verbal report and fielded questions from board members. He specifically highlighted the difficulty that the LNC has created by populating that committee with 10 members, which means the bylaws prevent the committee from meeting by teleconference. Potential solutions for this issue are being discussed with LNC members and the Bylaws Committee. He additionally expressed a preference that the LNC adjust the Policy Manual provision regarding the ASC to set a specific due date for the ASC's annual budget recommendations. No LNC action was taken.

AUDIT COMMITTEE

Aaron Starr as Chair of the Audit Committee reported that the Audit Committee has negotiated with Frye & Wolcott and has obtained a 2-year agreement to perform our audits at approximately the same rate as our previous engagements with them. The 2010 audit should be complete before the LNC's August 2011 meeting. The 2011 audit will be complete for presentation to the May 2012 convention. No LNC action was taken.

CONVENTION OVERSIGHT COMMITTEE

On behalf of the Convention Oversight Committee (COC), Secretary Mattson presented the following information:

- 1) The COC has negotiated and executed the contract for the 2012 convention with the Red Rock Casino Resort & Spa in Las Vegas.
- 2) The COC has collected proposals from approximately 30 hotels for the 2014 convention. In New Orleans the LNC adopted a motion that included the sentence, "...Therefore, the LNC shall decide the 2014 convention by the LNC meeting in August 2011, with all site-candidates submitted to the COC by May 10 of 2011." When the May 10 deadline passes, the COC will assemble the 2014 proposals for comparison and will begin the winnowing process so that the LNC can make a site selection decision at the August session.
- 3) The COC is in the early stages of planning the event details of the 2012 convention and invited board members to contribute potential event slogan ideas.

No LNC action was taken.

EMPLOYMENT POLICY AND COMPENSATION COMMITTEE

Mr. Wolf, as Chair of the Employment Policy and Compensation Committee, presented a verbal report on the committee's developing efforts to build from scratch the written policies tasked to them by the LNC Policy Manual. No LNC action was taken.

IT COMMITTEE

Mr. Flood, as Chair of the IT Committee, presented a verbal report. Work on implementing their recommended IP phone system will begin after the LNC adopts a budget authorizing the expenditures. No LNC action was taken.

OUTREACH COMMITTEE

Ms. Visek, as Chair of the Outreach Committee, presented a verbal report. No LNC action was taken.

BALLOT ACCESS REPORT

Treasurer Redpath discussed a ballot access report he had previously submitted in writing. No LNC action was taken.

ITEMS POSTPONED FROM PREVOUS MEETING

BALLOT ACCESS PETITIONING REQUIREMENTS

A motion postponed from the two previous LNC meetings came before the body again.

Mr. Wiener moved to substitute the following for the previously postponed motion:

Amend the Policy Manual to insert the following into Section 2.03 Financial Matters:

2) Ballot Access Petitioning Support Standards

Party expenditures for ballot access petitioning shall be for the purpose of qualifying for the ballot the Party's Presidential and Vice Presidential nominees or Sustaining Members in statewide races.

No state affiliate shall be eligible for Party financial support for petitioning unless it first presents a credible plan under which it will gather at least half the signatures or half the projected funds (or any proportionate combination thereof) needed to complete the petitioning. Disbursement of Party funds may begin after the affiliate has gathered at least one quarter of the signatures or one quarter of the projected funds (or any proportionate combination thereof).

The Party's financial support to a state affiliate for ballot access during a two-year election cycle shall not exceed an amount equaling its number of electoral votes multiplied by:

- \$2,000 in the case of the Presidential and Vice Presidential nominees; or
- \$1,000 in the case of any other office.

Party funds may only be encumbered if a determination is first made by the Party that such an amount is sufficient in the remaining time available to qualify the candidate or affiliate for the ballot. An encumbrance determination may be made in advance contingent upon the affiliate meeting specified eligibility requirements.

Party funds may not be encumbered if total encumbrances are calculated to cause the Party to have less than the targeted Reserve.

This standing rule may be suspended in individual cases by a majority vote of the LNC – either at a meeting or by mail ballot – or by consent of the Executive Committee with no more than one dissenting vote, if such suspension is predicated upon a written finding which explains with specificity why a suspension is necessary.

Proviso: This standing rule will not apply to any previously approved ballot access encumbrance by the Executive Committee.

Mr. Wolf moved to substitute the following language for the Mr. Wiener's new language shown immediately above:

No ballot access expenditure shall be made for an affiliate without a written plan setting forth the history of the past 3 election cycles for that race, a plan for the use of funds, and a plan for follow-up and review. Said plan shall be submitted to the LNC no fewer than 14 days prior to the date the funds are needed.

The motion to substitute Mr. Wolf's language for Mr. Wiener's new language failed.

The motion to substitute Mr. Wiener's new language for the postponed motion was adopted, making Mr. Wiener's proposal shown above the main motion.

Voting on the main motion:

Voting nay: Eshelman, Flood, Karlan, Kirkland, Lark, McLendon (for Craig), Olsen, Redpath, Root,

Rutherford, Ruwart, Sink-Burris, Visek, Wolf

The motion failed by a vote of 3-14.

POSTPONED DISCUSSION OF FINANCIAL REPORTS

Discussion continued about financial reports.

Dr. Lark moved to amend the agenda to recess for 5 minutes, then take up LP of Oregon agenda item, the Affiliate Petition Form agenda item, the Lifetime Memberships agenda item, take another recess, and then go into the Executive Session agenda item. After discussion, the motion was withdrawn with unanimous consent.

At 4:57pm Mr. Karlan moved to enter executive session to discuss employee compensation and a matter pertaining to a particular member. The motion was adopted unanimously.

The LNC rose from Executive Session and continued in open session at 6:09pm.

Treasurer Redpath moved to adjourn to 8:30am tomorrow. The motion failed.

2011 BUDGET

Treasurer Redpath moved to adopt the 2011 budget proposal prepared by staff.

Mr. Flood moved to amend the budget proposal to add a line item below Net Operating Surplus for \$15,000 of Capital Expenditures for the IP telephone system, computer equipment, and other IT expenditures recommended by the IT committee. The amendment was adopted.

Treasurer Redpath moved to amend the budget proposal by increasing the Administrative Expense by \$2,000 to allow for depreciation expense. The motion was adopted without objection.

Ms. Visek moved to amend the budget proposal to decrease Board Solicitation Major Gifts from \$200,000 to \$110,000.

Mr. Olsen moved to amend the Visek amendment by striking \$110,000 and inserting \$150,000. The motion failed for lack of a second.

Vice-Chair Rutherford moved the previous question. The previous question motion was adopted. The Visek amendment was adopted.

Mr. Olsen moved to amend the proposed budget as follows:
change Ballot Access Donations from \$0 to \$60,000
change Ballot Access Fundraising Expense from \$0 to \$12,500
change Ballot Access Petitioning Related Expense from \$0 to \$47,500

Mr. Wolf moved to adjourn to 9:00am tomorrow. The motion to adjourn was adopted at 7:03pm.

The LNC re-convened at 9:06am on April 17, 2011.

Treasurer Redpath moved to suspend the rules to consider a motion to adopt a budget showing only a total revenue of \$1.4 million and leave it to the Executive Director, the Chair, and the Treasurer to determine the allocation and report that allocation back to the LNC in a couple of weeks. The motion to suspend the rules failed.

Ms. Visek moved to substitute the following for the Olsen amendment:

Amend the budget proposal to increase Ballot Access Petitioning Expense from \$0 to \$60,000. Proviso: Ballot access expenditures for 2011 shall only be authorized by the Executive Committee, and the total expended cannot exceed the budgeted amount.

The substitution was adopted, making the Visek motion the primary amendment to the budget proposal. The Visek amendment was adopted.

Secretary Mattson moved to amend the budget proposal by inserting new line items for the donorrestricted categories of Campus Outreach donations and Building Fund donations with \$0 in each. Mr. Flood moved the previous question, which was adopted. The Mattson motion was adopted.

Mr. Craig moved to amend the budget proposal to insert an expense item called Slush Fund X for \$100,000. The motion failed for lack of a second.

Secretary Mattson moved to amend the amount in summary line 55 - Brand Development from \$52,000 to \$0. After discussion, without objection the Mattson motion was amended to strike \$0 and insert \$10,000 instead. Mr. Wiener moved the previous question, which was adopted. The Mattson motion as amended was adopted.

Mr. Wiener moved to amend the budget proposal to set Compensation to \$381,000 to maintain the 2010 levels. Mr. Karlan moved to amend the Wiener motion to instead set Compensation to \$412,000. Dr. Lark moved the previous question, which was adopted without objection. The Karlan amendment to the primary amendment was adopted, so the primary amendment became to set Compensation to \$412,000. Dr. Lark moved the previous question, which was adopted without objection. The primary amendment was then adopted.

Chairman Hinkle moved the previous question to proceed to a vote on adoption of the budget proposal as amended. The previous question motion failed.

After further debate the LNC proceeded to a vote on the main motion of adopting the budget proposal as amended, shown below:

LP of OREGON

Dr. Ruwart, M Carling, and Secretary Mattson all spoke on developments in the LP of Oregon. No LNC action was taken.

AFFILIATE PETITION FORM

Mr. Karlan moved that the LNC adopt an affiliate petition form to comply with the Libertarian Party Bylaws, Article 6.2, which includes the following:

"Organizations which wish to become state-level affiliate parties shall apply for such status on a standard petition form as adopted by the National Committee, which petition shall be signed by no fewer than ten members of the Party residing in the appropriate state."

Secretary Mattson moved to amend the first paragraph of the proposed form by striking "and certifying that we are members of the national Libertarian Party do hereby" and inserting "and individually certifying that each of us opposes the initiation of force to achieve political or social goals, hereby".

The Mattson amendment was adopted so that the first paragraph of the proposed form now would state:

"We, the undersigned, being residents of the	e state of	and individually certifying that each of
us opposes the initiation of force to achieve	political or social goals	, hereby petition the Libertarian
National Committee to charter	as the state-level affilia	ate of the Libertarian Party for the
state of ."

The affiliate petition form was adopted by a vote of 12-5.

LIFETIME MEMBERSHIPS

Mr. Knedler moved to amend Section 2.05.3 of the Policy Manual regarding "Membership Policies: Life Membership Status" as follows:

A member who contributes at least \$1,000 during any twelve month period who makes a one-time contribution of at least shall be granted life membership in the Party.

Proviso: This amendment shall take effect July 1, 2011.

Mr. Flood moved to refer the motion to a new committee which will report back a recommendation at the August 2011 LNC meeting.

Mr. Karlan moved to amend by striking "at" and inserting "by". The amendment was adopted without objection, making the pending motion now to refer the motion to a new committee which will report back a recommendation by the August 2011 LNC meeting. The motion to commit was adopted as amended.

Without objection this special committee was populated with Mr. Root, Dr. Lark, Mr. Wolf (committee chair), Mr. Knedler, and Mr. Flood.

RESCIND EC AUTHORIZATION FOR BALLOT ACCESS ENCUMBRANCES

Mr. Olsen moved that the authorization provided to the Executive Committee "to encumber expenses for ballot access, notwithstanding the provisions of section 1.05 of the Policy Manual, for the year 2011" at the November 2010 National Committee meeting is hereby rescinded in full for the remainder of 2011.

The Olsen motion failed for lack of a second.

NEW BUSINESS WITHOUT PREVIOUS NOTICE

ALTERNATIVE LEASING OPTIONS

Mr. Olsen moved:

"The Committee hereby instructs staff to prepare for its evaluation at the August 2011 meeting not less than three alternatives to the current leasing arrangement with the Watergate complex. Alternatives presented should include sufficient detail to enable the committee to properly evaluate the political and economic effects of an actual relocation such as an estimate of relocation expenses for each alternative. At least one of the provided alternatives shall be a location within a major metropolitan area other than Washington DC; such metropolitan area being chosen as representative of economic efficiencies available in metropolitan areas other than Washington DC."

Voting on the main motion:

Voting aye: Olsen

<u>Voting nay:</u> Craig, Eshelman, Karlan, Kirkland, Knedler, Lark, Mattson, McLendon (for Flood), Redpath, Root, Rutherford, Ruwart, Sink-Burris, Visek, Wiener, Wolf

The motion failed by a vote of 1-16.

LP SPEAKERS' BUREAU

Mr. Knedler explained that he would like to create a comprehensive list of people willing to be guest speakers at party events, make the list available to state chairs, and categorize the speakers by topics of specialty. He requested discussion between now and the August LNC meeting. No LNC action was taken at this time.

Mr. Root's travel plans made it necessary for him to depart during this agenda item.

SMALL AFFILIATE FUNDRAISING

Mr. Flood introduced Mark Bodenhausen (Chair of the Libertarian Party of Alabama) to address the challenges of raising funds in small affiliates. Discussion ensued, but no LNC action was taken.

RESOLUTION REGARDING STEVE GORDON

Without objection the LNC allowed consideration of a motion by Dr. Lark to adopt the following resolution:

"The Libertarian National Committee expresses its best wishes to Steve Gordon, former Political Director and Communications Director of the Party, and offers its hope for his rapid recovery."

The motion was adopted without objection.

OBAMA IMPEACHMENT RESOLUTION

Chairman Hinkle moved to adopt the following resolution:

"Whereas President Obama is engaging in acts of war in Libya;

And whereas Congress has not declared war on Libya per the U.S. Constitution Section 1.8;

And whereas the U.S. Constitution is the supreme law of the U.S.;

And whereas President Obama has violated the U.S. Constitution;

Therefore, the LP calls upon the U.S. House of Representatives to impeach President Obama for violating the law and his oath of office."

After some discussion, Secretary Mattson moved the previous question, which was adopted.

Voting aye: Hinkle, Knedler, Lark, McLendon (for Craig)

Voting nay: Eshelman, Karlan, Mattson, Olsen, Ploeger (for Flood), Rutherford, Sink-Burris, Wiener

Abstaining: Kirkland, Redpath, Ruwart, Visek, Wolf

The main motion failed by vote of 4-8.

UNIFIED MEMBERSHIP PLAN III

Without objection this agenda item was taken up before the Liberty Sales Team. Chairman Hinkle presented a conceptual plan for a new incarnation of a Unified Membership Plan, but no LNC action was taken at this time.

LIBERTY SALES TEAM

Chairman Hinkle presented a conceptual plan for establishing a commission-based reward system for recruiting new party members, but no LNC action was taken at this time.

ANNOUNCEMENTS

LSLA UPDATE

Since the Libertarian State Leadership Alliance (LSLA) meeting planned for Seattle in early 2011 had been cancelled by LSLA Chair Rachel Hawkridge, Mr. Knedler, who was selected by the state chairs as an event coordinator for a replacement event, updated the LNC on plans for a re-scheduled LSLA meeting to occur in Columbus, OH on Friday, August 19, 2011. The cost to attend is \$35, which includes a box lunch. Practical, internal party building will be the focus of the event. On Friday from 6-8pm will be a reception with LNC members, as the LNC meets in the same location the following two days.

REGARDING APPOINTMENT OF PLATFORM COMMITTEE

Secretary Mattson announced that at the August LNC meeting she intends to request an agenda item to appoint Platform Committee members. She will work with staff to write an appropriate announcement to notify the party membership of the timeline, and she requested that staff print such announcement in the next LP News edition.

THANKS FROM NEW MEXICO AFFILIATE

Mr. Olsen, the Region 4 Representative, indicated that the legal difficulties faced by the New Mexico affiliate had been resolved. He conveyed appreciation from the Libertarian Party of New Mexico for the LNC's assistance in making that happen.

ADJOURNMENT






















Executive Director's Report, submitted by Wes Benedict

Overview

I started as Executive Director on July 17, 2009. My focus has been to improve fundraising, increase membership, cut costs and recruit candidates.

We have more "money in the bank" than at any time going back through 2002.

Our previous staff report had extensive details on the 2010 election results. This report focuses on membership and finance.

Key Results:

- Financial turnaround: 2009 net surplus: \$85,367. 2010 net surplus: \$140,961.
- Membership: "Active Donors" count has been fairly steady, but not growing.
- <u>Pledge growth</u>: Monthly pledge recurring revenue increased from \$20,854 (June 2009) to \$32,022 (March 2011), providing a stable revenue stream for the future.
- Recent operational upgrades: servers, PCs, video production, archive storage room.

2011 LNC Goals

Goals adopted per the LNC Minutes - New Orleans, LA - November 20-21, 2010 Page 15-16 http://www.lp.org/files/2010-11-20-LNCMeetingMinutes-NewOrleans.pdf

The LNC is considering adopting a budget to meet these goals.

Goal Status:

1. Membership: 20,000 sustaining members by April 15, 2012

STATUS: According to March 2011 membership report, 13,705 sustaining members (as defined in bylaws).

- 2. Organization: Operational affiliates in 48 states (out of 51 "states"). Defined as:
- a. Runs at least 2 candidates for non-partisan or partisan office every 2 year election cycle
- b. Has a REAL web site (not a Meetup Group or Blog) that is updated with news or meeting info at least once per month
 - c. Has a Chair or Contact Person who responds to most inquires within 2 business days
 - d. Place candidates on the ballot and attempt to maintain ballot access.

e. The affiliate will provide the latest copy of their bylaws and constitution to the national office or post the same on their state website.

STATUS: 31 of 51 (as of 2/5/11)

3. Fundraising: \$1,400,000 gross revenue for calendar year 2011.

STATUS: \$300,528 (3/31/2011 year-to-date revenue)

4. Training: Several seminars around the country in 2011 to include training on winnable and party-building campaigns, and training that teaches affiliate development

STATUS: One scheduled (LSLA Conference August 19, Columbus, Ohio). LNC will need to clarify what events count towards this goal.

5. Political:

a. 200 U.S. House of Representative candidates in 2012

STATUS: List of 2012 U.S. House candidates has not been created yet.

b. 200 elected Libertarians by Apr 15, 2012 (for the purpose of this goal, Inspectors and Judges of Elections in Pennsylvania only count as 1/3 of an elected Libertarian)

STATUS: According to this formula, there are 157 2/3 elected Libertarians as of 4/12/11.

c. 30 state ballot access by Apr 15, 2012 (that means actually certified by the SOS or equivalent), which puts us in position for 45 or more state ballot access by Election Day 2012.


STATUS: Unknown. According to December 2010 Ballot Access News, count is 27. However, some states may not have issued an actual certification yet. For example, under Texas law the SOS will not issue a certification until summer of 2012.

Financial Results


Financial details are in the Treasurer's reports which are separate from this report.

Our 2010 revenue was \$1,472,218, which exceeded the original 2010 budget of \$1,138,000 that was adopted 12/5/09. The 2010 budget was later adjusted \$180,000 higher during the year, to \$1,318,000.

The LNC has not yet adopted a 2011 budget.



Revenue for the first three months of 2011 is at \$300,524. A simple extrapolation for the full year yields (12/3)x\$300,524 = \$1,202,096




Reserve Adequacy. Our efforts to increase revenue and decrease costs have improved our Reserve Adequacy. From the Policy Manual:

"Reserve" is calculated as the total cash balance less the sum of all restricted funds and accounts payable at month end. The targeted Reserve (from the budget) shall be equal to the sum of all monthly occupancy, labor and governance expenses.



Fundraising

We increased monthly pledge revenue from \$20,854 in June 2009, to \$32,022 in March 2011.



Overall the House Appeal Fundraising letters are doing well. The low revenue 1005-HO was an urgent-gram-style letter that did not go to any people who had donated in 2010 (monthly pledgers, convention attendees, other donors). The 1009-HO advertised the promotional materials: door hangers, stickers, and T-shirts. I had expected it to raise more, but considering we also advertised these heavily via email and LP News, and lots of people went online to order more quickly, the results are understandable. 1102-HO was recently released, so it is too early to predict how it will perform. It's common for people to mail in donations in response to letters many months after receiving the mail. So, the bars in the chart below, towards the right, will continue rising.



Prospecting

While several small prospecting efforts were made in some years, one major prospecting appeal was sent in each of 2008, 2009, and 2010. Those results are below. Most of the data comes from the Board Reports presented in each staff report.

Along with help from Art, I personally prepared the "1005 PR" appeal, which strongly outperformed the 2008 and 2009 efforts (which were sent before I was hired).

The Net Cost per Donor of \$19.66 is an important number. It's an indication of how much it would cost to "buy" new members.

Telemarketing

In July, we started a contractor, Bob Johnston, making membership renewal calls. It's difficult to assign exact credit for who renewed for what reason. For example, if someone renews online, it could be because they received a call, or an email, or for other reasons. However, I believe Mr. Johnston is more than paying for himself and our membership would be hundreds lower if not for this renewal phoning effort. Mr. Johnston also recently took on the monthly pledge calling and candidate and affiliate support.

Below are some notes with phoning statistics from Mr. Johnston:

I have been contacting former members who had not renewed their memberships 7-10 days into the month after their memberships expired.

I will try to contact each person on the phone a maximum of 4 times. If I have not been successful, I will leave a message, if possible. I will also follow up with an email, if possible.

I have called and emailed to each of the renewal lists from April, 2010 to January, 2011. I haven't yet sent out the emails to the February list.

To summarize, there is a 1-in-3 chance I can speak with you on the phone.

If we speak, there is a 60% chance you will renew or commit.

Of those who commit, 2/3 will renew.

If I can't get you on the phone, and I can leave a voice and/or email message, there is a 9% chance you will renew after leaving a message.


Elected Libertarians

The list of elected Libertarians was not maintained before I started. Now it is up to date and posted on LP.org. The total number continually changes as new elected Libertarians are found and others are removed for various reasons. After the November 2009 elections we counted 143 elected Libertarians. Currently we list 161.


Previous lists from the early 2000's that reported in the 600 range contained both elected and appointed officials and also contained lots of officials whose terms had expired. Later the LNC set the policy of counting elected officials separately.

Membership

Paid memberships (which we call "Active Donors") reached a peak around the year 2000, steadily declined until 2006, and have been somewhat stable since 2007.

Staffing

Since the November meeting, two paid internships have ended. Full-time staff member Kyle Hartz left. Steve Palubinsky, who was a former intern, worked part-time but has since left. Nigel

Lyons was hired to focus on video production. So now there are five full-time, one part-time, and two contractors.

Having lost Mr. Hartz recently, we are currently especially weak in the areas of inquiry response, volunteer response, on-line social networking (Facebook, etc.), and our internship program has been suspended.

I've been hesitant to add staff until the LNC decides on a budget. If the budget allows, I would consider adding one or more full or part-time staff to focus on:

- 1) inquiry response
- 2) publications
- 3) publicity
- 4) campus organizing
- 5) volunteer coordination
- 6) social networking
- 7) intern program

Director of Operation's Report

Blackbaud - Data Dumps - Internal Customer Service

With the help of Geoff Neale and Nick Dunbar, over the President's Day weekend we upgraded all of our servers at HQ, replacing three old file servers and one old SQL server with one new Dell file server and one new Dell SQL server. In addition, we upgraded to the latest version of RE, now running RE-7.92.

This involved a capital expenditure of \$8,600, which was booked on 2010. Staff is asking for about the same amount for the 2011 budget to replace our 1980's Meridian phone system, with a goal of having a new one in place by October. We are likely to see a savings of \$700 per month for a hybrid digital type system (such as Panasonic Avaya or Star to Star) where we purchase our hardware/software outright (hence the \$8,500 request in the budget). For a 100% hosted VOIP solution (like Broadview or Speakeasy - with no capital outlay - where equipment is paid for on a month-to-month basis or included in the contract) we would still see about \$300 a month in savings. Either way we would reduce our fixed monthly costs while getting superior service.

With the new server set up and the upgraded RE, we have seen a 50% or greater improvement in speed running reports, queries and exports. Some reports (like our daily "Gift Detail and Summary Report") that used to take several minutes to produce now only take a few seconds. As another example, the total RE Database Backup used to take about 6 hours to run and now only takes 25-30 minutes.

In terms of data clean-up efforts, with Arthur DiBianca's help, we have been able to clean up and remove over 49,000 bad emails from RE. Also, earlier this year we completed a NCOA (Change of Address) update and identified around 3,800 forwardable moves and almost 5,000 invalid addresses.

We also continue to see improvements with data updates from states (special thanks as usual to the LPOH which sends us both new member and data corrections weekly). In addition, the LPNH, LPNE, LPVA, LPSC, LPRI and LPIN also continue to regularly send us updates. (Some of these states have an automated process due to their use of Alicia's excellent membership management program.) We would still like to see more sharing of information and re-encourage regional reps to have their state membership directors send us their updates often.

Art continues to be doing a superb job at maintaining the list of emails within Sparklist and continues to be instrumental in aiding with other data management issues.

FEC Filing

We continue to file accurate FEC reports and use Paula Edwards to complete the FEC filing process on a monthly basis and handle our amendments. The reconciliation and audit steps to this process continue to work to assure that these reports are correct prior to filing, and to insure that the disbursements and contributions match to our cash accounting records.


As a reminder, the FEC reports are done on a cash basis while our financial reports are done on an accrual basis as required by our bylaws which require adherence to GAAP. Therefore, our Statement of Operations will not always look the same as what is reported on the summary page of our FEC filings.

Financial

We continued efforts to control and maintain our expenses and accounts payable. We also continue to operate with a surplus. Looking at March preliminary results, we can report that we have been in the black for two of the first three months so far of this year.

As you can see on the below chart, we continue to build up a decent cash reserve (the top light gray line – the black thick line is our targeted reserve) and we are in a better position than we were prior to (and after) the last three conventions. A relatively small part of this, of course, was due to the annual disbursement from the

Burrington Estate – but another factor is that we continue to get additional new major donations. For example, since the last meeting in November we have received over \$59,300 in major donor contributions (\$1,000 or more). All of our major donors receive a phone call or email personally from Mark Hinkle thanking them for their support (one of which recently resulted in an additional \$5,000 donation).



Human Resources

Staff changes include the addition of Nigel Lyons in January and Kyle leaving us in February. Please refer to Wes's report for full information.

1. Lyris Email Delivery

Currently, our Lyris list has about 95,500 "active" recipient addresses. This number has been pretty stable since August 2010. The rate of attrition of old emails is roughly equal to the rate we're adding new emails.


According to Lyris's reports, most of our mass emails have more than 99% successful delivery.


Since 2009, we have identified and resolved many problems involving delivery to different email providers.

From June 2009 to March 2011, the average number of **successful deliveries** per mass email increased from 54,556 to 95,338. (75% increase.)

From June 2009 to March 2011, the average number of **unique opens** per mass email increased from 5,956 to 12,907. (117% increase.)

Each point in these graphs represents a mass email (such as a Monday Message).


As of April 12, 2011, our list has 161 elected officials.

Region 5S Representative, Libertarian National Committee

This report will provide some information concerning efforts to build and support Libertarian campus organizations. I shall provide an updated report at the LNC meeting in Alexandria should additional information become available.

- 1) I continue to respond to inquiries from people who want information about the LP campus outreach effort. I am usually able to respond within 24 hours of receiving an inquiry.
- 2) I continue to work with the Advocates for Self-Government to provide material (e.g., "Operation Politically Homeless" kits) to campus organizations. (In the interest of full disclosure, please note that I am the chairman of the Board of Directors of the Advocates.)
- 3) I continue to work with various state and local LP organizations to assist their campus outreach efforts. I shall speak at the Libertarian Party of Florida convention on May 1; I hope to speak to campus activists during my visit. I plan to contact the chairs of our state affiliates prior to the end of May to provide information to them about campus outreach activities for the Fall 2011 semester. I have spoken to Pat Dixon (chair, Libertarian Party of Texas) and Danny Bedwell (chair, Libertarian Party of Mississippi) about visiting their states during the fall to assist campus organizing efforts.

I have given speeches at various schools during the spring semester, including the Catholic University of America in February and the University of Virginia in March. In addition, I gave an address at the fourth annual Students For Liberty International Conference at George Washington University in Washington, D.C. on Feb. 19.

4) I continue to work closely with Students For Liberty to promote libertarian groups at high schools and colleges. (I am a member of the Board of Advisors of SFL.) As part of this effort, members of the SFL board and I have found ways for the LP to use the many services available from SFL. We must be careful in so doing because we do not wish to jeopardize the 501c(3) status of SFL.

In addition, I serve as chair of the Student Libertarian Alumni Committee (SLAC). This organization assists Students For Liberty by promoting SFL among libertarians and helping to raise funds for SFL.

I continue to conduct "webinars" for SFL; for example, I conducted a webinar entitled "Warning: Governmentally-Mandated Safety Measures May Be Hazardous to Your Health" on Jan. 31. I am pleased to report that evidently the webinars have been well-received. As mentioned above, I gave an address at the SFL International Conference in February.

5) I continue to work with Young Americans for Liberty (YAL) on programs of mutual interest.

APPENDIX C CAMPUS ORGANIZING REPORT

- 6) As mentioned in previous reports, several liberty-oriented organizations (e.g., Cato, Reason Foundation, Institute for Humane Studies, Foundation for Economics Education) are working to coordinate their student outreach programs. I participate in meetings of representatives of these organizations when my schedule permits.
- 7) As mentioned in previous reports, I believe it would be helpful to hire an LPHQ staff member whose duties would include campus/youth organizing tasks, or at least to assign a staff member to campus organizing tasks on a quarter-time or half-time basis. I believe we should consider this as we discuss budgetary matters at the upcoming meeting.

April 2011 LNC Meeting Region 1 Report

Alabama

The Alabama state party has reported that they are having significant difficulties raising funds to meet their current financial obligations.

Arkansas

The Arkansas State Convention was held on April 9th, 2011, at the Comfort Inn in Downtown Little Rock, 707 Interstate 30. Featured speakers included Dr. Mary Ruwart, R. Lee Wrights and Bill Redpath.

Ballot access status: as of April 4, 2011, \$35,000 has been raised and the state party has collected two thousand of a goal of fifteen thousand raw signatures. Ten thousand valid signatures required. The starting date for signature collection was March 28, 2011. There is a ninty day window in which they must complete the process and submit the signatures.

California

California held its state convention on April 9th and 10th at Harrah's in Stateline, Nevada, at which time it elected officers for two-year terms, including re-electing Kevin Takenaga as state chair. Speakers included Steve Greenhut, an *Orange County Register* columnist and editor of Pacific Research Institute's *CalWatch*; Carlos Rodriguez, an author and expert on immigration issues; Judge James Gray, talking about the marijuana situation and other liberty issues; Tad Lumpkin and Harold Uhl, discussing their production of *The American Dream*; John Stagliano as the banquet speaker, describing his acquittal in his recent federal pornography trial; Richard Winger, describing new developments in the legal battle against Prop 14; and Steve Kubby, discussing a new marijuana initiative for 2012.

Despite the passage of Prop 14, California will retain official ballot status until at least November, 2014 based on the success of several statewide candidates in receiving at least 2% of the vote in November, 2010 (including Pamela Brown, who got 5.9% for Lt. Governor). This will keep the Libertarian Party's Presidential candidate on the ballot in 2012. After that, unless Prop 14 is overturned, it will require achieving a registration threshold which will fluctuate but is presently 103 thousand registered Libertarian voters. Current LP registration is 91 thousand, so during the next three years that must be increased by at least 12 thousand plus an adequate margin. According to Richard Winger, the lawsuit against Prop 14 holds considerable promise, but the State of California is trying to run up litigation costs as a way of defeating the challenge.

Georgia

Fundraising for the Libertarian Party of Georgia in the first quarter of 2011 ended up as the highest quarter on record. This year's convention was ten times as profitable as last year's. Both the State Party Chairman and Treasurer were re-elected to serve another term of office.

Membership is also rising, having recently surpassed 300 members. This is a nearly one third increase from 227 members at the beginning of 2010.

Thirty State Party members were nominated this year for Lights of Liberty Awards, including at least three for Triathlon awards. The last time that the Libertarian Party of Georgia was honored to have members nominated for Lights of Liberty was in 2005 (2003 for Triathlon awards).

Jeff Sexton (the Libertarian Party of Georgia's Legislative Director), has consistently issued Legislative Updates for every week of this session, identifying and reporting "the good" and "the bad", as well as an "action item" for each week. These reports are delivered every week by email to members of the state party, the media, and libertarians throughout the country who have expressed an interest in following events in Georgia.

Last, but certainly not least, the Libertarian Party of Georgia is pleased to be able to report that last fall their candidates received more media coverage in the 2010 election season than ever before. The party is also receiving more coverage during the current legislative session than in past years.

Louisiana

The Louisiana Libertarian Party approved a motion to convene state conventions every 4 years, and will not be having a state convention this year. Changes will be made on their state website to reflect this change to a four year cycle.

Mississippi

The Mississippi State Convention is being held this Saturday, April 16, from Noon to 3PM, in Butler Auditorium in the Triplett Alumni Center on the Ole Miss campus in Oxford, MS. Featured speakers include MSLP's Chairman Danny Bedwell. The Keynote Speaker is author & Mississippi business leader Jack Criss.

The state party is starting to use the free web conferencing system YUGMA (<u>www.yugma.com</u>) to web enable state meetings.

Oklahoma

Ballot access House bill #1058, supported by Rep. Charles Key, passed the OK House Rules Committee by a 14-0 vote. State Party Chair Angelia O'Dell expects the bill to go to the floor for a vote. The bill would reduce the required signatures from 5% (over 100,000 signatures) to only 22,500 signatures. OKLP has a sponsor in the Senate for a comparable bill, and recently requested \$5,000 from the LNC to pay Mark Snyder, a former Republican senator, to lobby the Representatives & Senators in support of passage. The \$5000 was authorized during a teleconference of the LNC ExCommittee. The bill has passed the House floor by a vote of 69-17, and is now in "limbo" in the Senate waiting to go to Committee.

South Carolina

One of the county "clubs" of the South Carolina Republican Party recently lost a suit in which they attempted to have the courts close their party primaries. Changes to state election law have also been proposed by their party that may affect the manner in which all party conventions and primaries are held in South Carolina. The SCLP is watching the status of this legislation closely. At the present time no significantly adverse effects are anticipated, but it is possible that the bill may be modified while in Committee.

Texas

Texas legislature bill HB 418 was withdrawn on March 14, 2011. The bill would have imposed filing fees on third-party and independent candidates, resulting in an intimidating burden for these candidates on future ballots. The LP of Texas formed an impressive coalition to defeat this bill, and our members testified in opposition to the bill at the March 7 elections committee hearing.

Texas LP member John Spivey updated the hotel price quote for the Dallas Hyatt Regency at Reunion. The updated bid was submitted to the LNC by Guy McLendon on March 25, 2011.

During the April 9, 2011 ExCom meeting the State Party contracted with John Jay Myers to assist with fundraising. In addition, Guy McLendon was appointed to coordinate for Texas SLEC during the 2012 LNC region formation.

- When adjusted by the number of registered voters, five of the top ten LNC affiliates are Region 4 affiliates.
- Per Bob Johnston's survey, five of the nine affiliates in the region meet the current "active" criteria specified in
 the goals statement adopted in New Orleans. Of the four affiliates which do not meet the New Orleans criteria,
 none fail due to the lack of candidates on the ballot. As New Mexico recovers from its law suit battle, I
 comfortable the New Mexico will meet all criteria shortly after its April 16th annual convention.
- The New Mexico LP has expressed great appreciation for the financial assistance provided byt LNC is resolving the law suit. Many members are demoralized, but the process of rebuilding has begun.

Well, now the "Stipulated Final Order," which formalized the settlement agreement, signed by the plaintiff and our attorney on our behalf, and signed by the Judge on February 9, 2011, bringing to an end multiple suits and counter suits that have kept us busily occupied.

What follows, is a slightly abbreviated list of the clauses in the Stipulated Final Order, binding all parties to adhere to and comply with the stipulations therein. Again, this is a slightly abbreviated list, giving only the binding clauses. Places where it is shortened or paraphrased are indicated by being enclosed in [] brackets, rather than quoting it verbatim.

- The parties have released each other from all claims and causes of action which were or could have been asserted in [the applicable cases] and from all claims and causes of action which may have existed on January 11, 2011.
- Woodruff acknowledges and recognizes that the phrase "Libertarian Party" is trademarked and owned by The Libertarian National Committee, Inc.
- The parties agreed to enter a Court Order which grants the relief to which the parties agreed.
- Woodruff shall not assert claims against or bring any legal action against the individuals named in this case or against the Libertarian Party of New Mexico relating to political, social or election issues.
- Woodruff shall dissolve the limited liability companies named New Mexico Libertarian Party, LLC and Libertarian Party of New Mexico, LLC within 30 days of the entry of this Order
- Woodruff shall not claim to be associated with The Libertarian Party of New Mexico and shall not represent or claim to represent The Libertarian Party of New Mexico
- Woodruff shall not violate the trademark "Libertarian Party" owned by the Libertarian National Committee, Inc.
- None of the parties shall pursue any causes of action which were or could have been asserted in [the cases] or any causes of action which any party may have had against any other party as of January 11, 2011.
- In the event of a violation of this Order, which is brought before a Court of competent jurisdiction, the prevailing party shall recover attorney's fees and costs and shall be entitled to recover liquidated damages of \$25,000.00.
- All Orders previously entered in this case shall remain effective and enforceable.
- 2The First Amended Complaint, the First Amended Counterclaim and the Third Party Complaint are dismissed with prejudice.

That's it. All of the clauses bind Woodruff in one way or another; only a few apply to the LPNM and the individual who were named defendants in the cases.

We are not planning to spend any time on this during the upcoming LPNM Annual State Convention in April (see below). Rather, if you have questions, you can join us in the meeting room at the Quarters BBQ on Ellison Drive NW in Albuquerque (the same venue as the Convention), at 6:00PM (or whenever you get there, on Friday, April 15, 2011, the evening prior to the Convention proper, and we'll try to answer your questions then. Nuf said!

Report on Region 5N (Maine, Rhode Island, Connecticut, New York, New Jersey, and Oregon):

Maine: Nothing to report

Rhode Island: The leadership have been sending news releases, and there are regular gatherings across the state that have served to sustain interest and inform everybody that the Party is back.

Connecticut: The Annual Convention has been scheduled for May 7, in New London.

New York: The LPNY has filed suit regarding the election vote report of fewer than 50,000 signatures, arguing that this is an undercount.

New Jersey: The Annual Convention was held on March 12. Jay Edgar remains Chair.

Oregon: LPO tried to hold their Bylaws-required annual Convention on March 12. It failed to achieve quorum, and has been continued to May.

The official web site contains this report of the current state of the affiliate:

At the most recent State Central Committee meeting on March 31st, 2011, Salem, Ore., the committee voted to adopt a new set of governing documents and refer them to the registered libertarian voters of Oregon for eventual ratification.

For a number of years dues paying members, who were the only individuals allowed to participate in internal party functions, have been attempting to reform the existing party rules. However, due to the different factional battles, ultimately were unable to do so and arrived at a point where the membership could no longer meet quorum to meet and resolve these issues.

The State Central Committee explained its reasoning as a preamble to adopting a new constitution and bylaws.

The last time the membership successfully met and was able to conduct business was in March of 2010, where the party adopted a plan for reformation. Ultimately that plan was unable to be executed by the membership at the most recent November 2010 special convention, nor the recent regular convention in March of 2011.

The new party structure lowers the barriers to participate by providing the opportunity to participate by mail for all registered libertarian electors in Oregon in both the nominating process for candidates, selecting representatives to the State Committee and approving or rejecting changes to the party's constitution and bylaws.

Oregon voters will have an opportunity to ratify this new governing structure during the 2012 primary election cycle. Should they ultimately reject it, the previous governing structure will be restored, which includes: a Judicial Committee that has only one member, cannot meet, and cannot reach quorum; a membership that is unable to meet at convention due to an inability to achieve quorum; suspect bylaws that have still not been reconciled against minutes which have not been approved due to questionable accuracy; county party affiliates that cannot be represented due to technical deficiencies that cannot be remedied; a dues structure that has raised legal doubts; the ability for non-libertarians to participate which also raises questions of legality; and other numerous issues.

The first meeting of the new state committee is scheduled for April 19th and will consider alternative plans for May 21st when the members' convention was scheduled to meet again.

The Secretary distributed the following report on April 1:

Friends, relatives, libertarians, LPO reform is now a fait accompli.

All judicial committee positions became vacant on March 14, when the annual convention failed to draw a quorum. The State Committee yesterday opened the private club to over 13,000 registered Libertarian voters. Under state law, the "central committee" has authority to make and revise state party rules.

With no judicial committee, opponents' only possible appeals are to the courts (with a track record of washing their hands of our internal disputes) and the Oregon Elections Division, which considers the LPO State Committee the state party's central committee.

At their State Committee meeting March 31 -- not April 1 -- the governing body of the Libertarian Party of Oregon (LPO) adopted a new Constitution and Bylaws, abolishing dues and making all (and only) registered Libertarian voters in Oregon members of the state party. The LPO's new governing documents also replace the State Committee with a Board of Directors consisting of nine members appointed to serve until elections can be held. The new board will hold its first meeting on April 19 at the Village Inn in northeast Portland.

The party attempted to hold a special convention last November 6 to consider replacing its old Constitution and Bylaws with documents closely resembling the ones adopted yesterday. That

convention adjourned early, without conducting any of its scheduled business, because a quorum (majority) of dues-paid LPO members was not present.

The party's annual convention on March 12 also adjourned early for the same reason. That convention was supposed to elect new LPO officials and consider amendments to governing documents. Since it did not, incumbent officers (except state chairman Jeff Weston, who resigned following adjournment) retained their positions, with Vice Chair Wes Wagner automatically becoming Chairperson to fill the vacancy left by Weston.

The quorum rule, never applied to LPO conventions before last November, springs from a Bylaws amendment adopted at the party's 2009 annual convention, attended by just over a dozen people. That amendment required that "Robert's Rules of Order Newly Revised shall govern the LPO" in all but strictly limited circumstances.

The new party rules adopted yesterday do not specify a parliamentary authority such as Robert's Rules, but allow each LPO body to adopt its own rules of parliamentary procedure. The new rules also provide for a privately funded statewide Libertarian primary election to select the party's nominees for public office, and for the LPO's Board of Directors to be elected directly by registered Libertarian voters in each odd-numbered year.

Oregon election law allows any state party's "central committee" to adopt or revise that party's rules. The office of Oregon's Secretary of State, which controls the Elections Division, has long considered the LPO State Committee to be that party's central committee.

Yesterday's State Committee vote to adopt the new rules was 7-0 in favor. The meeting opened with 9 members present, but two who were apparently opposed left before the final vote was taken. One of those is reported to have assaulted another member (who then called police), leaving before police could arrive.

This report will provide information concerning activities of the Libertarian Party state affiliates in Region 5S since the LNC meeting on Nov. 20-21, 2010. I shall provide an updated report at the LNC meeting in Alexandria should additional information become available.

I am pleased to report that I have represented the LP in various ways since the previous LNC meeting. I appear regularly as a guest on WINA radio (1070 AM in Charlottesville) to discuss the Libertarian Party's perspective on current affairs. I appeared on Jerry Hughes' "Straight Talk" radio program (ARN radio network) on Jan. 12, and conducted a webinar ("Warning: Governmentally-Mandated Safety Measures May Be Hazardous to Your Health") for Students For Liberty on Jan. 31. I was quoted in an article about local property rights issues in the Feb. 15 issue of The Hook (weekly publication in Charlottesville). I gave a speech at the Catholic University of America in Washington, D.C. on Feb. 18, an address on campus organizing at the Students For Liberty International Conference in Washington, D.C. on Feb. 19, and an address (entitled "What Libertarians and Conservatives Can Teach Each Other") to the Burke Society at the University of Virginia on March 3.

Delaware

The Libertarian Party of Delaware held its annual convention on March 19 in Dover; I had the pleasure of attending the convention. Brad Thomas (bradct@verizon.net), a long-time activist and former LPD officer, was elected chair. The LPD county organizations held caucuses at the convention. Will McVay, who was elected vice chair at the convention, has invested a great deal of time and effort to monitor the workings of the state government.

District of Columbia

Kyle Hartz (kylejhartz@gmail.com), who until recently served as Development and New Media Assistant at LPHQ, serves as chair of the LPDC. I have not received a report from him as of this time.

Maryland

Libertarian Party of Maryland chair Bob Johnston (rstanley21018@yahoo.com) provided the following report:

The Maryland Libertarian Party's membership is 101. The number of registered voters, as of February, 2011, is 9,262.

MDLP vice-chair Muir Boda will be participating in the Salisbury City Council general election on Tuesday, 5 April. 6 candidates will be on the ballot, with the top 3 being elected to the council. This is Muir's second attempt at getting elected to the council. As of 1 April, he has the most money raised among the candidates.

The MDLP held its annual convention on Saturday, 12 March, at Squires Italian Restaurant in Dundalk. Speakers included LPPA activist and frequent candidate Ken Krawchuk, LNC region 5S representative and former LNC chair Dr. Jim Lark, MarylandReporter.com editor and publisher Len Lazarick, and Libertarian writer and blogger Jim Bovard.

The MDLP was notified this week by the state Board of Elections that it did not have the requisite number of petition signatures necessary to regain ballot access, thus was being decertified. The Maryland Green Party was also decertified, and will be involved with the MDLP in a lawsuit against the BOE, to overturn the strict petition standard. Both parties, and the Constitution Party, were able to get back on the ballot in 2006 and 2007, prior to the tougher standard coming into effect. We are trying to work with the BOE in preventing our registered voters from being disaffiliated, and if necessary, will file a separate lawsuit to deal with this issue.

Maryland Supplement #1

From Bob Johnston on April 10:

The Maryland Libertarian Party was decertified by the state Board of Elections, due to not enough petition signatures being valid.

The MDLP will be filing a lawsuit in Anne Arundel Circuit Court tomorrow, Monday. Mark Grannis, our 2010 candidate for the US House of Representatives 8th district, will be handling the case. Below are comments from Mark.

+++

The Maryland Libertarian Party's petition to renew its status as a recognized party with ballot access privileges was rejected by the State Board of Elections last week, after the State Board invalidated almost 9,000 of the 15,000 signatures we collected and submitted to the State. However, we have retained counsel and are preparing to challenge the count in state court. In the meantime, officials at the State Board of Elections have assured us that they will not be making involuntary changes to the party affiliations of registered Libertarians, as has sometimes happened in the past when our ballot access privileges temporarily lapsed.

We can be proud of the effort we made in support of our petition, as the MDLP turned in almost 15,000 signatures. However, the State Board originally validated only 3,815, for a rate of about 25%. This reflects the extraordinarily difficult validation standard announced by the Maryland Court of Appeals in 2008, a standard known as "the Doe standard." Among other things, the Doe standard had been interpreted by the State Board to require the invalidation of legal but illegible signatures, and to require the invalidation of many other signatures based on an insistence that voters use "full names" on the petitions even if they do not do so in other business or legal contexts.

However, on March 22, 2011 -- when the validation of our signatures was nearly complete -- the Court of Appeals largely repudiated the overly strict reading that the State Board had given to the Doe standard, and ruled that signatures should be validated and counted as long as each signer's entry, taken as a whole, contained sufficient cumulative information to determine that it represented the support of an identifiable registered voter. Attempting to implement this standard even before the Court of Appeals announced it, the State Board credited the MDLP with an addition 2,417 signatures, for a total of 6,232 (42%). We believe a more faithful interpretation of the new standard from the Court of Appeals would have resulted in many more valid signatures, and we are hopeful that courts will agree.

Mark Grannis of Wiltshire & Grannis, our candidate in the 2008 US House of Representatives 8th district race, will be handling the case both for us and for the Maryland Green Party, with assistance from John Rego of Anderson & Quinn in Rockville.

LNC Report for Region 6 Compiled by Dianna Visek

Iowa: no response

Illinois:

The LP-Illinois now has 1638 members, determined by those who sign our pledge. We just implemented a tiered membership structure with different levels of contribution, including a free membership. Our state has 13 active chapters and 8 which are forming, which together cover 37 of Illinois' 102 counties.

At our September convention, we restructured our internal divisions to be more effective. We recently hired a fundraising manager who works on commission and are in the process of redoing our website to incorporate social networking and other features. We are also working to build a better database system to help us manage members and contributors and analyze voter and election data.

Our next convention will be at the Chateau of Bloomington on Oct. 21-23. We will be having a booth at the Illinois State Fair in August, for the second time in our history. We try to send out 2-3 press releases each month, and some are printed or put online. Our chapters often work with C4L, tea parties and other liberty-minded groups.

We ran nine candidates in the local elections held on April 5 and three won. We hope to run district candidates in 2012 as well as our presidential candidate. We will need to raise \$60,000 to get on the ballot in 2012 and expect to ask the LNC for assistance. Our major difficulty is the need to collect 50,000 signatures in order to be safe from challenges.

Christina Tobin of Free and Equal recently persuaded a state representative to introduce a bill substituting filing fees for the signature requirement. Although this is a fantastic idea, we don't expect the power structure in Illinois to adopt it.

As a result of our petitions being challenged last summer, we have decided to pursue litigation in the off-years in order to improve Illinois' horrible ballot access laws. We have compiled a preliminary list of issues, which the Chicago office of the ACLU is currently reviewing. They seem most interested in litigating the number of signatures required to get congressional candidates on the ballot. If we had run candidates in all nineteen congressional districts in 2010, we would have needed to collect 278,885 signatures, whereas we only needed 25,000 for our entire statewide slate. If the ACLU decides to take our case, they will supply the attorneys and cover the general expenses. If they don't take our case, the LNC has budgeted \$15,000 to assist us.

Missouri:

The LP-MO currently has about 3000 members, as determined by those who fill out a membership form. Voting members are those who donate over a certain amount, run for partisan office or have served as a Libertarian Committeeperson within the past two years. There eight active chapters and two that are forming. The LP-MO feels its website has good content and functionality, but could be improved visually. Monthly pledges are down from a couple of years ago, but their cash position is good.

The LP-MO will be having its convention on May 21 at the Best Western Airport Inn and Conference Center in St. Louis, at which time all officers will be elected.

Missouri just finished local elections. Doug Burlison was re-elected to the Springfield City Council and Cape Girardeau defeated their smoking ban. Some younger liberty activists ran for non-partisan local office and worked on referendum issues with other liberty-minded organizations. The recent election brought them a good bit of media coverage.

The 2012 election will include most statewide offices as well as president. The LP-Mo is on the ballot through 2014. The law requires them to get 2% in a statewide race every four years, and both of their statewide candidates in 2010 got over 2% of the vote. Because they didn't run a candidate for state treasurer in 2008, the Constitution Party became established in that race and now tends to split the libertarian-leaning vote. The LP-MO has been on the ballot since 1992 and experienced a slight increase in votes in 2010. Their biggest problem at the moment is the difficulty getting candidates for state races due to the onerous filing requirements, which were made more difficult in the last legislative session.

The trends they see are that more citizens are waking up to the ad reality of our current government.

They would like the LNC to stop embarrassing the membership with factional infighting. They like the fact that the LP is no longer putting out commentaries that sound like they come from the Republican Party.

They would like the LP to create free or inexpensive website templates that candidates could use, similar to what CampaignSiteBuilder.com now offers. They would like a mildly competent candidate to be able to develop a website with the standard features.

Minnesota:

The LP-MN currently has about thirty members, with membership determined by paying a minimum of \$30 per year. Only members are entitled to vote at the state convention, which will be held on April 30 in Rochester. All offices will be up for election, and the party is working on a consensus for party goals. Membership has increased to the point that the party will soon no longer be able to meet in the chair's house, and there are now enough

members to take care of the major functions of the party. Rochester has recently formed a chapter and is holding regular meetings. There are four dormant chapters.

The LP-MN has been participating in gun shows and Tea Party events, where they find that 95% of the people tested are libertarian. Chair Bob Odden has a public TV cable access show called "Libertarian Viewpoint", which goes out to 90 cities in Minnesota. Their biggest problem at the moment is simply contacting members and those who have expressed interest in the party.

This year there will be scattered local elections, with a small filing fee to get on the ballot. One LP-MN member will be running for the St. Paul city council. Filing is in June with the primary in August.

Statewide elections require petitioning. The LP-MN will need 2000 signatures to get our presidential candidate on the ballot and thinks that the only way to improve ballot access would be through the legislature.

The party feels that citizens are becoming unhappy with the Republicans because they are beginning to understand that it is easy to say you're for freedom or will follow the U.S. and Minnesota constitutions without actually understanding them. They see this as a potential opening for the Party.

The LP-MN would like assistance from the LP staff or the LNC, perhaps by teleconferencing, to help them set goals and map out the steps that would be needed to accomplish them. They would also like help in figuring out how to contact potential members and in finding a fundraiser who would be willing to be paid on commission.

Nebraska:

The LP-NE now has 785 members, defined as any registered Libertarian voter or anyone in the LP-US or LP-NE. They recently filled their three District Coordinator positions and are coordinating with the C4L for an August event. Their website is stable and updated regularly.

The LP-NE has experienced increasing success in the last couple of years. They collected 8,000 signatures to put Michelle Sallach-Grace on the ballot in Nov. 2010 as the Libertarian candidate for State Auditor. She won 34 precincts and 20% of the vote, which was probably the highest statewide Libertarian percentage in the nation.

Since state law requires the LP-NE to get 5% in a statewide election for every election cycle in order to maintain ballot access, they are set for the 2012 election. Their next filing deadline is March 1, 2012, for the primary. Because there will only be two offices available in 2012, U.S. Senate and President, it's not clear if the LP-NE will maintain ballot access for 2014.

The LP-NE plans to contact sympathetic state legislators to change ballot access laws, but realizes that this is a long shot. Gene Siadek, the LP-NE chair, recently testified in a state legislative committee hearing against a bill that would have further restricted their ballot access. They are party to a lawsuit objecting to the constitutionality of certain petitioning restrictions, which will be heard in Federal District Court on April 20.

Libertarianism is becoming increasingly popular in Nebraska, although still small. The fan count on the LP-NE Facebook page recently surpassed the Democratic Party Facebook page. And Libertarian voter registration is up by 11% while Democratic and Republican voter registrations are down by .01%.

The LP-NE would like the LP staff or LNC to develop some type of collaborative membership database instead of the current monthly "push-pull" set-up. They see their biggest problem as a lack of money and a lack of candidates.

North Dakota:

The LP-ND has about 30 members, with membership determined by paying dues to national. They use the free website provided by the LP, and their next convention will probably be in 2012. Their biggest problem is the low population density in North Dakota and the limited interest in third parties.

In spite of these problems, 2010 was their biggest year ever. They were listed on the ballot as the Libertarian Party of North Dakota, which required 7500 signatures, and ran a record number of candidates:

Richard Ames ND Senate
Keith Hanson US Senate
Thom Passa ND House
Anthony Stewart ND House

Richard Rimers Tax Commissioner

Josh Voytek Public service commissioner

Although none of them received more than 2-3% of the vote, they had some press coverage. The fact the Secretary of State's office messed up Richard and Josh's candidacy also generated press coverage.

The LP-ND's biggest challenge with ballot access is the primary minimum vote required. The LP-ND is working with Richard Winger on a lawsuit to remedy this matter. ND's election law requires all primary winners to get about 140 votes in the primary to pass on to the general election. In 2010, there were three candidates that won the LP-ND primary but because none got the required vote minimum, none passed on to the general election.

The trends in North Dakota are that some people are fed up with big government but tend to vote for the better Republican. Welfare recipients and government workers are big on government. There are billions of oil dollars in ND right now and the spending keeps on rising. Groups are trying to stop the spending increases and reduce the taxes.

The LP staff and LNC might be able to help with recruiting members and officers, perhaps through some type of promotion or ad campaign.

Comment from Dianna: Six candidates out of thirty members is an incredible 20%. I bet no other state can match this level of involvement.

South Dakota:

The LP has recently identified someone interested in rebuilding and reorganizing the LP-SD, which has been dormant for about five years. The remnants of the Executive Committee haven't yet met with this individual.

Wisconsin, by former Chair Ben Olson III:

The LPWI had our annual convention at the Olympia Resort in Oconomowoc, Wisconsin the weekend of April 1, with about 30 members in attendance. It began with a mixer on Friday evening, with entertainment by Chairman Ben Olson on bass, guitar and vocals and alt-rocker Random Lama on guitar and vocals. Saturday was a mix of Executive committee meeting, member meeting to elect new officers, several workshops and speakers. Saturday evening was a banquet with featured speaker Gene Cisewski, former political director of the LPUSA. Terry Gray was selected as the new chair.

The LPWI will be changing servers and upgrading our website right after the convention. With all the unrest over the budget bill here in Wisconsin the last couple months, we have had a surge in inquiries about the LP, and a number of new members. Membership is currently in the low 200's, but there are indications that our numbers will be growing between now and the 2012 election.

We do have some Libertarians running for local offices around Wisconsin, but I have no firm number that I can provide. Because of the political turmoil in Wisconsin, there may be a round of recall elections mid-summer this year and another round in early spring 2012. Because both the Democrats and Republicans have moved to the extremes of their constituencies, the LPWI has found itself in the center and the only party that seems to care about both balancing the budget and respecting the rights of individuals working for the public.

The LPWI has maintained the balance in our treasury for the last several years, with income slightly ahead of outgo. The state party may need to use some of those funds to help

regain our ballot status for the 2012 election, although that may be achieved by fielding a gubernatorial candidate in the recall election and receiving 1% of the vote.

The trend in Wisconsin was to elect fiscal conservatives to the statehouse and legislature to balance our budget. Strides have been made to eliminate the \$3.5 B structural deficit, and you may have seen the reaction on the 6 O'clock news. With a Republican controlled legislature, there is a very good chance that 'Constitutional Carry' will soon be the law in Wisconsin, as well as easing of regulation on businesses and spending cuts as opposed to tax increases. On the flip side of the coin, the state will be cutting aid to counties and municipalities, so some people will see their taxes go up anyway. Rules may be changed to allow small family farms to sell raw milk and other products that have come under control of the state in recent years. Any thought of a medical marijuana bill or decriminalization under the current leadership is probably a pipe dream for the foreseeable future.

The LPWI has issued timely press releases on a number of topics, but has been disappointed in the lack of ink we get. We have had much better luck getting letters to the editor published in a number of papers around the state. Vice Chair Jim Maas does have a column that appears somewhat regularly in several Wisconsin daily newspapers.
