Regular Meeting of the Libertarian National Committee March 1-2, 2014 Alexandria, Virginia

Call to Order

The regular session of the Libertarian National Committee was called to order at 9:01 AM on March 1, 2014 at the Westin Hotel in Alexandria, Virginia. Present at the table were: David Blau (Secretary), Sam Goldstein (Region 3), Tim Hagan (Treasurer), Mark Hinkle (At Large), Gary Johnson (Region 7), Vicki Kirkland (Region 2), Jim Lark (Region 5S), Scott Lieberman (Region 4 Alt.), Geoff Neale (Chair), Norm Olsen (Region 1), Bill Redpath (At Large), Starchild (At Large), Rich Tomasso (Region 5N), Dianna Visek (Region 6), Dan Wiener (Region 4).

Credentials Report

Mr. Blau reported that no changes in credentials were made known to him prior to the meeting. Mr. Neale reported that neither Mr. Cloud nor Mr. Wrights will be at the meeting this weekend. This is the second consecutive meeting that Mr. Wrights has missed. As Mr. Wrights provided notice in advance that he would not attend, Mr. Neale ruled that Mr. Wrights is no longer a member of the LNC.

Paperwork Check

Mr. Blau distributed a Secretary's Report. Mr. Olsen distributed a motion regarding Alaska Candidate Support.

Agenda

Starting from the Chair's proposed agenda, the following amendments were moved:

Mr. Hinkle moved to discuss filling the Vice Chair vacancy, for five minutes before the Chair's report. There was no objection.

Ms. Visek moved (Mr. Olsen seconded) to delete the agenda item under the Audit Committee report to fill the Audit Committee vacancy. Following debate, there was no objection to leaving the item in the agenda.

Ms. Visek moved to add an item to discuss the duration of the next LNC meeting, for 10 minutes as business without previous notice. There was no objection.

Mr. Goldstein moved (Starchild seconded) to consider the new business with previous notice before the region reports. The motion passed on a show of hands.

Mr. Redpath moved to take up his motion with previous notice regarding Paul Rossi at 3:00 PM due to Mr. Rossi's availability. There was no objection.

Starchild moved (Ms. Visek seconded) to add an agenda item to hear a report on progress on the convention, for 20 minutes after the Convention Management Committee report. The motion failed on a show of hands.

Mr. Neale asked permission of the body to reposition his motion with previous notice regarding the interim committee chairs to immediately after the Chair's report. There was no objection. Starchild moved to reduce all officer reports to 5 minutes each, and to add 10 minutes after each for discussion thereof. The motion failed on a show of hands.

Potential Conflicts of Interest

Mr. Redpath reported that he is now chair of the Libertarian Party of Virginia. Dr. Lark is now vice-chair of the Libertarian Party of Virginia. Through mutual agreement, the LNC and Big L Solutions have terminated their relationship regarding the Double the LP campaign, and any existing conflicts of interest related thereto are removed.

Motion on Vice-Chair Vacancy

Mr. Hinkle moved (Mr. Hagan seconded) to immediately reappoint Mr. Wrights as Vice-Chair of the LNC. Without objection, Mr. Starr spoke to note that, per the Bylaws, the vacancy will not occur until the end of the meeting, but it would be appropriate to move to reappoint him with effectiveness immediately upon the end of the meeting; Mr. Neale reversed his earlier ruling, and Mr. Hinkle amended his motion to have effect at the end of the meeting.

Following debate, a roll call vote was taken on the Hinkle motion.

The motion passed 11-2-2.

Mr. Pojunis replaced Dr. Lieberman at the table. Mr. Redpath moved (Mr. Hinkle seconded) to reappoint Mr. Wrights to all of his previous committees at the conclusion of the meeting. A roll call vote was taken.

Those voting aye: Blau, Goldstein, Hagan, Hinkle, Johnson, Lark, Neale, Redpath, Tomasso, Wiener.

Those voting nay: Olsen, Pojunis, Starchild.

Those abstaining: Kirkland, Visek.

The motion passed 10-3-2.

Chair's Report

Mr. Neale did not provide a written report, since all of his activities since the last meeting were covered by committees. He will provide his input when those committees report.

Mr. Neale will be launching a Libertarian Angels site shortly. He also will send out a fundraising letter (once approved by the APRC) using the "You Might Be A Libertarian" idea.

Motion on Interim Committee Chairs

Mr. Vohra joined the table, and Mr. Pojunis left the table. Mr. Neale handed the gavel to Mr. Hagan, and moved:

To add a new subsection to Section 1.03 of the Policy Manual as follows:

4) Interim Committee Chairs

The Chair shall have the authority to appoint an interim chair for all committees which select their own permanent chair. The interim chair shall serve until a permanent chair is chosen by the committee.

Dr. Lieberman raised a point of order to state that the Bylaws (Article 12, Section 1) require appointment of interim chairs for the platform, bylaws, and credentials committees by the LNC as a whole. Ms. Visek raised a point of order that since LP Bylaws Article 10.2 forbids the officers from even voting on the makeup of the Audit Committee, it would be improper to have the LNC Chair then pick the interim chair of the Audit Committee.

Ms. Visek moved to amend the main motion to clarify that it should pertain only to "non-standing" committees "of the LNC". The Visek amendment was adopted, and a roll call vote was taken on the main motion, which now read:

To add a new subsection to Section 1.03 of the Policy Manual as follows:

4) Interim Committee Chairs

The Chair shall have the authority to appoint an interim chair for all non-standing committees of the LNC which select their own permanent chair. The interim chair shall serve until a permanent chair is chosen by the committee.

Mr. Blau noted (with parliamentary assistance from Mr. Starr) that because this motion would create a special rule of order, a vote of either two-thirds of those voting, or a majority of the entire membership of the LNC, was required for passage.

The motion passed 11-3-1.

Mr. Hagan returned the gavel to Mr. Neale. Mr. Pojunis returned to the table.

Treasurer's Report

Pursuant to past findings of the Audit Committee, Mr. Hagan reported that staff has been working to determine ultimate vendors for filing amended FEC reports in 2011 (7 reports), 2012 (4 reports), and 2013. There are no deadlines for making these amendments. Mr. Hagan fielded other questions from the committee about financial matters.

Dr. Lark thanked Mr. Redpath for donating just under \$100,000 to the party. Dr. Lark was also recognized by the body for his generous contributions.

Secretary's Report

The Secretary's Report is reproduced in the appendices.

Staff Reports

Wes Benedict discussed the staff report reproduced in the appendices and fielded questions from the assembly. Pursuant to a requirement in the Policy Manual Section 3.04.3, which states:

"The Executive Director shall promptly report to the Executive Committee if cumulative revenue as of the end of the month is less than 90% of the accepted budget and submit detailed plans for appropriate expense reductions for the remainder of the budget period."

he proposed several expense reductions, including ballot access for Illinois and Alabama and *LP News* expenses.

Audit Committee Report

Mr. Starr summarized the Audit Committee report reproduced in the appendices.

The committee has prepared draft motions for whistleblower protections and for document retention, and recommends that the motions be reviewed by counsel before a vote is taken. The

2013 audit is now underway, and the committee expects to produce the 2013 report for LNC review before the national convention.

Filling the Committee Vacancy. Mr. Neale asked whether we should find someone to fill Mr. Buchman's vacated seat on the Audit Committee.

Following discussion, there were no nominations to fill the vacancy, and Mr. Neale stated that this agenda item has been fulfilled.

In light of the Audit Committee report, Ms. Visek moved:

Whereas, the Audit Committee found general ledger records stating that UPS and FedEx Kinko's transactions in the amount of \$956.30 were incurred, for Ms. Howell's move, in March and April 2013 (more than one year after she moved);

Whereas, Staff later claimed that those expenditures were Party business related, and not for Ms. Howell's personal shipments;

Whereas, the Libertarian National Committee ordered Staff to provide to the Audit Committee receipts or statements from UPS and FedEx supporting those incurred expenses;

Whereas, once those records were produced, Ms. Howell admitted that the Party had paid for shipping some of her personal items, and repaid \$200 to the Libertarian National Committee; and

Whereas, an examination of those records and further inquiry by the Audit Committee revealed that \$144.52 was charged to the Party for shipments to Ms. Howell's residence, including a television set, and \$504.75 was charged to the Party for shipments to LPHQ for which personal items were listed on the manifest, including pots, pictures, glassware, picture, printer, and CD player; now, therefore be it

Ordered, that Ms. Howell is obligated to promptly repay the balance of \$449.27 to the Libertarian National Committee; and

Ordered, that Robert Kraus and the Audit Committee be notified of this decision so that appropriate adjustments are made to the 2013 financial statements.

Following debate, a roll call vote was taken on the Visek motion.

Advertising & Publication Review Committee Report

The APRC gave no report. Without objection from the LNC, Mr. Benedict expressed his heartfelt thanks to the APRC members.

Affiliate Support Committee Report

Mr. Tomasso reported that he has been creating outreach fliers in absence of any activity by the Affiliate Support Committee,

Mr. Pojunis moved (Mr. Olsen seconded) to remove all LNC members from the Affiliate Support Committee and then fill those positions by mail ballot.

Following debate, time expired. Mr. Pojunis moved (Mr. Olsen seconded) to extend for two minutes. Mr. Pojunis requested a roll call vote on the motion to extend time.

Those voting aye: Hagan, Johnson, Lark, Olsen, Pojunis, Starchild, Visek, Wiener. Those voting nay: Blau, Goldstein, Hinkle, Kirkland, Redpath, Tomasso, Vohra. Those abstaining: Neale.

The motion to extend, needing a two-thirds affirmative vote to pass, failed 8-7-1. The roll call vote on the main motion was as follows:

Those voting nay: Blau, Goldstein, Hagan, Hinkle, Johnson, Lark, Redpath, Tomasso, Vohra.

Those abstaining: Kirkland, Neale.

The motion failed 5-9-2.

Ballot Access Report

Mr. Redpath presented the ballot access report which is included in the appendices and fielded questions from the assembly.

At 12:01 PM, the meeting was adjourned. Members of the LNC and members of the public were transported to 1444 Duke Street in Alexandria for a viewing of the proposed new LPHQ office. After the tour and a break for lunch, the meeting resumed at 2:03 PM.

Discussion of the ballot access report continued after lunch, but the LNC took no action on this subject.

Office Acquisition Committee Report

Robert Kraus and Mr. Neale discussed with the LNC the terms of the pending agreement to purchase 1444 Duke Street. The closing is scheduled for April 25 at 10:00 AM. The mortgage principal amount is expected to be around \$500,000, and the interest rate 4.85%.

Mr. Neale passed around a resolution that Bill Hall would like us to pass at this meeting regarding the potential purchase. Mr. Hinkle moved to amend the agenda to take up the resolution as the first item of business Sunday morning, the delay to allow the LNC to consider it. The motion passed without objection.

Wiener and Visek Motions on the Mortgage

Dr. Lieberman replaced Mr. Pojunis at the table. Mr. Wiener moved (Mr. Hagan seconded):

To add a new subsection to Section 2.03 of the Policy Manual as follows:

17) Office Mortgage

It shall be the goal of the LNC to completely pay off the office mortgage as quickly as possible, and in any case prior to the due date of the 10-year balloon payment. Towards that end the LNC shall budget a minimum of \$60,000 in each odd-numbered year to pay down the principal until the mortgage balance is zero. Fundraising for this specific purpose shall be made a high priority. This provision does not preclude additional fundraising and pre-payments in even numbered years.

Ms. Visek moved (Starchild seconded) to substitute the following motion, which she distributed to the LNC on a paper entitled "Mortgage Payoff Comparisons":

To insert a new subsection to Section 2.03 of the Policy Manual as follows:

11) Mortgage Retirement Fund

Money shall be raised for the restricted purpose of establishing and replenishing the Mortgage Retirement Fund, a sinking fund with the objective of retiring the mortgage. Mortgage payments shall be disbursed first from the sinking fund in even fully-amortized amounts so as to pay off the mortgage in ten years, thus avoiding a future balloon payment. In the event there are insufficient funds in the sinking fund, payments shall continue to be disbursed at a ten-year fully-amortized rate from general funds, except during those times when the National Committee has specifically declared that a state of financial exigency exists. This section shall not preclude the National Committee from making additional disbursements to accelerate the repayment of the mortgage. The Party's budget and interim financial statements shall include a separate report of the balance and activity of the sinking fund.

Mr. Neale handed the gavel to Mr. Hagan, and moved (Mr. Olsen seconded) to amend the Visek motion to reallocate \$65,000 from the ballot access budget line item to help pay off the mortgage. Mr. Hagan returned the gavel to Mr. Neale.

Following debate, the Neale amendment failed on a show of hands.

A roll call vote was taken on the Visek motion to substitute.

Those voting aye: Goldstein, Johnson, Lieberman, Starchild, Visek.

Those voting nay: Blau, Hagan, Hinkle, Kirkland, Lark, Neale, Olsen, Redpath, Tomasso,

Wiener.

Those abstaining: Vohra.

The motion to substitute failed 5-10-1, leaving the Wiener motion as the main motion.

Starchild moved (Mr. Vohra seconded) to amend the Wiener motion to reallocate half of the budget of the LNC meeting expense line item to pay off the mortgage early. The Starchild amendment failed on a show of hands.

A roll call vote was held on the Wiener motion. For this vote, Mr. Pojunis replaced Dr. Lieberman at the table.

Those voting aye: Blau, Goldstein, Hagan, Johnson, Kirkland, Neale, Pojunis, Starchild,

Tomasso, Visek, Vohra, Wiener.

Those voting nay: Hinkle, Lark, Olsen.

Those abstaining: Redpath.

The motion passed 12-3-1. Dr. Lieberman returned to the table, replacing Mr. Wiener.

Motion To Repay Expenses of Paul Rossi

3:00 PM having been reached during the previous agenda item, the orders of the day called for the Redpath motion to be taken up.

Mr. Redpath introduced Mr. Rossi, who was present in the gallery, and explained the background of his motion. The 2012 Pennsylvania ballot access drive was heavily contested by the Republican Party and Mr. Rossi was our lead attorney for this process. The total legal bill for this was about \$20,000, of which the 2012 Gary Johnson campaign paid approximately half. Mr. Redpath's wife made a donation of \$2,500 to Mr. Rossi. With other minor contributions, the remaining debt owed him is \$6,650. The LNC legally may pay up to \$5,000 to offset this debt.

Mr. Redpath moved that the LNC make a \$5,000 payment to Paul Rossi as an in-kind contribution to the 2012 Gary Johnson campaign to help retire the debt owed by the campaign to Mr. Rossi. Following debate, the roll call vote was as follows:

Those voting aye: Blau, Goldstein, Hagan, Hinkle, Johnson, Kirkland, Lark, Lieberman, Neale,

Pojunis, Redpath, Starchild, Tomasso, Visek, Vohra.

Those voting nay: Olsen.

The motion passed 15-1.

Dr. Lark moved that the LNC express its appreciation and thanks to Mr. Rossi for his actions on behalf of the Libertarian Party. There was no objection.

Without objection, the meeting recessed at 3:32 PM. The meeting resumed at 3:47 PM, with Mr. Wiener replacing Dr. Lieberman at the table.

Convention Oversight Committee Report

Mr. Goldstein reported that the Convention Oversight Committee has not done anything to date, because the committee has not been asked to do anything by the Convention Management Committee. Ms. Kirkland reported that she has not been receiving communications from the Convention Management Committee.

Mr. Wiener moved (Mr. Redpath seconded) to amend Section 2.03, Subsection 4 of the Policy Manual (Conventions) as follows (underlines and strikethroughs showing changes):

The Party shall not directly or indirectly compensate or otherwise underwrite or subsidize the convention travel, lodging (excepting room upgrades), entertainment costs or speaker fees/honorariums of any Convention delegates. This policy shall not prohibit the Party from underwriting organized convention events offered to all donors of a particular level. This policy shall not prohibit a delegate from receiving a complimentary meal if the delegate is performing volunteer work specifically related to that meal event. Nor shall it prohibit delegates from receiving complementary meals or access to convention events in rough proportion to their level of volunteer work. All volunteer compensation must be approved by the Convention Oversight Committee, and contemporaneously published when actual compensation is received.

Ms. Visek moved to amend the motion by striking "(excepting room upgrades)" and inserting a new second sentence which would read:

"This policy shall not prohibit providing complimentary hotel room upgrades to donors who have made lifetime donations in excess of \$25,000 or at least \$5,000 since the last convention, provided that the upgrade is at no cost to the party, is offered on a first-come-first-serve basis to all donors who are eligible, and the national committee is provided with a list of those donors who accepted the offer."

Mr. Neale turned the gavel over to Mr. Hagan.

Following debate, the Visek amendment failed by a vote of 4-6 on a show of hands.

A roll call vote was taken on the main motion.

Those voting aye: Goldstein, Hagan, Johnson, Lark, Neale, Redpath, Tomasso, Wiener.

Those voting nay: Blau, Hinkle, Olsen, Pojunis, Starchild, Visek.

Those abstaining: Kirkland, Vohra.

The motion passed 8-6-2.

Mr. Hagan returned the gavel to Mr. Neale.

Olsen Motion Regarding Alaska Candidate Support

Mr. Olsen moved (Mr. Pojunis seconded):

For the purpose of supporting the election of two Representatives to the Alaska Legislature at the 2014 general election and the retention of ballot access by Alaska by achieving 3% of the vote in the 2014 gubernatorial election as outlined in the attached request, the following budgetary changes are made:

- Budget line 7360-40 (Campaign-Candidate Support) is hereby increased to \$20,000
- Budget line 4030-10 (Online Contributions General) is hereby increased by \$7,500
- Budget line 7380-10 (Ballot Access Petitioning Expense) is hereby reduced by \$12,500

The Chair shall direct the Executive Director to disburse funds as so budgeted directly to the Alaska affiliate as indicated by the basic intent detailed in the attached campaign plan.

The campaign plan referred to in the motion is reproduced in the appendices. Debate was centered around clarifying whether there is an alternative means of retaining ballot access in Alaska by achieving a certain number of voter registrations.

The Alaska state Party chair Michael Chambers was called at 4:25 PM. Mr. Chambers fielded numerous questions from the assembly regarding conditions of the races in question, and regarding the accuracy of numbers from the Secretary of State regarding voter registration requirements. The call ended at 4:48 PM.

Following further debate, Mr. Tomasso moved (Mr. Goldstein seconded) to postpone the Olsen motion indefinitely. A roll call vote was taken on the motion to postpone indefinitely.

Those voting aye: Blau, Goldstein, Hagan, Hinkle, Kirkland, Lark, Neale, Olsen, Pojunis, Starchild, Tomasso, Visek, Vohra, Wiener.

Those voting nay: Johnson, Redpath.

The motion to postpone indefinitely passed 14-2.

Ms. Visek moved (Starchild seconded) to suspend the rules for one minute to amend the delegate compensation motion so the first new amended text reads "(excepting room upgrades which the

<u>Party received at no cost</u>)". The motion to suspend the rules passed 12-2, and there was no objection to amending the delegate compensation motion as requested.

Starchild moved (Mr. Tomasso seconded) to suspend rules to further amend the delegate motion. The motion failed 5-7.

Convention Management Committee Report

Mr. Neale reported that the committee cannot function without staff. The convention web page is up, and packages and prices are set. Speakers are being lined up; details are not ready for public release.

In response to a question by Ms. Visek, Mr. Neale confirmed that all of the speakers will sign paperwork stating that they will not seek office in the Libertarian Party, per our Policy Manual.

Dr. Lieberman asked whether the banquet is considered a major event for the purposes of speaker statements; Mr. Neale viewed that as a novel question, and did not have an immediate answer.

Starchild would like public distribution of convention data on a website during the convention. Mr. Goldstein moved to appoint Starchild to gather this data, but the motion died for lack of a second.

Ms. Visek also has asked for data about last conventions. Robert Kraus has this information and will distribute it to the entire LNC by putting it on a wiki. Dr. Lark suggested tasking the Convention Oversight Committee with collecting and publishing such data.

Executive Committee Report

Mr. Neale had no report to make, except to say that we get the conference calling system for free and more committees should feel free to use it for their own calls.

Membership Level Review Committee Report

The report of the Membership Level Review Committee is reproduced in the appendices. Mr. Tomasso asked when we will be occupying the new headquarters space (and therefore when the new membership levels come into effect). Mr. Neale had no definitive answer due to the number of variables involved.

<u>Libertarian State Leadership Alliance Report</u>

Alicia Mattson reported that the state chairs' annual meeting is in conjunction with the national convention. There will be training sessions the day before the convention starts; for example, Mark Axinn (NY) and Paul Frankel will be presenting a workshop on running a petition drive. The LSLA is lining up speakers. Anyone with specialty skills who wishes to put on a workshop should contact Ms. Mattson.

Unfinished Business: 2014 Goals

Dr. Lark moved (Mr. Pojunis seconded) to adopt the goals presented at the December 2013 meeting (see below for details). After discussion, without objection this item was moved to the second item of business Sunday morning [following consideration of the Hall building resolutions] and was allotted 20 minutes.

Motion Regarding Proposed Agenda

Mr. Neale handed the gavel to Mr. Hagan, and moved to delete Section 1.02.2 of the Policy Manual in its entirety. This section reads as follows:

"1.02.2 Format of Proposed Agenda

The proposed agenda shall be in the following format:

After discussion, Mr. Neale withdrew his motion without objection by the LNC.

Neale Motion Regarding Official Spokesperson

After informal discussion, Mr. Wiener moved (Mr. Redpath seconded) to amend Section 2.06.1 of the Policy Manual by changing "monthly" to "quarterly", as shown:

The Chair represents and serves as the chief spokesman of the Party as appropriate, including:

- representing the Party to the public, including the business community, media, other political and educational organizations, government agencies, and elected officials;
- planning and directing all investigations and negotiations pertaining to cooperative efforts of the Party with non-libertarian political organizations and the acquisition or sale of major assets;
- maintaining systems of internal and external communication, including providing a monthly quarterly chair's report to all LNC Members.

There was no objection to the motion.

A roll call vote was taken on the substitute motion.

Those voting aye: Blau, Goldstein, Hagan, Hinkle, Johnson, Kirkland, Lark, Neale, Olsen,

Pojunis, Redpath, Tomasso, Visek, Vohra, Wiener.

Those voting nay: Starchild.

The motion passed 15-1.

At 6:03 PM, the meeting was adjourned until 9:00 AM on Sunday, March 2.

The meeting reconvened at 9:07 AM on Sunday, March 2, with Dr. Lieberman replacing Mr. Pojunis at the table and with Starchild absent.

Mr. Neale asked to suspend the rules for three purposes: to allow Dr. Lieberman to make an announcement (1 minute), to allow Mr. Frankel to discuss his desire to collect ballot access signatures in Alabama (5 minutes), and to allow Mr. Neale to make a statement on the office acquisition procedure (5 minutes). There was no objection.

Dr. Lark asked the LNC to recognize the Libertarian Party of Northern Virginia for hosting a wonderful party Saturday night. There was no objection.

Frankel Petitioning in Alabama

LNC policy requires that "No agreement involving a financial transaction with a related party shall be executed unless first approved by the LNC. Any such agreement shall be disclosed in a conflict of interest statement."

In light of this policy, Mr. Redpath moved (Mr. Hinkle seconded) to permit Mr. Frankel to collect ballot access signatures in Alabama.

Mr. Goldstein noted that the contract itself does not involve Mr. Frankel, and that Mr. Frankel would be only a subcontractor.

With permission of the body, Mr. Starr stated that Mr. Frankel is a related party because he has influence over the contracting process in the first instance, and that we should ensure that the terms are fair.

After discussion, Mr. Redpath moved (Mr. Hinkle seconded) to substitute a motion to approve the Alabama petition contract for 2014 that ends on June 3, 2014 as disclosed to the LNC, and to approve that contractor's use of Paul Frankel as a subcontractor. The substitute motion passed 14-0 on a show of hands and became the main motion.

The main motion passed without objection.

Headquarters Office Acquisition

Mr. Neale was surprised yesterday to be confronted with the fact that Marijuana Policy Project (MPP) bought a property in Washington, DC. He asked whether anyone on the LNC actually looked at properties that met our criteria. Mr. Tomasso did early in the process, but otherwise no one did. Mr. Neale did so three or four times in some detail, and the MPP property did not show up in any search because it was not zoned as commercial. He also stated that, while Mr. Kraus was liaising with our real estate agents, Mr. Neale was looking over his shoulder.

Office Acquisition Resolutions Prepared By Mr. Hall

Mr. Neale had the opinion that the resolution is unnecessary for us, because our Bylaws grant us the ability to delegate authority for any function so long as doing so does not violate the Bylaws.

The LNC previously delegated the authority regarding an office purchase to the Executive Committee by a vote of 13-3, and the Executive Committee relied substantially on Mr. Hall's expertise.

Mr. Hinkle moved (Mr. Hagan seconded) to formally adopt the resolution prepared by Mr. Hall as reproduced in the appendices. With permission of the body, Mr. Starr asked whether the LNC officers actually intended to list any other party assets as collateral besides the building itself. Mr. Neale replied "yes".

A roll call vote was taken.

Those voting aye: Blau, Goldstein, Hagan, Hinkle, Johnson, Kirkland, Lark, Lieberman, Neale, Redpath, Tomasso, Visek, Vohra, Wiener.

Those abstaining: Olsen.

The motion passed 14-0-1, after which Starchild joined the meeting.

2014 Goals

Dr. Lark moved (Mr. Goldstein seconded) to formally adopt the goals prepared at the December 2013 meeting:

- The LP will have at least 15,000 sustaining members as of Dec. 31, 2014.
- The LNC will purchase an office and move its headquarters into that office by Dec. 31, 2014.
- The LP will hold a national convention that attracts at least 600 delegates.
- The LNC will reevaluate our printed outreach material (especially the pamphlets), and will update that material where appropriate. The LNC will also develop new pamphlets to provide a Libertarian perspective on important topics (e.g., health care, privacy issues (especially government monitoring of communications in the absence of a reasonable, articulated suspicion of criminal activity), and crony capitalism).
- Establish a very simple, objective, universal, and aggregatable success metric for national, state, and local levels.
- The Executive Director and the Political Director will be in contact with each state chair at least once a month.

Mr. Tomasso proposed additional goals:

- To have the "You Might Be" project and the "Libertarian Angels" project running by the end of the year.
- To have 35 states with ballot access and a 10% increase in the number of Libertarian office holders after the 2014 general election.
- To create a policy group for brainstorming position papers and talking points to create policy positions for submission to the APRC for review and publication.
- To create a working group of majority non-LNC membership for studying structural and process weaknesses in the LP and for recommending changes to the LNC.
- To create an LP speaker bureau.

Following discussion of how these goals would happen without assigning "champions" to each, Mr. Neale volunteered to champion the "You Might Be" and "Libertarian Angels" projects. Mr. Olsen volunteered to champion the success metrics. Mr. Vohra volunteered to champion the speaker's bureau.

Given that some of the individual goals now have champions, Dr. Lark withdrew his motion from the body, without objection.

Motion Regarding Cloud Repayment

Starchild moved that the Libertarian National Committee ask Michael Cloud to return \$_____ [blank to be filled] to the Libertarian Party general fund because his billings for his services were not fair and equitable. The motion failed for lack of a second.

Recording of LNC Meetings

Starchild moved (Mr. Johnson seconded) to amend Section 3.05, subsection 3 of the Policy Manual as follows (underlines and strikethroughs showing changes):

The Executive Director shall be responsible for recording all LNC meetings on audio or video medium, providing a copy to the Secretary. With the exception of any sessions that are not open to the public, such Such recordings shall be destroyed promptly after the approval of the minutes made publicly available, and if possible broadcast live online, as soon as possible after each meeting. These recordings shall be kept in a public archive along with meeting minutes at LP.org.

Mr. Johnson asked if this motion would impose any burden on staff. Mr. Kraus stated that this would require us to have a hard line Internet connection, which can cost anywhere between \$600 and \$1200 per meeting and would require us to increase our meeting budget.

Ms. Visek asked whether we had consulted retained counsel regarding the propriety of publicizing our meetings in this way. A prior LNC did so consult, and counsel recommended against doing so.

A roll call vote was taken.

Those voting aye: Johnson, Starchild.

Those voting nay: Blau, Goldstein, Hagan, Hinkle, Lark, Olsen, Redpath, Tomasso, Visek,

Wiener.

Those abstaining: Kirkland, Lieberman, Neale, Vohra.

The motion failed 2-10-4.

LNC Meeting Space

Starchild moved (Dr. Lark seconded):

That the Chair direct staff to:

- (a) Send an email (written by volunteers from the LNC if the Chair or executive director desires) to our membership list letting LP members know that we are looking for free or low-cost spaces in which to hold LNC meetings in order to keep our overhead low and put as much of the resources they give us as possible directly toward the struggle for freedom, informing them that they could host a future LNC meeting if a suitable space is identified in their area and selected by the LNC, and asking them to contact any of the LNC members whose names and contact information are included in the letter (any LNC member who agrees to be so listed) with any leads they may have.
- (b) Identify in our database (with the assistance of volunteers from the LNC if the Chair or executive director desires) any small business owners, law firm partners, and others whose

profiles suggest they might have access to potential LNC meeting spaces, and provide their names and contact information to any LNC volunteers willing to contact them for the purpose of inquiring about such spaces who agree in writing to keep these members' names and information confidential.

Following debate, a roll call vote was taken.

Those voting aye: Blau, Hagan, Starchild, Tomasso, Vohra.

Those voting nay: Goldstein, Hinkle, Johnson, Lark, Lieberman, Olsen, Redpath, Visek, Wiener.

Those abstaining: Kirkland, Neale.

The motion failed 5-9-2.

Mr. Wiener moved (Mr. Olsen seconded) to amend the agenda to postpone to later in the agenda all motions that Mr. Pojunis was scheduled to present, since he was running late. There was no objection.

Project Administration

Mr. Neale made a motion (Mr. Hinkle seconded) which after clarification of a clerical error, and amendment without objection, became a motion to delete the first paragraph of Section 2.03.13 (Special Projects and Task Forces), change the title of Section 2.03.13 to "Project Funding", and delete Section 2.09.3 (Project Administration) from the Policy Manual.

2.03.13 Special Projects and Task Forces Project Funding

Special projects and task forces may not be used to raise money unless and until the requirements for such projects, as delineated elsewhere in this Policy Manual, have been fulfilled.

Projects shall be self funding and shall expend or obligate only money which has been received unless such expenditures or obligations are approved in advance by the LNC.

2.09.3 Project Administration

A detailed proposal specifying the purpose, means, personnel, and objectives proposed for the project must be prepared in writing and approved by the LNC.

A Project manager shall be selected by the LNC. The Project Manager will be responsible for the development and execution of the project. All Project activities are to be directed by the Project manager, or by a delegated party. Use of the dedicated fund raising list, access to new LNC donor information, or access to available funds shall not be unreasonably withheld.

A budget for a new project must be included as part of the proposal to be approved by the LNC. Budgets for ongoing projects will be included in the annual budget.

Projects are to develop a dedicated funding stream, raising funds in a manner that does not substantially erode core fund raising. Use of the complete donor list for direct response mail, bulk e-mailing or telephone fundraising shall require the approval of the LNC:

Restricted Project Funds shall be charged:

- All direct expenses of fund raising, including:
 - o dedicated staff time for writing and/or proofreading;
 - o all costs associated with fundraising (LP News ads, printing and postage).
 - o merchant fees, if any.
 - o All other expenses necessary to implement the project
- A 10% of the amount of each contribution not to exceed \$10 which shall account for:
 - o caging and accounting for funds received and expenses paid;
 - management oversight of caging, expenses and program implementation;
 and
 - o an allocated portion of occupancy and operations cost.

Following debate, a roll call vote was taken.

Those voting aye: Blau, Goldstein, Hagan, Hinkle, Johnson, Kirkland, Neale, Olsen, Redpath, Starchild, Tomasso, Visek, Vohra, Wiener.

Those voting nay: Lark, Lieberman.

The motion passed 14-2. The Secretary will renumber the subsections of Section 2.09 accordingly.

Magazine Advertising

Mr. Neale handed the gavel to Mr. Hagan. Mr. Olsen moved (Ms. Kirkland seconded) that:

The amount of \$50,000 is added to the existing approved amounts for budget lines 4320 (Outreach – PR & Marketing) and 4030-10 (On-line Contributions – General) for advertising in political magazines, split roughly evenly between right-leaning and left-leaning publications, with a target of 3-4 1/4-1/3-page ad insertions per publication, with the exact wording and design of the ad and selection of publications left to the discretion of the Executive Director. The purpose of such advertising is to raise awareness of our party and its positions with the right and the left, especially in media venues which frequently publish material critical of our positions.

Following debate, a roll call vote was taken.

Those voting aye: Kirkland, Olsen.

Those voting nay: Blau, Goldstein, Hagan, Hinkle, Johnson, Lark, Lieberman, Redpath,

Starchild, Tomasso, Visek, Vohra, Wiener.

The motion failed 2-13-1.

Mr. Hagan returned the gavel to Mr. Neale.

Mr. Neale reminded the body that the Counsel's Report at 11:00 AM will require an Executive Session with Alicia Dearn to discuss a legal matter, and suggested a break until that time. Without objection, the meeting adjourned. The meeting resumed at 11:01 AM.

Counsel's Report

Without objection, the LNC entered into Executive Session at 11:07 AM to discuss a legal matter. The LNC rose from Executive Session at 12:20 PM, having spoken only with Ms. Dearn without reaching Mr. Sinawski. Without objection, the meeting adjourned for lunch until 12:45 PM. When the meeting resumed at 12:45, Mr. Pojunis was present.

Mr. Goldstein moved (Mr. Redpath seconded) to combine all of Mr. Pojunis' agenda items into one item called "Pojunis Motions" and provide 30 minutes for this item. There was no objection.

Pojunis Motions

Mr. Pojunis made a presentation and then moved (Mr. Olsen seconded):

- 1. To add a new item "Website Development & Maintenance 8191" to the budget, and allocate \$26,000 to it (\$20,000 for initial design and development, and \$500 per month for maintenance).
- 2. To allocate \$6,000 to budget item "Outreach PR & Marketing Exp 7320" for hiring a professional newswire service to distribute our material news.
- 3. To add a new item "Data Cleansing & Appending 8192" to the budget, and allocate \$12,500 to it for cleansing our member database.
- 4. To add a new item "Data Cleansing & Appending 8192" to the budget, and allocate \$14,000 to it for cleansing our email database.
- 5. To add a new item "Email Marketing 7321" to the budget, and allocate \$15,000 to it for an email acquisition campaign.
- 6. To add a new item "Email Marketing 7321" to the budget, and allocate \$6,000 to it for hiring a service provider to guarantee 500,000 emails will be opened.
- 7. To allocate \$14,500 to budget item 7320 for social media marketing.
- 8. To allocate \$14,500 to budget item 7320 to hire an SEO company for one year (\$2,500 up front, \$1,000 per month).
- 9. To add a new item "Branding 7102-10" to the budget, and allocate \$5,500 to it for producing a well-designed annual report to share with our membership and to use for new member solicitation.

- 10. To allocate \$1,000 to budget item 7320 to hire a logo designer for the production of a new national party logo.
- 11. To add a new item "Bookkeeping 8221" to the budget, and allocate \$9,800 to it to hire an outside firm to assist us with maintaining the LP's books and records.

Mr. Wiener moved (Mr. Hinkle seconded) to divide the questions into separate motions. The motion failed 7-8 on a show of hands.

Mr. Hinkle moved to amend the Pojunis motion to strike references to Quickbooks (i.e., budget) accounting numbers; there was no objection.

Following debate, without objection Mr. Pojunis withdrew his motion from the body to allow more time to develop individual ideas.

Affiliate Support Discussion

The LNC had a general discussion of ways in which we might better support affiliates besides ballot access, but no action was taken on this item.

Mr. Redpath moved (Mr. Goldstein seconded) to suspend the rules to amend the agenda to consider the Counsel's Report, then the regional reports, then the Visek discussion of the next LNC meeting time, then the remaining Pojunis discussion items. The motion passed without objection. The meeting recessed at 1:54 PM. The meeting resumed at 2:10 PM.

Counsel's Report (Reprise)

Mr. Sinawski had nothing to add to his written report, which is reproduced in the appendices, and he fielded specific questions regarding it.

Supplements to Region Reports

Mr. Neale handed the gavel to Mr. Hagan.

Region reports are reproduced in the appendices.

Mr. Olsen summarized his region report.

Ms. Kirkland summarized her region report.

Mr. Goldstein reported that Ohio is poised once again to crush the Republicans in their failed attempts to keep Libertarians off the ballot. Budget for Indiana will be \$65,000 for 2014.

Mr. Wiener invited the LNC to attend the California convention at the end of the month in Visalia, CA. There are two candidates who will be soon filing for Secretary of State and Attorney General. However, none of the California candidates are likely to show up on the November ballot due to "Top Two".

Mr. Pojunis reported that states in the region are moving to a monthly scorecard to measure their financial and operational progress. The Nevada LP hosted the first Clark County Sheriffs' debate which was covered by all major media outlets and earned approximately \$21,000 in earned media time.

Mr. Tomasso summarized his region report. The "Heat for the Homeless" fundraiser in New Jersey raised 30% more than needed to provide heat for those living in a tent city. He recommended that state chairs contact the World Affairs Council to do international outreach.

The LP Womens' Caucus wants to have a meeting at the national convention.

There were no questions about the Region 5N report.

Ms. Visek added that Lex Green (ballot access coordinator) sends his thanks to Mr. Redpath and the Executive Committee for the ballot access funding approved last night.

There were no questions about the Region 6 or Region 7 reports.

Mr. Pojunis moved to suspend the rules to recognize Jason Scheurer of Virginia to speak about social media and outreach for ten minutes. Mr. Blau objected because some LNC members may have to leave. The motion to suspend failed for lack of a second.

Pre-Convention LNC Meeting

Ms. Visek reminded the body that the Chair has requested an LNC meeting on Thursday, June 26, 2014 from 1 PM to 5 PM. Ms. Visek moved (Mr. Redpath seconded) to change the meeting time to instead be from 3 PM to 5 PM.

Starchild moved (Mr. Johnson seconded) to substitute a motion to require the LNC to meet from 9 AM to 5 PM on Wednesday, June 25, 2014. Following debate, the motion to substitute failed on a voice vote.

Mr. Redpath moved (Mr. Hinkle seconded) to amend the motion so that the meeting would begin at 3 PM and continue until it adjourns. There was no objection to adopting the amendment.

The main motion passed without objection.

Mr. Pojunis moved to suspend the rules to recognize Jason Scheurer of Virginia to speak about social media and outreach for ten minutes. There was no objection.

Social Media and Outreach Discussion

Mr. Scheurer stated that the two major parties are stealing our issues and rebranding them as their own in the media, and we are losing voters who think that, for example, Democrats were always for marriage equality. He asked for endorsement from the LNC to act as an unpaid press

secretary, so he can have a mandate to speak on behalf of the party on dozens of radio and television shows. General consensus was that decisions about tasking volunteers would be left to the Chair and the Executive Director.

Mr. Pojunis requested to remove Report Standardization and Project Based Funding from the agenda as having already been addressed. There was no objection.

Member Communications Discussion

Mr. Pojunis asked the LNC for ideas about how we can better communicate with our members for fundraising. Following discussion, no action was taken on this item.


Announcements

Monthly membership reports and financial reports have been submitted to the LNC separately from this report.

Staff Personnel Changes

Arthur DiBianca, an independent contractor, is helping pat-time with publications, data maintenance, wikis, and various other tasks as needed.

Other items

- A support wiki for affiliates and candidates is in the works.
- Book and T-shirt fundraising offers have performed well and were profitable.
- Recent house fundraising letters have not performed very well. I think we sent too many at the end of 2013. I'm cutting back from shooting for 12 per year, to around 7 per year. Profitability was much higher when I sent fewer a few years ago. We've issued an "Urgent Gram" similar to one that did very well a few years ago that should reach mailboxes soon. The details in it are true. If we don't raise enough soon, we might have to cut ballot access support, lay off staff, or have trouble getting financing for the LP headquarters.
- January profitability should be high, but you might be surprised at how low our general fund bank account is when you get the February end of month financials. I advise caution on spending.
- Preparing for the move is taking significant staff time. Requests for other special projects, tweaks to things, and new ideas continue to roll in. I can focus more on fundraising, or lots of other things instead.

Political Director Activities Nov 22, 2013 - Feb 13, 2014

Regular activities: Candidate support and recruitment, media interviews, writing blogs and news releases, posting videos and Facebook memes to LP.org (list of publications and media hits follow).

Director of Operation's Report

by Robert Kraus

Blackbaud – Data Dumps – Internal Customer Service

We finished the major email data cleanup of our database (Raiser's Edge). As mentioned in the last report we used an email verification service (Melissa Data) to check the remaining unknown emails from the database and we further removed an additional 5,000 bad emails for a total of about 17,000 bad emails now removed. In addition we did some other cleanups of phone/email and web sites within the database. At this point the dumps only include known good emails as of Jan.

Building (Office Acquisition) Fund

Building Fund reserves now at \$324,000 net (\$363,000 including outstanding pledges). We have an accepted purchase offer in the Roundhouse Sq development where 1428 Duke was located. The property is an end unit town house in a fee simple association (not an "office condo"). We are currently in process of doing our due diligence including inspections and surveys. In addition, we have received multiple term sheets and commitment letters from banks for the mortgage. Most if not all of our due diligence items and the bank loan should be complete by the time of the March LNC Meeting. We hope to close by end of April and move in by end of May. We also hope to give notice to the Watergate by the time of the March meeting.

FEC Filing

We continue to file accurate FEC reports and use Paula Edwards to complete the FEC Filing Process on a monthly basis and handle our amendments. The reconciliation and audit steps to this process continue to work to assure that these reports are correct prior to filing, and to insure that the disbursements and contributions match to our cash accounting records.

There remain some recent concerns over the acceptance of bitcoins by political organizations and candidates. As mentioned previously, the FEC could not come up with an agreement on a response to an inquiry by a Republican based PAC and will continue to investigate the issue.

Meanwhile, we have stated in our FEC Filing memo's that believe we are in compliance because we do not except bitcoins directly. We use a merchant processor called BitPay and we only accept contributions in dollar amounts and only receive funds in dollars – just like how we handle PayPal. Thus, we find that the current FEC discussions concerning bitcoins do not apply to us since the FEC previously ruled that it is acceptable to receive donations via PayPal and other third party merchant possessors.

The FEC has not sent us any letters in regards to this and we will continue to disclose to the FEC which donations are via BitPay.

As a reminder, the FEC reports are done on a cash basis while our financial reports are done on an accrual basis as required by our bylaws which require adherence to GAAP. Therefore, our Statement of Operations will not always look the same as what is reported on the summary page of our FEC Filings.

Financial

We continued efforts to control and maintain our expenses and we continue to maintain zero accounts payable.

Third Interim Report of the 2012/2014 Libertarian Party Audit Committee

23 February 2014

Note: Our second Interim Report for the 2012 Audit dated 15 October 2013 was presented to the Libertarian National Committee, 14 December 2013.

This report is a follow up to that report and is not confidential.

EXECUTIVE SUMMARY OF INTERIM REPORT

- The 2012 audit is complete and financial statements have been issued.
- > The LNC's FEC consultant, Paula Edwards, has made recommendations concerning some FEC-related issues and stated that she would be available to implement those recommendations after January 31, 2014. We await Treasurer Tim Hagan's report of the outcome.
- Mr. Dixon's reimbursed moving expenses are now documented, but staff has not correctly reported them as non-taxable on his W2, though the IRS requires it to be reported.
- Payments paid on behalf of Ms. Howell for rental deposits and her friend's airfare in the amount of \$3,723.40 has been recovered from Ms. Howell as of December 31, 2013 and the 2012 financial statements were adjusted accordingly.
- ➤ Ms. Howell was able to produce receipts supporting \$2,488.24 of the \$3,106.24 of previously undocumented expenses. The remaining \$618.00 has been recovered from Ms. Howell as of December 31, 2013 and the 2012 financial statements were adjusted accordingly.
- An analysis of FedEx and UPS shipments made in February and March 2013 revealed that the Party paid for Ms. Howell's personal shipments. We recommend that the LNC direct Ms. Howell to repay the Party an additional \$449.27.
- We have provided a draft whistleblower policy for your review.
- We have provided a draft document retention policy for your review.
- We are commencing with the annual audit of 2013.

SCOPE AND AUTHORITY OF THE AUDIT COMMITTEE

An Audit Committee is required by the Bylaws.

Bylaw Article 10.2 states "The National Committee shall cause an efficient double-entry system of accounts to be installed and maintained. Financial statements of the Party shall be prepared in accordance with Generally Accepted Accounting Principles (GAAP). Audits shall be performed annually

by an independent auditor. The non-officer members of the National Committee shall appoint a standing Audit Committee of three members with power to select the independent auditor. One member shall be a non-officer member of the National Committee and the other two shall not be members of the National Committee. The Audit Committee shall clarify for the National Committee any recommendations made by the auditor."

The Policy Manual explicates the role of the Audit Committee:

"The Audit Committee's tasks are to select an independent audit company and to direct the scale and scope of standard annual audits of the Party's accounting records and processes. Following receipt of the audit company's report, the Committee shall help the LNC interpret the audit results and assist the latter in preparing any action plans that might be needed to alleviate deficiencies."

The Policy Manual clarifies that the Audit Committee shall have access to corporate records:

"Members of the National Committee and Audit Committee are entitled to inspect and copy books, records (including electronic records) and documents of the Libertarian National Committee, Inc. to the extent reasonably related to the performance of the member's duties to the corporation, including those duties as a member of a committee, but not for any other purpose or in any manner that would violate any duty to the corporation. Prior to obtaining copies the member shall execute a standard nondisclosure agreement. If the member requires an outside professional to assist in reviewing and analyzing the materials, that individual shall also execute a standard nondisclosure agreement prior to receiving the materials."

The Audit Committee has been granted special rights to review the Party's records. Each LNC Member has an absolute right under Washington, D.C. law to inspect corporate records in the exercise of his or her duties as a board member and to enlist agents to assist with this.

Any member of the LNC (including the member of the LNC who sits on the Audit Committee) has the legal right to enlist the help of outside professionals to review the Party's corporate records, provided that such review is reasonably related to one's duties as a member of the Board of the Libertarian National Committee, Inc.

COMPLETION OF THE 2012 AUDIT

Issues surrounding 2012 transactions have been resolved and our outside CPA firm was able to conclude their audit of the financial statements. We submit to you the audited financial statements, which you are free to distribute. In our CPA firm's opinion, our financial statements "present fairly, in all material respects, the financial position of the Committee as of December 31, 2012, and the change in its net assets and its cash flows for the year then ended in accordance with accounting principles generally accepted in the United States of America."

In addition, we submit to you a letter from our CPA firm that addresses their significant audit findings, and a letter describing the significant deficiencies they found in our internal controls, much of which the LNC has already addressed. This information is intended solely for the use of the Audit Committee, Board of Directors and management of the Libertarian National Committee, Inc. and is not intended to be, and should not be, used by anyone other than these specified parties.

FOLLOW UP ACTIONS TO LNC DECISIONS MADE AT ITS DECEMBER 14-15, 2013 SESSION

At its December 14-15, 2013 session the LNC adopted several motions as a result of its discussions related to the Audit Committee's second interim report. Below is the status or outcome of each decision.

> FEC MATTERS

LNC Adopted Motion Regarding FEC Matters.

Whereas, the Audit Committee identified a number of FEC-related issues, as addressed in the confidential section of the Audit Committee's Second Interim Report and reviewed by FEC Consultant Paula Edwards; now, therefore be it

Ordered, Treasurer Tim Hagan shall review the relevant transactions reported on previous reports, as recommended by FEC Consultant Paula Edwards, to determine the scope of the problems and follow her recommendations, including the filing of amended reports, if required, by no later than February 28, 2014.

Paula Edwards has made recommendations and stated that she would be available to implement those recommendations after January 31, 2014. Tim Hagan should report on the status of this during the meeting.

➤ MR. DIXON'S MOVING EXPENSES

LNC Adopted Motion Regarding Eric Dixon's Moving Expenses.

Whereas, employee Eric Dixon was given \$2,000 to cover expenses for relocating to the D.C. area; now, therefore be it

Ordered, That Mr. Kraus is to obtain documentation from Mr. Dixon supporting that he incurred at least \$2,000 in moving expense; and

Ordered, That to the extent receipts cannot be produced, the balance is to be treated as taxable compensation on Mr. Dixon's W2 for 2013.

In order for reimbursed moving expenses to not be considered taxable wages to the employee, the employee must adequately account for his moving expenses by giving his employer documentation of

those expenses, such as a statement of expense, an account book, a diary, or a similar record in which he entered each expense at or near the time he had it. Documentation includes receipts, canceled checks, and bills. The accounting should be provided in a reasonable period of time, typically within 60 days, and the employer is required to report the amount of reimbursed expenses on the employee's W2 in Box 12. If the expenses are not accountable, they should be included in Box 1 and treated as ordinary wages.

The Audit Committee assisted Mr. Dixon with identifying expenses that qualify as allowable moving expenses and the total exceeds \$2,000. Mr. Kraus has not followed our advice to report this amount correctly on Mr. Dixon's W2 as a non-taxable moving cost reimbursement in Box 12 and he has been directed to correct the filing. To our knowledge, this has yet to be done.

➢ MS. HOWELL'S UNAUTHORIZED EXPENSES.

LNC Adopted Motion Addressing Ms. Howell's Moving & Commuting Expenses -- Rental Deposits and Friend's Airfare.

Whereas, payments for rent security deposits for Ms. Howell in the amount of \$3,550 and airfare for her friend Leslie Fish in the amount of \$173.40 were made, but not authorized by Ms. Howell's employment agreement (as detailed in an exhibit in the Audit Committee's Second Interim Report);

Whereas, LNC Policy requires that the Chair or Treasurer approve (and evidence by signing or initialing) all expenses and expense account reimbursements more than \$200 made to the Executive Director or other officers prior to payment, and such approval was not obtained; and

Whereas, Ms. Howell has only repaid \$1,800 of this amount to the Libertarian National Committee; now, therefore be it Ordered, That Ms. Howell is obligated to promptly repay the balance of \$1,923.40 to the Libertarian National Committee; and

Ordered, that Robert Kraus and the Audit Committee be notified of this decision so that appropriate adjustments be made to the 2012 financial statements.

That \$3,723.40 has been paid in full as of December 31, 2013 and the 2012 financial statements have been adjusted accordingly.

> MS. HOWELL'S UNDOCUMENTED EXPENSES

LNC Adopted Motion Addressing Ms. Howell's Moving & Commuting Expenses -- Expenses without Receipts.

Whereas, the Party reimbursed Ms. Howell \$1,118.00 for expenses and Ms. Howell directed the Party to pay \$1,422.84 directly to vendors for expenses, all of a nature allowed by her employment agreement, but without receipts (as detailed in an exhibit in the Audit Committee's Second Interim Report);

Whereas, the Party also paid \$565.40 for airfare that Ms. Howell states is not related to the commuting and moving expenses of her employment agreement, but that she may be able to substantiate as being employment related by presenting receipts, along with other supporting documentation; and

Whereas, LNC Policy requires that the Chair or Treasurer approve (and evidence by signing or initialing) all expenses and expense account reimbursements more than \$200 made to the Executive Director or other officers prior to payment, and such approval was not obtained; now, therefore be it

Ordered, that Ms. Howell promptly repay \$3,106.24 to the Libertarian National Committee, but allow her to reduce that amount by providing receipts and other documentation to the Audit Committee by December 31, 2013 to substantiate those expenses as employment related, provided the Chair or Treasurer also approve (and evidence by signing or initialing) such expenses; and

Ordered, that Robert Kraus and the Audit Committee be notified of this decision so that appropriate adjustments be made to the 2012 financial statements.

Of the \$3,106.24 of undocumented expenses, Ms. Howell was able to produce receipts supporting \$2,488.24. The remaining \$618.00 that could not be substantiated was reclassified as an employee receivable on the books as of December 31, 2012. Ms. Howell reimbursed the party for that amount by December 31, 2013.

As a result of our work, we have recovered for the LNC \$4,341.40 in unauthorized payments made during 2012.

> UNDOCUMENTED SHIPPING EXPENSES

The National Committee may recall from our Second Interim Report that we noted that the general ledger records revealed additional expenses incurred for Ms. Howell's move in March and April of 2013 (more than one year after she moved). We requested documentation supporting those expenses and any others that are not yet listed as moving expenses for Carla. We also asked whether Carla authorized these payments.

Mr. Kraus did not provide those records to us at the time. He stated that it was a misclassification on his

part based on a prior memorized credit card entry and that he will correct the classification of the transactions. Mr. Kraus is incorrect. We performed a global search with a recent QuickBooks file of the LNC's accounting records. There are no other examples where another transaction included in the memo field the phrase "CH Move Exp," such as was found in a \$504.75 April 2013 transaction with UPS; or "CH Moving Exp," such as was found in a \$451.55 March 2013 transaction with FedEx Kinko's. This memo language was not "memorized" from another transaction. It was manually entered. In addition, if Mr. Kraus had been using a "memorized transaction" in QuickBooks, we would have seen other examples where UPS and FedEx Kinko's transactions were being classified as an employee benefit expense. We found no instances of that, so we repeated our request, to which Mr. Kraus replied:

"Sorry, I can not find any related UPS/Fec-Ex receipts except for one USP from OK to DC on something Geoff signed (the lease I assume). I do know that I personally sent some stuff back to DC from the Chicago Meeting that would account for some of this. I do not have those receipts. There were some other boxes that Carla sent as part of the Candidate archival and Training Project that was defunded. I've reclassified all of those related expenses previously to their natural accounts. We can ask Carla to see if she can dig up those receipts. They were charged (obviously) to our credit card. As we mentioned we are now keeping better records of those charges per the new policy and now are getting approval from Geoff or the Treasurer for any credit card charges per the new policy. I honestly still do not know why I put "CH Moving" and simply attributed that to memorized transactions without looking further into it — my apologies for the error. Either way these were obviously misclassified and I thank the audit committee for pointing out the error so that it could be corrected. There are now no "moving expenses" for 2013."

We did not understand how Mr. Kraus could know now that these were misclassifications on his part if he has no receipts to support his conclusions and his notes at the time indicated otherwise. These transactions took place earlier this year, so the records are available.

As an outcome of our Second Interim Report, the LNC adopted the following motion:

LNC Adopted Motion Regarding Shipping Expenses.

Whereas, the Audit Committee found general ledger records stating that UPS and Fedex Kinko's transactions in the amount of \$956.30 were incurred for Ms. Howell's move in March and April of 2013 (more than one year after she moved); and

Whereas, Mr. Kraus did not provide the Audit Committee copies of those records supporting those transactions; now, therefore be it

Ordered, Mr. Kraus shall provide to the Audit Committee receipts or statements from UPS and FedEx Kinko's supporting the \$956.30 in incurred expenses; and

Ordered, if complete records do not exist at headquarters, Mr. Kraus shall within the next seven days contact the vendors to obtain copies of those records.

The records were requested on December 19, 2013.

We learned on January 2, 2014 that Carla had concluded that she had indeed used UPS and FedEx to pay for her personal shipments and she decided that she ought to pay the party \$200 to reimburse for those costs.

Robert asked that I send you the information related to the shipping motion.

Copies of receipts Robert and I were able to get from shipping vendors are attached covering the following charges:

27-Feb FedEx - \$307.03 (11 pieces)

27-Feb FedEx - \$95.08 (4 pieces)

12-Mar FedEx - \$49.44 (1 piece)

30-Mar UPS - \$481.93 (10 pieces)

3-Mar UPS - \$22.31 (packaging material)

Most of the materials shipped were media (news clippings, cassettes of radio interview, videos of TV appearances), campaign files (petitioning, how-to, talking points and speeches, ads, brochures, fliers, etc), an extra printer; yard signs, placards, and large laminated newspaper ads. They are shown in the attached photos, though some video tapes are being digitized now and not on premises. Some of the paper files were thinned out and tossed earlier in the year. My intent is to scan or otherwise digitize

most of these materials so they can eventually be thrown away so as not to take up space in the office.

There were some personal items included in the UPS shipments. I recall throwing in some of the packages a few kitchen items, 2-3 pictures, a Christmas ornament, and a CD player. I'm guessing it comes to 5-20% of the weight shipped. The bulk of this shipment was media (clippings, cassettes, videos). I have given Robert an additional payment of \$200 that I believe more than covers any personal items that were included in these shipments. He can treat it as a donation or as a reimbursement, however the party sees fit.

The 46" TV that was shipped is being donated to the new headquarters building.

The photograph of her Panasonic television shows it plugged into a cable or satellite connection in her apartment, suggesting that it is currently in use.

Hello Carla,

Your reply to me earlier today indicated that you decided to pay an additional \$200 after you saw the detailed receipts. You also indicated to me today that very little of a personal nature was shipped to the office.

Perhaps you can help me understand the two March 30 UPS transactions that total \$504.75 (\$22.82 + \$481.93).

The first transaction was for 30 feet of bubble wrap and a 3-pack of sealing tape. The second transaction several hours later was for two boxes, more packing materials, labor for UPS to pack the boxes and for four boxes shipped, each with its own tracking number. Three were delivered to the office, while the least expensive of the four was delivered to your home.

Note the following details on these four shipments:

- One box was of a size designed for the shipment of a 36" mirror, but could be used for something like a painting. The description of this shipment with tracking # 1Z8720AR4220010013 is "Picture". The declared value was \$5,000, for which an additional \$70.75 was paid for the enhanced declared value. UPS packed this box. This 17 lb. shipment was delivered to the office.
- The description of this shipment with tracking # 1Z8720AR4220004217 is "Pots, Pictures". The declared value was \$1,500, for which an additional \$24.25 was paid for the enhanced declared value. UPS packed this box. This 122 lb. shipment was delivered to the office. After it was delivered you filed a damage claim.
- The description of this shipment with tracking # 1Z8720AR4253340444 is "Glassware". The declared value was \$2,000, for which an additional \$31.75 was paid for the enhanced declared value. This 24 lb. shipment was delivered to the office.
- The description of this shipment with tracking # 1Z8720AR0320012915 is "Printer, CD Player". The declared value was \$200, for which an additional \$2.00 was paid for the enhanced declared value. This 51 lb. shipment was delivered to your home.

For the three shipments that went to the office, all of them mention items of a personal nature. There is no mention of files, audio cassettes, etc. The enhanced declared values of those three shipments amount to \$8,500, which is consistent with valuable personal items. Also, bubble wrap is not usually required for packing paper files and audio cassettes.

When I received your collection of photos, my first thought was that you were attempting to provide me with a complete catalog of what was shipped. However, I do not see any photos for the personal items described on the shipping documentation.

Do the above details seem consistent with your statement that very little of what was shipped to the office was personal?

Regarding the damage report you filed, can you please provide me with the disposition report that UPS prepared? I imagine that it will describe the contents with more detail. Perhaps it will have photos of the damaged goods. How much did UPS pay for this claim? Did they refund any portion of the shipping cost as part of the claim? If so, was that portion refunded to the LP, which paid for the shipping cost?

Aaron,

In response to your questions:

Regarding the bubble wrap and tape, they may have been the only sizes they offered. Don't remember how much was used. I still have a couple rolls of unused tape, which I would guess were left over from that shipment.

The personal stuff shipped was not of terribly high value, certainly not in the thousands as indicated in the insured values. My main concern was giving them incentive not to lose the packages, especially being shipped via ground delivery. They won't cover the value of documents or media other than their physical value, which is trivial. When I was shipping petitions in MA under tight deadline, some were occasionally lost. They were worthless to me when they were later retrieved past the state's deadline for turn-in. But

I tried to make a claim on some anyway. Despite previous UPS or Fedex claims that they had looked everywhere for missing packages and could not be found, they coughed them up when I went to make a claim.

I will look for the insurance claim. I recall that it was for several small items that broke, not of great value, and that the claim was denied. No payment was made.

I don't remember what was in what boxes, but I can say with certainty that the descriptions of these packages represented a relatively small portion of what was shipped. I have gone over my entire apartment, and there are very few items here that could have been shipped at that time other than what has already been described in previous emails. For example, there is only one small glass that could possibly have been in that shipment. The printer was here and is now in the storage room at LP HQ.

Carla,

I look forward to seeing the claim you submitted and whatever responses you received from UPS.

I noticed that there are two FedEx shipments for which I only have the tracking detail page, but not the receipt which shows the dollar amount that was charged. Please provide the matching receipts for the shipment of the TV on 3/4/13 and the 11 boxes on 2/25/13.

I'm confused by some of your answers.

If you knew from past experience that an insurance claim would be denied because the items being insured have no recoverable value, why did you bother to file a claim? What were the several small items that broke? Were they video tapes, audio cassettes, something else?

If your sole purpose for paying for the insurance is so that you will obtain better or more reliable service, why would you select different values for insurance for each package? It seems to me that you would instead select a uniform low value for insurance purposes. What is the advantage of insuring one item for \$200 (at a cost of \$2.00) and another for \$5,000 (at a cost of \$70.75)?

I'm also perplexed by the shipment that is shaped like a mirror and insured for \$5,000. You purchased a box uniquely shaped to fit something like a mirror or a picture (36" x 36" X 6"). UPS offers other shaped boxes that are more conducive for the paperwork and cassette tapes, and you have actually purchased other such sized boxes. The description of the contents states "Picture". Why didn't you purchase a more appropriately sized box for this shipment if the contents were not, in fact, a picture as the description states? If this is not a picture, what else can this be?

Aaron,

I have attached two records I was able to get from UPS regarding the insurance claim for a damaged package. They denied the claim. It shows that it was for "electric fond" which was a small electric pot that got damaged. This was thrown in with items in a large box that I had them pack.

As I have said, the shipment of a total of about 20 boxes contained primarily the items in the photos I emailed you. They are still in boxes here at the office or in file cabinets. It also contained a printer and a handful of personal items as mentioned below. The insurance amounts were chosen hastily (I was in a rush as the store was closing) based on what items I was most concerned about losing. That would not preclude filing a claim. I could guess what was in particular boxes, but that's all they'd be is guesses. That's what I can remember. As I've stated, the only personal items that I have in the DC area that could have been shipped in that time frame i have listed.

Above, she indicated that her reason for her haste in picking random insurance values was that the store was closing, but the receipt shows the transaction in question took place nearly forty minutes before the store closed.

It seemed odd that Ms. Howell had little recollection of the personal items that she herself had listed on the UPS manifest. After concluding that Ms. Howell was avoiding our questions, the Audit Committee chair on January 16 called Sarah Kingsbury, the owner of the UPS Store in Natick, Massachusetts, from where the UPS shipments were shipped. Ms. Kingsbury stated that she remembered her dealings with Ms. Howell and kept notes of the event, particularly because she receives so few claims. She described Ms. Howell as having been quite agitated over her experience with UPS because much of what she shipped included items from her father's estate and had filed complaints with UPS.

The UPS records indicate that Ms. Howell provided pictures of the damaged items to UPS as a part of her damage claim. But their insurance provider no longer has those pictures, as the case is more than 6 months old. Though we requested that Ms. Howell provide us with copies of these damage pictures so as to see the nature of the shipped items, she did not provide them. UPS records indicate that her claim was denied because their policy is that the claimant must make the actual damaged items and shipping boxes available to their insurance provider for inspection. Ms. Howell did not allow them to inspect the items. Rather she sent pictures of the items and indicated she had thrown away the items and shipping boxes. Thus her claim was denied for failure to comply with the terms of the insurance policy the Party had purchased on the shipment.

It is hard to imagine that after Ms. Howell wrote a number of complaint letters to UPS about the damaged to items from her father's estate, that she would not remember that aspect of the story when at the December LNC meeting she asserted that there were no personal items in these shipments.

The attached exhibit provides the details we were able to obtain on the questionable shipments. After having examining the receipts, corresponding with Ms. Howell, interviewing agents with FedEx and UPS, and speaking with the UPS Store owner who shipped some of the items, we believe that a substantial portion of these shipments through UPS and FedEx were personal items, in contrast with her prior statements to the National Committee.

Our conclusion is that the FedEx shipments of February 25 and March 4 that went to other than LPHQ were likely of a personal nature and recommend that the LNC direct her to repay the Party \$144.52 for those shipments. In addition, the UPS purchase and related shipment of March 30 describes personal items, some of which went to LPHQ and some to her apartment, and we recommend that the LNC direct

her to repay the Party \$504.75 for those expenditures. We believe it is possible that the \$307.03 FedEx shipment of February 25 that went to the LPHQ is likely business related. This one shipment seems to correlate to the bulk of audio tapes, video cassettes, and paper files shown in the pictures Ms. Howell provided to us. All told, we recommend that the LNC direct Ms. Howell to repay the Party \$649.27 less the \$200.00 she has already remitted, or \$449.27.

Once we received the available evidence, it became clear that numerous staff assertions about the nature of these shipments turned out to not be true. We originally initiated inquiry about two QuickBooks entries with memos indicating it was for Ms. Howell's moving expenses, though more than a year after she had moved. Mr. Kraus without any evidence available to him promptly claimed it was a misclassification caused by an accidental duplication of a memorized transaction, reclassified these as regular shipping of Party materials, asserted to us that a portion of it was items shipped back from the Chicago LNC meeting, and said he didn't know why his memos suggested it was Ms. Howell's personal items. The evidence shows that it was not a memorized transaction, and none of it was items shipped back from the Chicago LNC meeting. Later Mr. Kraus and Ms. Howell asserted to the LNC in the December meeting that all of the items were work-related, and they were all shipped to the office. After staff obtained the receipts under direction from the LNC, Ms. Howell asserted that most of the items shipped were work-related, and only a small portion was personal items. From our review of the receipt evidence it appears that most of the items shipped were personal in nature, with some of them shipped to her residence rather than the office, and less than half of the shipped material appears to have been work-related. In the end, the most accurate information we received from staff was the original memos on the QuickBooks transactions which indicated it was personal items, though staff proceeded to spend several months contradicting that original description.

WHISTLEBLOWER POLICY

One of the outstanding recommendations from our outside auditors was the development of a whistleblower policy. Attached as an exhibit, we have developed a whistleblower policy for your consideration using boilerplate language from the American Institute of Certified Public Accountants. Prior to adopting this or any other such language, we request that Staff and the LNC's legal counsel review this proposed language in light of our unique circumstances and any D.C. and Virginia laws pertaining to whistleblower protections.

DOCUMENT RETENTION POLICY

One of the outstanding recommendations from our outside auditors was the development of a document retention policy. Attached as an exhibit, we have developed a document retention policy for your consideration using boilerplate language from the Public Counsel Law Center, and included some additional document types addressed by the American Institute of Certified Public Accountants. Prior to adopting this or any other such language, we request that Staff and the LNC's legal counsel review this proposed language in light of our unique circumstances and any D.C. and Virginia laws pertaining to document retention.

Draft Libertarian National Committee Whistleblower Policy

General

The Libertarian National Committee Policy Manual requires directors, other volunteers, and employees to observe high standards of business and personal ethics in the conduct of their duties and responsibilities. Employees and representatives of the organization must practice honesty and integrity in fulfilling their responsibilities and comply with all applicable laws and regulations.

The objectives of the Libertarian National Committee Whistleblower Policy are to establish policies and procedures for:

- The submission of concerns regarding questionable accounting or audit matters by employees, directors, officers, and other stakeholders of the organization, on a confidential and anonymous basis.
- The receipt, retention, and treatment of complaints received by the organization regarding accounting, internal controls, or auditing matters.
- The protection of directors, volunteers and employees reporting concerns from retaliatory actions.

Reporting Responsibility

Each director, volunteer, and employee of the Libertarian National Committee has an obligation to report in accordance with this Whistleblower Policy (a) questionable or improper accounting or auditing matters, and (b) violations and suspected violations of LNC Policy Manual (hereinafter collectively referred to as Concerns).

Authority of Audit Committee

All reported Concerns will be forwarded to the Audit Committee in accordance with the procedures set forth herein. The Audit Committee shall be responsible for investigating, and making appropriate recommendations to the Board of Directors, with respect to all reported Concerns.

No Retaliation

This Whistleblower Policy is intended to encourage and enable directors, volunteers, and employees to raise Concerns within the organization for investigation and appropriate action. With this goal in mind, no director, volunteer, or employee who, in good faith, reports a Concern shall be subject to retaliation or, in the case of an employee, adverse employment consequences. Moreover, a volunteer or employee who retaliates against someone who has reported a Concern in good faith is subject to discipline up to and including dismissal from the volunteer position or termination of employment.

Reporting Concerns

Employees

Employees should first discuss their Concern with their immediate supervisor. If, after speaking with his or her supervisor, the individual continues to have reasonable grounds to believe the Concern is valid, the individual should report the Concern to the Director of Human Resources. In addition, if the individual is uncomfortable speaking with his or her supervisor, or the supervisor is a subject of the Concern, the individual should report his or her Concern directly to the Director of Human Resources.

If the Concern was reported verbally to the Director of Human Resources, the reporting individual, with assistance from the Director of Human Resources, shall reduce the Concern to writing. The Director of Human Resources is required to promptly report the Concern to the Chair of the Audit Committee, who has specific and exclusive responsibility to investigate all Concerns. If the Director of Human Resources, for any reason, does not promptly forward the Concern to the Audit Committee, the reporting individual should directly report the Concern to the Chair of the Audit Committee. Contact information for the Chair of the Audit Committee may be obtained through the Human Resources Department. Concerns may be also be submitted anonymously. Such anonymous Concerns should be in writing and sent directly to the Chair of the Audit Committee.

Directors and Other Volunteers

Directors and other volunteers should submit Concerns in writing directly to the Chair of the Audit Committee. Contact information for the Chair of the Audit Committee may be obtained from the Treasurer.

Handling of Reported Violations

The Audit Committee shall address all reported Concerns. The Chair of the Audit Committee shall immediately notify the Audit Committee, the President, the Executive Director, and Chief Operating Officer of any such report. The Chair of the Audit Committee will notify the sender and acknowledge receipt of the Concern within five business days, if possible. It will not be possible to acknowledge receipt of anonymously submitted Concerns.

All reports will be promptly investigated by the Audit Committee, and appropriate corrective action will be recommended to the Board of Directors, if warranted by the investigation. In addition, action taken must include a conclusion and/or follow-up with the complainant for complete closure of the Concern.

The Audit Committee has the authority to retain outside legal counsel, accountants, private investigators, or any other resource deemed necessary to conduct a full and complete investigation of the allegations.

Acting in Good Faith

Anyone reporting a Concern must act in good faith and have reasonable grounds for believing the information disclosed indicates an improper accounting or auditing practice, or a violation of the Policy Manual. The act of making allegations that prove to be unsubstantiated, and that prove to have been made maliciously, recklessly, or with the foreknowledge that the allegations are false, will be viewed as

a serious disciplinary offense and may result in discipline, up to and including dismissal from the volunteer position or termination of employment. Such conduct may also give rise to other actions, including civil lawsuits.

Confidentiality

Reports of Concerns, and investigations pertaining thereto, shall be kept confidential to the extent possible, consistent with the need to conduct an adequate investigation.

Disclosure of reports of Concerns to individuals not involved in the investigation will be viewed as a serious disciplinary offense and may result in discipline, up to and including termination of employment. Such conduct may also give rise to other actions, including civil lawsuits.

DRAFT LIBERTARIAN NATIONAL COMMITTEE DOCUMENT RETENTION AND DESTRUCTION POLICY

1. Policy and Purposes

This Policy represents the policy of Libertarian National Committee, Inc. (the "organization") with respect to the retention and destruction of documents and other records, both in hard copy and electronic media (which may merely be referred to as "documents" in this Policy). Purposes of the Policy include (a) retention and maintenance of documents necessary for the proper functioning of the organization as well as to comply with applicable legal requirements; (b) destruction of documents which no longer need to be retained; and (c) guidance for the Board of Directors, officers, staff and other constituencies with respect to their responsibilities concerning document retention and destruction. Notwithstanding the foregoing, the organization reserves the right to revise or revoke this Policy at any time.

2. Administration

- **2.1 Responsibilities of the Administrator.** The organization's Executive Director shall be the administrator ("Administrator") in charge of the administration of this Policy. The Administrator's responsibilities shall include supervising and coordinating the retention and destruction of documents pursuant to this Policy and particularly the Document Retention Schedule included below. The Administrator shall also be responsible for documenting the actions taken to maintain and/or destroy organization documents and retaining such documentation. The Administrator may also modify the Document Retention Schedule from time to time as necessary to comply with law and/or to include additional or revised document categories as may be appropriate to reflect organizational policies and procedures. The Administrator is also authorized to periodically review this Policy and Policy compliance with legal counsel and to report to the Board of Directors as to compliance. The Administrator may also appoint one or more assistants to assist in carrying out the Administrator's responsibilities, with the Administrator, however, retaining ultimate responsibility for administration of this Policy.
- **2.2 Responsibilities of Constituencies.** This Policy also relates to the responsibilities of board members, staff, volunteers and outsiders with respect to maintaining and documenting the storage and destruction of the organization's documents. The Administrator shall report to the Board of Directors (the board members acting as a body), which maintains the ultimate direction of management. The organization's staff shall be familiar with this Policy, shall act in accordance therewith, and shall assist the Administrator, as requested, in implementing it. The responsibility of volunteers with respect to this Policy shall be to produce specifically identified documents upon request of management, if the volunteer still retains such documents. In that regard, after each project in which a volunteer has been involved, or each term which the volunteer has served, it shall be the responsibility of the Administrator to confirm whatever types of documents the volunteer retained and to request any such documents which the Administrator feels will be necessary for retention by the organization (not by the volunteer). Outsiders may include vendors or other service providers. Depending upon the sensitivity of the documents involved with the particular outsider relationship, the organization, through the Administrator, shall share this Policy with the outsider, requesting compliance. In particular instances,

the Administrator may require that the contract with the outsider specify the particular responsibilities of the outsider with respect to this Policy.

- 3. Suspension of Document Destruction; Compliance. The organization becomes subject to a duty to preserve (or halt the destruction of) documents once litigation, an audit or a government investigation is reasonably anticipated. Further, federal law imposes criminal liability (with fines and/or imprisonment for not more than 20 years) upon whomever "knowingly alters, destroys, mutilates, conceals, covers up, falsifies, or makes a false entry in any record, document, or tangible object with the intent to impede, obstruct, or influence the investigation or proper administration of any matter within the jurisdiction of any department or agency of the United States ... or in relation to or contemplation of any such matter or case." Therefore, if the Administrator becomes aware that litigation, a governmental audit or a government investigation has been instituted, or is reasonably anticipated or contemplated, the Administrator shall immediately order a halt to all document destruction under this Policy, communicating the order to all affected constituencies in writing. The Administrator may thereafter amend or rescind the order only after conferring with legal counsel. If any board member or staff member becomes aware that litigation, a governmental audit or a government investigation has been instituted, or is reasonably anticipated or contemplated, with respect to the organization, and they are not sure whether the Administrator is aware of it, they shall make the Administrator aware of it. Failure to comply with this Policy, including, particularly, disobeying any destruction halt order, could result in possible civil or criminal sanctions. In addition, for staff, it could lead to disciplinary action including possible termination.
- **4. Electronic Documents; Document Integrity.** Documents in electronic format shall be maintained just as hard copy or paper documents are, in accordance with the Document Retention Schedule. Due to the fact that the integrity of electronic documents, whether with respect to the ease of alteration or deletion, or otherwise, may come into question, the Administrator shall attempt to establish standards for document integrity, including guidelines for handling electronic files, backup procedures, archiving of documents, and regular checkups of the reliability of the system; provided, that such standards shall only be implemented to the extent that they are reasonably attainable considering the resources and other priorities of the organization.
- **5. Privacy.** It shall be the responsibility of the Administrator, after consultation with counsel, to determine how privacy laws will apply to the organization's documents from and with respect to employees and other constituencies; to establish reasonable procedures for compliance with such privacy laws; and to allow for their audit and review on a regular basis.
- **6. Emergency Planning.** Documents shall be stored in a safe and accessible manner. Documents which are necessary for the continued operation of the organization in the case of an emergency shall be regularly duplicated or backed up and maintained in an off-site location. The Administrator shall develop reasonable procedures for document retention in the case of an emergency.
- **7. Document Creation and Generation.** The Administrator shall discuss with staff the ways in which documents are created or generated. With respect to each employee or organizational function, the Administrator shall attempt to determine whether documents are created which can be easily segregated from others, so that, when it comes time to destroy (or retain) those documents, they can be easily culled from the others for disposition. For example, on an employee-by-employee basis, are emails and other documents of a significantly non-sensitive nature so that they might be deleted, even in the face of a litigation hold with respect to other, more sensitive, documents? This dialogue may help in

achieving a major purpose of the Policy -- to conserve resources -- by identifying document streams in a way that will allow the Policy to routinely provide for destruction of documents. Ideally, the organization will create and archive documents in a way that can readily identify and destroy documents with similar expirations.

LIBERTARIAN PARTY BALLOT ACCESS ACTION REPORT Libertarian National Committee meeting Alexandria, Virginia March 1-2, 2014

Dear Colleagues:

If we lived in a nation with just election laws, we wouldn't have to pursue ballot access. Unfortunately, that is not the case. The following memo addresses petitioning opportunities for the LNC in 2014, and through 2016.

I want to thank Bob Johnston, LP of Maryland Chair and an Independent Contractor to the LNC, for his work in contacting various state parties and their Chairs, and his preparation of the table that is a part of this report, and Richard Winger and Paul Frankel for their assistance in updating this report.

We currently have ballot access in the following 32 states (plus DC): AK, AZ, AR, CA, CO, DE, FL, GA, ID, IN, HI, KS, LA, MD, MI, MS, MO, MT, NE, NV, NM, NC, ND, OH, OR, SC, SD, TX, UT, VT, WV & WY. This assumes that all paperwork will be filed on a timely basis.

Current petition drive updates:

States in which we could be circulating a petition in 2013 or 2014 are:

AL: Petitioning (not subsidized by the LNC) has been ongoing for local candidates in AL. Since the December 2013 LNC meeting, the EC encumbered \$12,500 of LNC funds to complete sufficient petitioning to allow the LPAL to run one US House candidate, about ten State House candidates, and several score candidates for lower offices in 2014. The petition contract with Paul Frankel has been circulated to the LNC, but it has not been approved. Accordingly, none of the \$12,500 has yet been spent by the LNC.

The AL legislature has, historically, been horrible on ballot access, and it might behoove us to get a candidate on for US House to send a message and to help develop the LPAL. There has been only one LPAL candidate for public office (other than President) after 2002.

In AL, no Democrat is running for four (4) statewide offices in 2014: US Senator, Supreme Court Justice (a partisan office), Public Service Commissioner Seat One and Public Service Commissioner Seat Two. Also, the AL House Elections Committee has passed HB 327, lowering the number of signatures from 44,829 to 22,415. If it passes it will take effect immediately. The petition deadline is June 3, 2014. The vote test is 20% for any statewide office. If the bill passes we should consider petitioning in Alabama this year. In 2000, there were two Alabama races with no Democrat in a statewide race. We were on the ballot as a party that year and we got over 20% for one of them. If we got at least 20% in one of those four elections this year, we would retain ballot status through

2016, at which time we would likely be in some more two-way elections. Also in 2012, in the three states in which we were in two-way statewide races, we got 34% in Georgia, 43% in Montana, and 22% in Texas.

IL: The LPIL request for funds from the LNC is \$66,500. I have not asked the EC yet to encumber funds for IL, but, if that is going to be done (either by the EC or the LNC), it needs to be done by March 2, as the start date of the IL petition drive is Tuesday, March 25, and the drive lasts only 90 days. I (Bill Redpath) will be in Illinois from Memorial Day 2014 through the following Friday to work as a volunteer on this petition drive, hopefully doing petitioning.

MA: If the LPMA runs for a minor statewide office (Attorney General, Secretary of the Commonwealth, Treasurer or Auditor) and earns at least 3% of the vote (which is highly likely) in 2014, the LPMA would be ballot qualified for 2016. It would take only a 5,000 valid sig petition drive for one of these offices. LPMA Chair Dave Blau thinks this would be good to do and requests \$10,000 from the LNC for successful completion of the petition drive.

NH: Governor and US Senate candidates can get on in 2014 with Independent petitions for 3,000 valid sigs each. If either candidate would receive at least 4% of the vote, the LP would get party status again in NH.

NM: If the LP completed an 6,018 valid sig petition drive for a candidate for statewide office, and that candidate got at least 5% of the vote in November 2014, the LPNM would be entitled to its own primary, and we would no longer have to complete such arduous candidate petitions to run candidates for office in NM (except President, which requires zero sigs). We got 8.5% for Land Commissioner in 1998. There are about seven "low level" statewide offices in NM in 2014, and the petition deadline is in late June 2014. We would also need to increase our voter registration percentage to 0.33333333%. We now have about 3,541 voter registrations in NM, and we would need to increase that number by about 625.

I have spoken with LPMN Chair Mike Blessing, but he does not know of someone in the LPNM who wants to run for one of these "low level" statewide offices.

NY: There will be a 15,000 valid sig petition for our statewide candidates (including Governor) in 2014. Our Governor candidate in 2010, Warren Redlich, received 48,386 votes for Governor. Gary Johnson got 47,256 votes for President in New York in 2012. 50,000 votes are needed to retain ballot status for the next four years. LPNY Chair Mark Axinn says that LPNY plan includes volunteer petitioning, and (as I recall) \$10,000-15,000 of LPNY funds. He says that \$25,000-30,000 from the LNC will be needed to successfully complete this petition drive. The drive occurs during a six week period from about July 10 to about August 20.

OK: Richard Prawdzienski is filing as an independent for Governor of Oklahoma in 2014, so in a sense we will be "on" the ballot in Oklahoma this year. He just needs a

filing fee and it isn't too high. He will be the first Libertarian on the ballot for Governor of Oklahoma in history, but without a "Libertarian" label.

PA: Ken Krawchuk got the LPPA nomination for Governor, and Henry Haller got the nomination for Lt. Governor on 2/22/2014. The results of those elections will not qualify the LPPA for the 2016 ballot. We need to do a petition in 2016. About 16,625 valid sigs will be needed on the 2014 petition. The LPPA will attempt to do this on an all volunteer basis, with the petition drive starting on March 12, 2014 and ending on August 1, 2014. Emphasis will be put on Primary Day petitioning on Tuesday, May 20. We can assess the situation after Primary Day to see if paid petitioning will be needed in PA. I attended the LPPA convention on 2/22/2014 and told the delegates not to expect financial help for the petition drive from the LNC this year

VA: Rob Sarvis, the 2013 Governor nominee, got the LPVA nomination for US Senate in 2014. 10,000 valid sigs would be needed, with ballot retention if that candidate received 10% of the vote. I do not think the LNC should subsidize this drive, given that vote percentage retention requirement.

WI: I intend to work with the LPWI Chair to lobby to make a minor change to the law that would get the LPWI ballot status (the Constitution Party has ballot status now because they got over 1% for US Senate in 2010, and the LP got over 1% for US Senate in 2012, but only the vote for President applies in Presidential election years). If that does not work, we would have to do 2,000 valid sigs on a separate petition for each office, but if we got 1% for Governor/Lt. Governor, or Secretary of State, or Treasurer or Attorney General, the LP would have ballot status for the next four years in WI.

2014 Summary: IL for \$66,500, plus NY for \$25,000-30,000, plus MA for \$10,000 equals \$101,500-106,500, plus the \$12,500 encumbered for AL equals \$114,000-119,000. The Ballot Access expense budget for 2014 currently stands at \$120,900, which would allow \$1,900-6,900 for other uses during the year.

2016 Petitioning:

AL: 5,000 valid sig petition for Independent for President that cannot start until Memorial Day 2016, as there is no substitution for President or VP in Alabama. Early September 2016 deadline.

CT: 7,500 valid sigs in 2016 for President. The LPCT is working with the ACLU to possibly litigate the out-of-state petitioner ban in CT. This drive will likely need some subsidization from the LNC.

IA: 1,500 valid sigs in 2016 for President. This needed LNC subsidization in 2012.

KY: 5,000 valid sigs for President in 2016, with a petition that can start to circulate the day after Election Day 2015. There is a US Senate race in KY in 2014, but ballot status cannot be gained through the results of that election.

ME: 4,000 valid sig petition for Independent for President that cannot start until Memorial Day 2016, as there is no substitution for President or VP in Maine.

MN: 2,000 valid sig petition for President in 2016. This needed LNC subsidization in 2012.

NJ: 800 valid sigs in 2016 for President. Unfortunately, this required LNC subsidization in 2012. And, it is my understanding that the LPNJ could not get the 800 valid sigs needed for the recent US Senate election in NJ. In my opinion, the LPNJ has some bad habits in the operation of its petition drives, and I will work with the LPNJ Chair in 2016 or before to change that.

OK: Unless something changes through litigation or lobbying, this will be a 40,000+ sig petition drive.

RI: 1,000 net sigs for a Presidential petition. The LPRI needed LNC help for this petition in 2012.

TN: Because the TN ballot access law has been found to be unconstitutional, the LP may be a ballot qualified party in TN, just as has been the case in OH over the past few years. If not, it is 275 net sigs for a Presidential petition. The LPTN needs to work to get this done well ahead of the deadline in 2016, not let it go to a last day fire drill, as in 2012.

VA: In 2016, VA will require only 5,000 valid sigs for a Presidential petition. I do not know if this can be done totally volunteer or if the LPVA will have funds for this, as the LPVA's cash minus liabilities now is only about \$9,000. Some small LNC subsidization may be necessary.

Chair, Membership Level Review Committee

The members of the Membership Level Review Committee (MLRC) are Michael Cloud, Mark Hinkle, Jim Lark, Scott Lieberman, and Rich Tomasso. The committee was established by Geoff Neale during the LNC meeting on March 16-17, 2013. Mr. Neale appointed the members of committee, and appointed Dr. Lark to serve as chair.

The charge of the Committee was to recommend membership/contribution levels (and associated benefits) that would garner the support of a strong majority ("a supermajority") of the LNC. The Committee provided its recommendations on July 8, 2013, for consideration by the LNC. The LNC did not adopt the recommendations.

Shortly after the conclusion of the LNC meeting on July 14, 2013, Mr. Neale requested that the MLRC continue its work on recommendations concerning membership/contribution levels. As of this moment the MLRC has not chosen to offer new recommendations.

I have enclosed below the current language of Section 2.05 ("Membership Policies"), subsection 2 ("Association Levels"), subsection 3 ("Life Membership Status"), and subsection 4 ("Benefits") of the Policy Manual, as well as the list of membership/contribution levels and associated benefits proposed by Rich Tomasso and included in the MLRC's recommendations in its July 8, 2013 report.

Since it appears likely that the LNC will soon purchase a building, it would be appropriate for LNC members to review both the current language of the Policy Manual and Mr. Tomasso's list of proposed membership/contribution levels and associated benefits. If the LNC wishes to change the Policy Manual regarding these issues, it would be appropriate for members to suggest changes at the upcoming meeting, and if necessary consider specific proposed changes via e-mail ballot.

From the Policy Manual:

2) Association Levels

Until the LNC takes occupancy of a purchased building:

The following levels of association are recognized by the Party:

- Basic \$25 annual dues payment
- Regular \$50 annual dues payment

- Supporting \$100 annual dues payment
- Sponsor \$250 annual dues payment
- Patron \$500 annual dues payment
- Torch Club \$1,000 in dues or contributions prior twelve months
- Chairman's Circle \$5,000 in dues or contributions since last convention

Effective after the LNC takes occupancy of a purchased building:

The following levels of association are recognized by the Party:

- Chairman's Circle* \$25,000 annually or \$2500 monthly in dues or contributions
- Select Benefactor* \$15,000 annually or \$1500 monthly in dues or contributions
- Beacon of Liberty* \$5,000 annually or \$500 monthly in dues or contributions
- Pioneer of Freedom* \$2,500 annually or \$250 monthly in dues or contributions
- Lifetime Founder* \$1,500 annually or \$150 monthly in dues or contributions
- Patriot \$500 annually or \$50 monthly
- Minuteman \$250 annually or \$25 monthly
- Advocate \$150 annually or \$15 monthly
- Supporter \$50 annually
- Foundation Member \$25 annually

Convention registration does not count towards contribution levels.

3) Life Membership Status

Until the LNC takes occupancy of a purchased building:

During the convention, at an appropriate time, the Chair will recognize en masse, in turn, new Life Members, and those who reached Torch Club or higher.

Premiums:

Monthly pledgers at \$10/mo or greater (Minuteman level) will get a monthly pledge newsletter. Additional news may be made available to pledgers at greater levels.

other special ticketed events, with the understanding that seating may be limited and will be made available first-come first-serve.

Members at Silver and above will have the opportunity for seating with keynote speaker, the national chair or LNC officer at the National Convention banquet(s).

Members at Gold and above will have the opportunity for seating with the presidential or vice presidential nominee, keynote speaker, national chair or LNC officer, or other candidate of their choice, at the National Convention banquet(s).

Members at Silver and above will have priority to reserve any available hospitality suites at the hotel, behind the presidential candidates.

Strictly subject to availability and scheduling, Gold members and above may be given naming rights to National Convention events.

With the approval of the Executive Committee, in consultation with the appropriate Convention Committee, additional National Convention benefits such as a private lounge, upgraded rooms, free amenities, comped travel to/from airport, or the like may be made available to members at the Chairman's Circle and above.

("**Seller**"), concerning Company's proposed acquisition from Seller for a purchase price of \$825,000 of the property legally described as Lot 16, Round House Square, and commonly known as 1444 Duke Street, Alexandria, Virginia ("**Property**");

WHEREAS, the principal place of business of the Company, and the location where the Company's Executive Director and other principal employees currently maintain their offices, is currently 2600 Virginia Avenue, N.W., Suite 200, Washington, DC, but this Board has determined it is in the best interest of Company to move such principal place of business, and the location where the Company's Executive Director and other principal employees maintain their offices, to a location owned by the Company, such as the Property; and

WHEREAS, this Board has determined that the acquisition of the Property would be in the best interests of Company.

NOW, THEREFORE, IT IS RESOLVED that the acquisition of the Property from Seller and movement of the Company's principal place of business to the Property is ratified and approved in all respects;

FURTHER RESOLVED, that any one or more of Company's officers is authorized, for and on behalf of Company, to negotiate the terms and conditions of a purchase agreement and any other ancillary agreements, instruments, and documents with respect to the acquisition of the Property, all containing such terms and conditions as such officer(s) deem necessary, appropriate, or convenient (which with such further additions, omissions, or changes as are authorized by these resolutions are collectively referred to as the ("Agreements") in these resolutions); and

FURTHER RESOLVED, that the signing, delivery, and performance of each of the Agreements by any one or more of the Company's officers, and the consummation of the acquisition of the Property, by and on behalf of Company is authorized; and that, when signed

and delivered, the Agreements shall be binding upon and enforceable against Company in accordance with their respective terms.

AUTHORITY TO BORROW

FURTHER RESOLVED, that any one or more of Company's officers is authorized, for and on behalf of Company, to negotiate and procure loans from Branch Banking and Trust Company ("**Lender**") in connection with the acquisition of the Property, and to grant a security interest in, pledge, mortgage, assign, or otherwise encumber to Lender any or all assets and properties of Company, both real and personal, tangible and intangible, now owned and in the future acquired, wherever located, as security for any such loan or other extension of credit, all upon such terms and conditions as such officer(s) may deem necessary, appropriate, or convenient; and

FURTHER RESOLVED, that any one or more of Company's officers is authorized, for and on behalf of Company, to sign or endorse, acknowledge (where required), and deliver to Lender such loan agreements, promissory notes, mortgages, deeds of trust, leases, and any other documents or instruments (including, without limitation, amendments or restatements of the agreements, notes, mortgages, leases, or other documents) as may seem necessary, appropriate, or convenient to such officer(s) in connection with any loan or other extension of credit, or in connection with any amendment, renewal, or extension of any such transaction.

OTHER ACTIONS AND RATIFICATION

FURTHER RESOLVED, that any one or more of Company's officers is authorized to take such other actions as such officer(s) shall deem necessary, appropriate, or convenient to carry out these resolutions; and

FURTHER RESOLVED, that all actions of Company and its officers to date consistent with these resolutions are ratified, approved, and affirmed in all respects.

SUBJECT: Counsel's Report

Introduction

This report summarizes my work as general counsel to the LNC since December 1, 2013, the date of my previous report. The report is not privileged and confidential, as it simply relates facts and does not constitute legal advice. It may be disclosed to other members of the Libertarian Party, in your discretion.

General

I have reviewed documents and correspondence, responded to questions, and provided legal advice and assistance on a variety of matters, including the following: conducting ballot access litigation in Illinois and Alabama; reviewing documents in connection with the LNC's proposed purchase of new office space; legal research regarding a state affiliate's loss of corporate status; legal research regarding the LP's trademarks; legal research regarding whether a state LP affiliate and a PAC may employ the same person simultaneously; drafting a nondisclosure agreement between the LNC and banks with which the LNC forms affinity credit card relationships; reviewing documents relating to invoices submitted by Michael Cloud; reviewing the Third Interim Report of the 2012/2014 Libertarian Party Audit Committee and related documents.

Litigation

Libertarian Party of Michigan, et al. v. Secretary of State - This action was commenced on June 25, 2012 in federal district court in Detroit seeking declaratory and injunctive relief from the secretary of state's refusal to place Gary Johnson on the November general election ballot, on the ground that he was listed on Michigan's Republican presidential primary ballot and was therefore barred from the November ballot by the state's "sore loser" law. I represent the plaintiffs along with co-counsel Mark Brown. This litigation was pursued on an emergency basis at the U.S. District Court, U.S. Court of Appeals and U.S. Supreme Court levels, but Gary Johnson was not granted access to the Michigan ballot. Because the issues involved are so important, we continued the litigation after the election was over. In May the Sixth Circuit Court of Appeals issued a final decision against us, and in July it denied our petition for rehearing. In September I prepared and filed a petition for certiorari (discretionary review) with the Supreme Court. Unfortunately, the Supreme Court denied the petition. This litigation is now concluded.

Libertarian Party of Illinois, et al. v. Illinois State Board of Elections, et al. This action was commenced on April 5, 2012 in federal district court in Chicago seeking declaratory and injunctive relief from Illinois' June 25th filing deadline for petitions to form a new party; an ambiguity in the law relating to the calculation of signature requirements; and a requirement that a candidate for statewide or countywide office be part of a full slate of candidates for state or county offices. Subsequently I discontinued our challenge regarding the signature requirements because, while the applicable statutes are disorganized and confusing, the signature requirements themselves are not ambiguous. The state made a motion to dismiss the case, and I prepared and filed a brief opposing the motion. In September 2012 the court issued a decision refusing to dismiss the case but indicating that the filing deadline is not unconstitutional. Pre-trial discovery has been completed. I made a motion for summary judgment on the remaining issue (the "full-slate" requirement) and prepared an initial brief, a reply brief and a sur-reply brief. The case has been fully briefed and ready for a decision since mid-July 2013. However, a decision has been delayed because the case was transferred to a new judge. Subsequently it was again transferred to yet another new judge. We are still awaiting a decision.

Stein, et al. v. Bennett. I recently took this case over from other counsel at the request of some of the plaintiffs, who are the Libertarian, Constitution and Green parties of Alabama, their candidates for president in 2012, and several of their officers and supporters. The action was commenced in January 2012 in federal district court in Alabama seeking declaratory and injunctive relief from Alabama's March petition deadline for a minor party to place its presidential candidate on the November general election ballot along with the party's name. The March deadline is now the earliest such deadline in the country. In September 2013 the plaintiffs lost in federal district court, and I stepped in to handle the appeal. I have prepared and filed a brief with the U.S. Court of Appeals for the Eleventh Circuit and will prepare a reply to the secretary of state's responsive brief when I receive it.

Libertarian National Committee Region 1 Report

Overview

- The ten affiliates which comprise Region 1 are: Alaska, Arizona, Colorado, Hawaii, Idaho, Kansas, Montana, Utah, Washington, and Wyoming.
- Nine of the ten states in the region are currently ballot qualified for 2014. The exception, Washington, requires only 1,000 valid signatures. Washington has obtained ballot access without assistance for several election cycles now.
- Due to the geographic nature of this region, which spans five time zones and extends from 19 to 71 degrees north latitude (some 3,000 x 3,000 miles), personal contact between the Regional and Alternate Representatives and the individual affiliates is quite rare.

Alaska

Michael Chambers, State Chair

Former Chair Mark Fish has stepped aside for personal reasons and former Vice Chair, Michael Chambers, is now acting Chair until the Party's convention on April 27.

Chair Chambers is following through on the electoral strategy promoted by Mark Fish. Electable candidates in two Alaska House districts have changed their registration to Libertarian and are considering running as Libertarians for State Representative from districts 19 and 21. (Alaska is undergoing a delayed redistricting for the 2014 election cycle. What used to be district 17 will become district 19 in the 2014 general election, and what was formerly district 19 will become district 21.)

These candidates received 41% and 44% of the vote in the 2012 election in their districts. Both of these districts are traditionally democratic and both candidates ran as Republicans. However, Alaska is a very Libertarian state; and 53% o all voters are registered as "Uaffiliated" or "NonPartisan". Thus, a three way race with electable candidates is capable of producing a Libertarian victory.

To retain ballot access in Alaska for the 2016 general election, the Libertarian gubernatorial candidate needs to capture 3% of the vote. In Alaska, ballot access retention requires 3% of the top line on the ballot. Since 2014 ballot includes the governor's race, that's the race which counts for ballot access retention.

Arizona

As the pseudo Top Two legislation in Arizona has been successfully recalled, and the recall effort is considered likely to succeed, the Republicans are now trying to repeal the pseudo Top Two legislation. Should the recall succeed, Arizona law would prohibit the introduction of similar legislation in the future. Thus, the Republicans are trying to repeal the legislation so that they can introduce and pass similar, but perhaps not so drastic, versions thereof. If they lose the recall, which many Republicans consider likely, they will be forever prohibited from pursuing this line of legislation. Arizona Libertarians are hoping that the Republicans are unsuccessful in repealing the law so that a successful recall will preclude similar battles in the future.

Ballot access relies on registration numbers which are over the requirement, but just barely so. Candidates are being recruited for 2014.

Colorado

For Jeffery Orrok, Norm Olsen reports:

LPCO continues to develop its master membership list using the web based list management system produced and maintained by Big L Solutions. Since the inception of the program, some 6,000 initial contact calls were made to obtain current information from voters registered as Libertarians. LPCO can now maintain communication with these voters on a regular basis through electronic means. 18,000 more registered Libertarians are yet to be contacted.

LPCO's 2014 convention will be held at the Denver West Marriot in Golden Colorado on the weekend of March 28, 2014. Candidates for the 2014 general election will be selected at that event. In the event that two or more candidates for a particular office receive 30% or more of the delegate vote, Colorado law requires that the eventual general election candidate be selected by primary. In any case, petitioning is not required for any partisan election in the state. Candidate recruitment is already underway. The LPCO goal is to have not less than 5 Libertarians on every ballot in the state.

Idahoan's can now register as affiliate with a political party, and some 3,412 have registered as Libertarians. Rob Oates figures there would be a lot more, but the primaries in Idaho are now closed primaries. This trend is reinforced by the fact that the winner of the Republican primary is quite often the de-facto elected official in this heavily republican state. Kansas

Libertarian registration is up by 10% yet again in Kansas, now totaling 11,628; while unaffiliated has grown to 30% of all registered voters.

The 2014 annual convention at which general election candidates will be selected is scheduled for April 26, 2014 at the Holiday Inn East (549 South Rock Road) in Wichita Kansas. Gary Johnson is scheduled to be the Saturday night banquet speaker. A Friday night mixer is also planned.

It is at this convention that "will set in motion the final stage of our statewide plan to win Major Party status in the governor's race on November 4th." Tresa McAlhaney is actively campaigning for the gubernatorial nomination. Major party status can be achieved by garnering 5% of the vote in the governor race. The LPKS has developed a strong capability of generating positive media coverage by latching on to specific issues and becoming their major advocate. Second amendment issues have been used very successfully, now gay marriage issues are being tackled.

Montana

A court challenge has been made against LR 127, the Top Two primary legislation in Montana. A court challenge of a similar measure (LR 126) for similar reasons was rejected, so there is reason to be pessimistic concerning the court challenge to LR 127. The challenge is based on the fact that the actual ballot title is too long (law requires not more than 100 words, the title has 196 words) and that it addresses more than one subject.

Assuming the court challenge fails to remove the measure from the 2014 ballot, the measure will need to be vigorously fought in the public opinion arena. Losing this battle will put yet another very Libertarian state into Top Two limbo state. Until a court decision is reached, it is difficult to generate action. Hopefully, the court will rule soon so we will know what, if anything, needs to be done in Montana.

What could the LNC spend money on to help us defeat LR 127? Maybe a \$1,000 dollars seed money just in case. I need to send out a fund raising letters out to our mailing list and to other politicians who may be inclined, hopefully, to contribute. Would they contribute to the MTLP or would I be better off starting a different group?

UM College Libertarians are collecting names for the 2013-2014 school year to become a campus group. The process seems to be slow, so I hope they got all the paperwork submitted. We did the same thing down at Montana State University, but we're having troubles finding an advisor.

[NTO: Mike has chosen to start a political committee to fight LR 127. This will enable him to seek non-Libertarian support (i.e. like Democrats) to help ensure the defeat of this measure. There is another ballot issue (HB-405) which the Democrats are actively opposed to and vigorously fighting. Thus, there is ample opportunity for cooperation and mutual effort. Coordinating this will be a challenge for the MTLP. It is very important that the LNC provide support to ensure defeat of LR 127.

My e-mail tag for several years has been "First they ignore you, then they ridicule you, then they fight you, then you win". In Montana, we have reached the point where the Republicans are fighting us. This is indeed a battle which we need to fight, and a battle we cannot afford to lose.

Please keep in mind that Montana is a very Libertarian state. Gary Johnson received 2.9% of the vote in Montana (three times the national average). That's second only to Gary Johnson's home state of New Mexico. In a recent statewide election, Libertarian Mike Fellows received Libertarian record of 43% of the vote. To cede Montana to the Republicans would be a disastrous mistake for us Libertarians.]

How the "Top-Two" Primary System in Washington Will Actually Help Libertarians Get Elected, by Michael Pickens

The dreaded Washington State "Top-Two" initiative, which was voted into law in 2004 and implemented in 2006, is cited by many as the main reason for the Libertarian Party of Washington's subsequent decline. I love it; why do so many good Libertarian activists hate it?

For those of you who are not familiar with the "Top-Two" primary system, this election law basically states that only the top two vote recipients from the primary election will move on to the general election (You can learn more about the "Top-Two" primary system at http://www.sos.wa.gov/elections/fagcandidates.aspx).

Let's say there are three candidates in the primary election: Libertarian, Republican, and Democrat. Only the two candidates who receive the most votes will move on to the general election.

Critics of this system say that it's unfair to 3rd-party candidates. I, for one, had initially bought into the rhetoric fed to me by Libertarian Party leadership: "'Top-Two' is very bad! We must fight 'Top-Two!'" These critics state that the law limits the choices that voters will have come Election Day, because there would only be two candidates to choose from in the general election.

While this is true, it doesn't change the fact that voters could vote for whichever candidate they wanted to in the primary and send their candidate of choice to the general election. Instead of battling through the general election, candidates would fight it out in the primary.

The Advantage of "Top-Two"

Have you ever heard these phrases?

"Libertarians are just spoilers."

"Voting third party is a wasted vote."

"Voting for a Libertarian will allow candidate X to win."

Fortunately for us, Libertarians in Washington can never be spoilers because there are only two candidates who move on to the general election ballot. We would also be able to focus our energy on an election with considerably lower voter turnout.

For example:

August 7th, 2012 Primary Election statewide voter turn-out: 1,435,928

November 6th, 2012 General Election statewide voter turn-out: 3,167,128

Almost 2 million fewer voters, 1,731,200 to be exact, came out to vote in the primary. This is a huge advantage for us and we are planning on using it. By focusing on the primary, we could secure a place in a general election with only one competitor.

Let's break down those numbers in an actual district where we have a candidate running.

Libertarian Chris Rockhold is running for State Representative Position 2 in the 17th Legislative

District (I am going to use numbers from 2010 because it is the last non-presidential election year).

In the 2010 17th District Primary, 27,171 ballots were cast. In the 2010 17th District General Election, 49,202 ballots were cast out of 74,853 registered voters. That's 22,031 fewer votes cast in the primary than cast in the general election!

So instead of having to compete amongst the 49,000 ballots cast in the general election, we'd only have to compete amongst the 27,171 ballots cast in the primary. Even then, we'd only have to come in 2nd place to have a chance at pulling out a win!

Impact of Moving Through the Primary

2nd place in the primary is a win for the LPWA. Defeating either a Republican or Democrat in the primary will signal a massive shift in the electorate. No one can argue against the fact that the fastest-growing demographics of American voters are the "Independents" and "Decline-to-state" voters. It is up to us to prove to them that the Libertarian Party is ready to be part of the mainstream political spectrum.

This August primary will be a major test for us in the LPWA. A primary win will set the tone for future success. Please help us provide our candidates with the resources necessary to make it through a primary and give the finger to the corrupt establishment that introduced the "Top-Two" law with the intent of discouraging 3rdparties. LPKY REPORT - LNC MARCH MEETING - WASHINGTON DC

Structure

We continue to grow and build our ground team; still our #1 priority in LPKY. More county parties are being developed. Growing slower than hoped, but we're focused on ensuring any growth is stable. Stability is critical. We still only know about 3411 registered Libertarians, as redistricting is still going in KY and we apparently won't have updated numbers until the end of April.

Candidates

At our state convention, we expect to nominate a candidate for US Senate. This race will probably come down to Mitch McConnell versus Alison Lundergan Grimes versus our candidate.

I'm personally encouraging people to run for local, winnable, partisan office. I want a partisan win in KY. I still have a reward of a steak dinner for the first partisan Libertarian to get over 10% in a partisan three-way race. The initial filing deadline for non-federal candidates is April 1st (no such requirement for federal candidates). Petitions due for any office in August.

Conventions

Our LPKY convention is happening March 1st in Danville, KY. We will be passing a state party platform, so I expect this to be the most

We're also having District and County conventions this year, taking place at various times throughout March. This is a relatively new thing for LPKY, as we continue to grow toward an lowa-caucus-style of

running our internal primaries once we reach critical mass on county parties.

Membership

We continue to have new members complaining about the "national versus state" dues, with the latest happening this week (writing this Feb 13th, issue happened on Feb 11th). I still would like to ask national to please consider a "single check out" option, where one can pay both sets of dues at once. This would increase the membership of both organizations. It's not that these people are unwilling to give to one or both organizations, but they feel like it's a bait-and-switch and it's out of my control; LPKY cannot give to LP National.

Legal

We are preparing some "tough questions" for the agencies responsible for monitoring elections in KY, which will likely end in legal challenges. We've already talked with these agencies and their hands are tied by stupidly-written state laws. We plan to attack these later this year, as the election season rolls along (establishing standing for inevitable legal action). We're also looking at taking legal action against county clerks that repeatedly and negligently are incorrectly registering our members as "Other" instead of "Libertarian".

LSLA

In my LSLA role, I'd like to let the LNC know that we're working to make LSLA an even better organization, and with the recent up-tick in state chairs interested in helping we're excited for the future of the LSLA. LSLA will be holding their annual convention on Thursday, June 26th at the same location as the LP National Convention, and the business meeting will happen the following Friday night.

Ohio LP wins another ballot access court battle with Ohio.

On January 7, the US District Court ruled that the LP and other minor parties could remain on the ballot for the 2014 election cycle in Ohio, including a party primary. This was a result of the case LPO vs SOS Husted after Senate Bill 193 was passed. The new law, which was 100% driven by the Republican Party, passed in November and would have stripped away primaries and ballot access for minor parties in 2014, unless they went back out and petitioned for new access. The issue was the lateness in the decision of the Ohio Assembly and that the law would go into effect on February 5, the same day the candidates were to file their petitions. But it didn't stop there, as the State of Ohio appealed the decision to the Sixth Circuit Court. On January 15 the Sixth Circuit Court ruled they would not expedite the case, which makes it very likely that minor parties will be able to have primaries and be on the November ballot in Ohio.

Further attacks on our candidates continued since February 24. Even though petitions are certified, in Ohio a party member can challenge a candidate petition. Sounds odd, but our members are determined by voting in a party primary and a "Trojan horse" could be in wait. Our candidate for Governor and Attorney General were both challenged by supposed party members. We believe some of the challengers are not registered with the LP in Ohio. But some are registered. We have a hearing on Monday, March 3 to review the case and give testimony. We had one Ohio House candidate challenged also. This happens to be our best funded candidate. I have never seen such behavior from a major political party.

Ohio LP State Convention is March 7 to March 9.

The State Convention will be held at the DoubleTree Hotel on the North side of Columbus, Ohio. The convention will feature speakers, workshops, annual business reports, annual awards, and the Saturday night banquet featuring speaker and journalist Ben Swann. Full details and registration is on the home page of www.lpo.org

Region 4 / California Report

The Libertarian Party of California's annual convention will take place on March 28th through March 30th at the Holiday Inn in Visalia. Business will include the election of new Executive Committee members and consideration of proposed changes to the Bylaws and Platform. For more information see: ca.lp.org/blog/archives/4689. In addition, the California Libertarian Women's Caucus will hold their first annual meeting at the convention.

The LPC has endorsed and is providing financial support for Calimesa City Council member (and Vice Mayor) Jeff Hewitt in his campaign for the State Senate District 23 seat, which covers parts of Riverside, San Bernardino, and Los Angeles Counties. This is for a special primary election on March 25th, with a possible runoff on June 3rd. Jeff has already raised \$14k on his own in three weeks. More information is available at Jeff's campaign web site: hewittd23.com.

Two libertarians are trying to qualify for the June primary ballot for statewide races: Jose Castaneda is running for Secretary of State, while Jonathan Jaech is running for Attorney General (his web site is jaech.info). Unfortunately the Top Two system has made it much more expensive even to get on the primary ballot, since the filing fee is \$3,000. Any contributions would be welcome.

California College Libertarians will be visiting local high schools during Government Day, beginning March 18th.

The latest report from the California Secretary of State shows that registration in the Libertarian Party has increased to 112,527, up from 109,636. This pushes us above the Green Party, which saw its registered voters decline to 108,785. It also means that we exceed the threshold of 103,004 registered voters (i.e., 1% of the total votes cast during the last gubernatorial election) needed to maintain our ballot-qualified status. Although that threshold will change following this November's gubernatorial election, and our voter registration numbers will also change, the Libertarian Party should be able to remain ballot-qualified for the 2016 election. (Prior to the Top Two system we were easily able to maintain our ballot-qualified status by having at least one of our statewide candidates receive more than 2% of the votes cast for that office. Now it's unlikely that any Libertarian candidate for statewide office will make the cut to appear on the November general election ballot.)

Region 5 North Report

This is the most geographically compact region, but each state has very different politics. We are still without an Alternate Rep.

Some affiliates are showing less activity, others have renewed activism and more social functions, some engaged in charitable work. Maine and Rhode Island bounced up from a recent lull and slid back.

For 2014, each affiliate (sans New Jersey) will be busy with petitioning (sans Vermont) and elections, some also have local (mostly non-partisan) races, but there are opportunities to share resources like petitioners and general LP advertizing that crosses borders.

There are always opportunities, the challenge is having the resources (time, money, people) to apply to capitalize on them. We are all small affiliates and are frugal with our resources. We may do another joint event, perhaps a candidate training. There have already been discussions about regional formation for the next LNC term. Would like more members to subscribe to the LP 5N yahoogroup.



The *New Hampshire Liberty Forum* hosted by the FSP, was February 20-23. We had a small presence there. It's reaching the size of the LP national convention.

Upcoming state conventions in the Region:

New Hampshire on March 8th in Manchester.

New Jersey on March 29th in Hightstown.

Vermont on April 26th in South Burlington.

Other events of interest:

Liberty Love Fest in Rhode Island on April 5. libertylovefest.org

Porcupine Freedom Festival (aka PorcFest) in Lancaster, NH June 22-29.

Several political trainings from C4L and Atlas.

Half the affiliates have set some ambitious goals for this year. Perhaps we can set up an informal competition for which state will be the first one done with petitioning.





Outreach

Our Facebook group has become a busy hub of activity, with member conversations and updates from party officers occurring almost daily. It has become our main online presence.

There is a strong effort underway to form a college Libertarians group at UConn.

The LPCT has an active email listserv that you can join at lpct.org. We have an Activists list and an Opinions list. The activists list is used far more often.

The new anti-gun-owner laws in Connecticut are generating a lot of attention. Still haven't finalized how we will fight them, but there are lots of opportunities.

Campaigns & Elections

We'll be kicking off election season early with a goal of having enough signatures for all of our candidates to be on the ballot by May. This will enable them to spend the summer and fall earning votes.

We are recruiting for Comptroller. We don't have ballot access for Governor but will definitely run a candidate. Doing well in this race (1%) gives us party status for the next election, and should permanently solve our ballot access issues.

Dan Reale will be the LP candidate in the second congressional district as he won enough votes in the last election so we don't have to petition.

Aaron Freeman is looking for help to collect signatures for an open State Senate seat in New Haven.

Marc Guttman will probably run again, but wait and see.

Bill Russell will head up forming the Norwich Libertarian Town Committee in February at which we will chose 16 candidates to run for Council, BOE, and Treasurer for Norwich in 2015. This way we can hit the ground running in January 2015.

Ballot Access Law

LPCT is working with LP National and the ACLU to overturn some of the more onerous provisions in state ballot access laws. These include restrictions on who can and cannot petition and the recent restrictions regarding running on multiple lines.



Good News!

On November 5, voters in Portland voted to legalize marijuana! A local ballot initiative that would make the possession of up to 2.5 ounces of marijuana legal for adults 21 and older passed with 67% of the vote. Supporters say they will build on Portland's vote with a statewide legalization effort in the next two years.

Current Activity

We've had a few county organizing meetings. Somerset county is the best organized.

The LPME Facebook page has more than 680 likes, up from 500 in June.

Our twitter feed, @LP_Maine, got realy active in November, with frequent tweets with news, updates and links to commentary.

The Future

We have lost some key executive committee members. Our convention is tenuous at best right now. I am hoping to have better news or at least some activities to report around the April timeframe. Delegates to the national Libertarian convention will be selected at our state convention. To attend as a delegate, you must be a current member of the LP.



General Activity and Outreach

We hold monthly meetups in the Boston area and we have five regional meetups established. Our Facebook (1900 Likes, up from 1100 in November) and Twitter presence grows with regular postings. The newsletter includes items of general interest and practical aspects of Libertarianism.

Libertarians are gathering signatures on an Initiative (officially known as "Petition C") to repeal the automatic inflation adjusted increases of the state gasoline tax that was enacted this summer. All details and reasons for it are at www.TankTheGasTax.org.

2014 Election Goals

We set a goal to run more LP candidates for state rep than the GOP currently has seats. Recruitment and promotion of this effort is already underway, as is our fundraising. We already have 8 candidates for 2014. The electoral effort will be focused on the legislature rather than the executive branch.

We are building up the list of unopposed state legislative races, the best opportunities for Libertarian breakouts. So far the list is rather long. We are also closely tracking what seats will have incumbents retiring, creating open races, that list is also growing.

Andrew Pontbriand, from Southbridge, got press coverage for his announcement running as a Libertarian candidate for the Worcester and Norfolk senate seat.

Robert Underwood also got a press mention for his candidacy for the 9th Hampden house seat.

Social Networks and Website

Our social networks continue to grow, our Facebook Group has 500 members, our Page has 300 Likes, and we have 900 Twitter followers (@LPNH). Twitter is our most active network, with new followers and re-tweets every day, and our Facebook group is more active every week. Our website backlog has grown, we need a new webmaster to take on several pending digital projects.

General Activity

Still working on making contacts with college YAL, S4L, etc groups. Want to work with them on upcoming projects and creating internships.

Pro-liberty activity abounds across the state, Libertarians have been involved in much of it, from rejecting Common Core, lots of First Amendment activism, asset forfeiture reform, fighting state-funded Medicaid expansion, and more. The NH House became the first to vote to legalize marijuana for all adults.

Looking at the election law bills to find something to support. We were promised two ballot access reform bills. There will be a slew of other bills to support and oppose.

Not enough volunteers came forward to have an exhibitor table at the NH Liberty Forum, but we did have a presence. I helped run a session on legislative activism. Bonnie Scott led a great session on restarting the LP Women's Caucus, we came up with some initiatives to attract and more importantly keep more women in the LP, plus some workshop ideas for the national convention. I talked with a few potential candidates. I also spoke with the LPMA coordinator about joint events we could do this year, perhaps a Liberty on the Rocks.

Rested Up For 2014

We have a lot in the pipeline for 2014. My hope is the time off in 2013 gave people a rest and they are ready to charge ahead refreshed. With some hard work and a little luck, NH can make a national impact on Libertarian politics this year and for 2016. The GOP and Dems are worried, we're being lobbied not to run any candidates, especially up-ticket. I recruited some candidates and am working on fundraising, including Bitcoin and other alternative currencies.

Our convention will be March 8th at Area 23 in Manchester (a libertarian-owned meeting space). We'll nominate candidates for 2014, encourage members to be delegates to the national convention, and likely run a Who's Driving game.

Our goal is to complete petitioning in March so we can spend our time and money on campaigns, particularly for Governor and US Senate, our ballot access races (4%). The second draft of the plan is in review.

Town elections are March 11th. There are usually a few Libertarians running, but they rarely tell us, so I hope to have good news to report next time.



Membership

The number of registered Libertarians continues to climb, we're now at a 7-year high! We've seen a 22% growth in the last year! We are 81% larger than the Green Party.

Activity, News and Events

We are resurrecting a show we used to run on Cable Access. *Third Point of View* – *Next Generation.* The shows will be much shorter and geared for YouTube viewing.

We had a private concert featuring Jordan Page on November 15th.

We are planning a Constitution Class in April featuring Michael Badnarik.

The NJLP has moved to a more reliable server.

We are regularly commenting on the active political scene in the Garden State, focusing on hypocrisy in the Christie administration, such as pension reform.

Prison mistreatment of inmates has become a bigger issue thanks to information being shared by recently released inmates.

A lot of effort on opening up local government, from better minutes of executive sessions to opening up more closed meetings and records.

Convention

The Convention will be Saturday, March 29th from 9am to 6pm at Tavern on the Lake in Hightstown. The Party's Business Meeting will be in the morning and will be open to all. Speakers include Dr Walter Block, Dr Murray Sabrin, Dr Mary Ruwart, Dimitri Vassilaros, and Daniel Zolkinov.

Private Charity vs Government, Update

Steve Uccio and the NJLP ran a fund-raiser to give Heat for the Homeless! In Lakewood, a community of 100 people live in a wooded area called "Tent City". They have nowhere else to go, aren't asking for government assistance, they are supported by private charity to better themselves. The city harassed them, passed an ordinance banning outdoor fires. One freezing November morning, police came and gave warnings never to use wood stoves, their main source of heat.

The fundraiser was a huge success! With as little as \$5 from one person and as much as \$150 from another, we received donations from Jersey to Germany. We beat our goal by 30% and the people of Tent City have propane heaters and enough fuel money for at least a month!



Making the News

State Chair Mike Rollins was quoted in the Providence Journal-Bulletin on Nov 24th for a question he asked at a meeting of the joint commission to study repeal of the state sales tax.

Rollins asked "How many members of the committee have ever in their entire lives saved their receipts from out-of-state purchases, and at the end of the year, tallied up how much they supposedly owe in the so-called use tax and actually paid the stupid use tax?" The chair ruled Rollins' question out of order, saying the responses "would be incriminating, and I love my committee."

At least he got a mostly honest answer.

Fun and Games and Liberty

On Saturday, Feb 8th, Tony Jones hosted a second "Liberty Drinks", building on our first great event in November. More than 50 people attended and folks drove as far as 100 miles to be here. It was great to meet people and discuss issues relating to turning the country towards a libertarian future. There were a variety of groups represented including LPRI, the Free State Project, Regulate RI (a marijuana legalization group) and Liberty Love Fest. We took lots of pics!

RIP Karen Kiren

Karen Kiren, Vermont Libertarian Attorney General Candidate, died in January. She ran for AG in 2004, 2008 and 2010.

Karen felt that we had too many laws and regulations that intruded on our liberty to use our own personal property as we see fit and costing the state much needed jobs. join other states in suing the federal government to overturn it.

Karen was a very committed and passionate candidate. She ran for office even in poor health, traveling the state, attending state committee meetings, campaigning and fighting for victims and for what she felt was right, despite her personal suffering and poor finances.

Members are working on a legislative review system to facilitate activism at statehouse.

The Vermont LP held its town caucuses on September 18th. We formed enough to maintain our status as a minor party, so no need to petition in 2014.

Catch *The Woodchuck Report* on Channel 17 at 5:25pm every 2nd Friday. Bonnie Scott and Ruel Wheelock talk about the issues of the day with a Libertarian perspective.

Local elections are March 4th. The VTLP is working with other groups to stop three guncontrol initiatives in Burlington (#6, #7, #8). Even if the initiatives pass, each is vulnerable in court, but the goal is to generate enough attention, including media buys to stop them at the ballot box. Along the way, a Democrat activist changed sides when he saw how well he was treated by libertarians compared to his former team for supporting RKBA.

Our state convention will be Saturday, April 26th at Zachary's Pizza, South Burlington. Details are in the works, but currently looking at candidate and activist workshops.

REGION 5S REPORT

Region 5S Representative, Libertarian National Committee

This report will provide information concerning activities of the Libertarian Party state affiliates in Region 5S since the LNC meeting on Dec. 14-15, 2013. I shall provide an updated report at the LNC meeting in Alexandria should additional information become available.

I am pleased to report that I have been able to represent the LP in various ways since the previous LNC meeting. For example, I continue to serve as a frequent guest on a two-hour political talk show that airs on weekdays on WINA radio (1070 AM in Charlottesville, Virginia).

Delaware

Scott Gesty (gesty4congress@aol.com), chair of the Libertarian Party of Delaware, said the LPD will hold its state convention in Dover on March 8. He noted that LPD is looking into improvements of its website. The party is recruiting candidates for the 2014 elections.

District of Columbia

Ryan Sabot (<u>ryan.sabot@dclibertarians.org</u>), chair of the Libertarian Party of the District of Columbia, provided the following report:

We have put together an extremely large slate of candidates in DC; we have candidates running for nearly every single partisan race in the District. Our goal, ultimately, is to meet the threshold so that we can continue to possess ballot access and major party status.

There are many factors that could impact this, but I believe that we are doing our best to ensure a positive result. Our mayoral candidate, Bruce Majors, has worked tirelessly to recruit candidates and we have seen the party grow as a result. The media is paying attention to us, as we are brand new and have the second-largest slate of candidates in DC (more than the Republicans and Greens). We're excitedly looking forward to the primary and general elections.

We plan to have a convention in the first week of May; I am currently studying and working abroad until May 4, so, upon my return, we will have a convention to elect delegates for Ohio.

Maryland

Bob Johnston (<u>bob.johnston@live.com</u>), chair of the Libertarian Party of Maryland, provided the following report:

As of January, the Maryland Libertarian Party has 13,313 registered voters. At this time a year ago, the amount of registered Libertarian voters was 11,660. We are averaging 137 new registered voters per month.

The MDLP will be conducting a special Central Committee meeting on February 15 for the purpose of nominating candidates. The filing deadline is February 25. The MDLP currently has candidates for Governor, Lieutenant Governor, and the US House races in the 4th and 7th districts.

The Maryland LP will be conducting its annual convention at Squires Italian Restaurant in Dundalk, MD on Saturday, April 5. Speakers include Michael Cloud, Wes Benedict, Arvin Vohra, and Sharon Harris.

I am working with the state Board of Elections Director of Campaign Finance on a bill to lower the party retention threshold has been submitted to the General Assembly. This bill would allow a political party with at least 10,000 registered voters to retain ballot access. In addition, the bill would allow Independent Presidential candidates to get on the ballot with 10,000 signatures. Currently, a statewide Independent candidate must collect over 34,000 signatures, while a new political party only needs 10,000.

OP-ED's

Raise the Minimum Wage?

The laws of supply and demand cannot be broken. They cannot be changed by humans, by legislative bodies of humans or even by the executive orders of humans. The demand curve has a negative slope. That is, the more you charge for something the less will be demanded, and this is especially true of the cost of labor. When the minimum wage rises, anyone whose marginal productivity of labor is less that the new wage will lose their job. Nobody will hire an employee at \$10/hour to produce \$9/hour of goods. Whether these jobs will be discontinued or moved overseas, they will be lost to American workers.

It seems cruel and mean-hearted for our elected representatives to intentionally deprive workingclass Americans of their jobs. Do they not understand market economics? Do they not understand that we live in a global economic community? Do they really believe the government can dictate labor rates?

If the concept of a minimum wage is economically valid, why not raise the minimum wage to \$1,000,000/hour? Everyone could work for an hour then retire rich! The concept of a government imposed wage floor is invalid and serves as a slap in the face to members of our society on the lower rungs of the economic ladder.

The minimum wage distorts markets, misallocates capital and causes unemployment. It should be abolished.

Special Benefits for Government Contractors?

In his State of the Union speech Tuesday, President Obama announced special new benefits *only* for employees of government contractors. Via executive order, President Obama raised the minimum wage for employees of federal government contractors to \$10.10 per hour, a 32% increase over NC's current \$7.65 minimum wage.

No other workers in the country have this benefit. The cost of this political favoritism will easily be passed on from the contractors to the government and, finally, to the taxpayers. At a time when public sector pay and benefits are already significantly higher than their privately

employed counterparts, this executive order smacks of cronyism, political arrogance and economic ignorance.

Pennsylvania

Steve Scheetz (<u>cz85b@cz85b.com</u>), chair of the Libertarian Party of Pennsylvania, provided the following report:

This past board meeting, we voted to expand the LPPA's Facebook presence, and I am thrilled to say that this has inspired much discussion on the various issues! Currently, we are working on the LPPA webpage. We were building a new one, though the only difference between the old and the new was the platform it was built upon. There are people updating the information that has not been updated for years, and we are doing it both for the Joomla version as well as the new Wordpress version. Once we switch over, it will make life much easier, moving forward. The goal is to have a living front page filled with news reports and blog posts from PA Libertarians displaying our principles in action!

We have had people coming to the party who do not espouse the principles of the party, and then wonder why we are not flexible with said principles, and then scratch their head when we say something like: "Because they are our PRINCIPLES!" Well, I have been told that Libertarians will never win, so we should just support republican X or democrat y. My reaction? No words need be stated or typed. Instead, I will act in a way that helps LPPA county affiliates in order to gather more Libertarian candidates, for 2014, than we have had in the history of the LPPA for any election cycle!

The action of encouraging candidates to run also brings me to the reason for hosting the LPPA convention on February 22, 2014. Petitioning is able to begin March 12th, and for this reason alone, the date sold itself. Our candidates will have the longest period of time to gather signatures in 2014? It's a no brainer! We have a great list of speakers for the convention including Robert Fernandes radical school reform advocate, and Lemonade Freedom Day sponsor, Benjamin Gross (10th Amendment Group), and our Keynote Speaker will be Ernest Hancock. Ernest received a great deal of attention as a result of his abilities with regard to campaigning on a shoestring, and at the very least, THIS LIBERTARIAN intends to pick his brain during our conference!

Administrative update warning! (if you hate reading about administrative details, stop reading, otherwise, all have been warned!) We adopted a large number of changes to our policy manual that made the policies more clear, one of the more noteworthy is the fact that we have updated our method of communicating events like the convention from snail mail to e-mail so that we no longer have to spend \$500-600 to notify the membership regarding various events... HELLO 21st CENTURY!!! End of Administrative Warning...

During the ebb and flow of membership and various committees coming and going, we have had two committees disband. The Chairs of Cumberland County and Blair County informed the LPPA Secretary that they were no longer going to have a committee, and that was that.

However, both of these counties managed to gain new committees within a very short order. The first, Cumberland County, had its meeting on February 3^{rd} , and the second, Blair, had its meeting on the 7^{th} of February. David Moser helped to facilitate the process, and is continuing to help new counties come together.

There will be a great deal of news following the convention and a large number of Libertarian candidates for political office here in Pennsylvania.

Virginia

Bill Redpath (wredpath2@yahoo.com), chair of the Libertarian Party of Virginia, provided the following report:

The Libertarian Party of Virginia held its biennial convention on Saturday, February 8, 2014. The convention was held at the Hilton Garden Inn near Richmond International Airport. It was a single day convention, with a Friday night reception beforehand. The number of attendees was a high two digit number.

Robert Sarvis, the LPVA candidate for Governor in 2013, was nominated for US Senate in 2014. His opponents will be incumbent Democratic Senator Mark Warner and a Republican yet to be nominated. Former RNC Chairman Ed Gillespie and Northern Virginia financial analyst Shak Hill are seeking the nomination. A 10,000 valid signature petition drive must be completed by Tuesday, June 10.

Bill Redpath was elected the new Chair of the LPVA, while Jim Lark, Marc Montoni and James Curtis were reelected as Vice Chair, Secretary and Treasurer, respectively.

While the LPVA has only formally nominated one US House candidate (Xavian Draper in the District 1), I think that the LPVA will have a record number of US House candidates this year. The previous record is four candidates out of 11 US House districts. We do not have party status or a party petition in Virginia, so each candidate must get 1,000 valid sigs for US House. This hurts the number of candidates we can place on the ballot. Even with only 125 valid signatures needed for US House, we had only six Virginia House of Delegates candidates (out of 100 districts) last year, and at least two of them would not have made the ballot without petitioning help from others. I cannot rule out having all 11 districts covered with US House candidates, but I think that is unlikely.

Virginia has odd numbered year elections for state offices.

The latest numbers can be seen in the Membership Report, but when I recently checked the LPVA ranked fifth among all states in Sustaining Members of the National Party, even though Virginia currently ranks 12th in population among the states.

February 23, 2014

2014 is already proving to be a big year for the Libertarian Party of West Virginia. Below are a few of the highlights of our current projects, developments and campaigns.

WEBSITE:

In January, the LPWV launched our new website (built on the Nation Builder platform) – still resides at lpwv.org. This new site fully integrates twitter and facebook into our site and provides an all-inclusive system for donations and accounting, contacts management and recruiting, as well as a internal tracking system of all correspondence.

CONVENTION:

On March 8, 2014, we will be hosting our annual meeting and Nominating Convention. This will be a single day event feature:

- General Business of the LPWV
- Presentations from our 2014 Candidate Hopefuls
- Nominations: 2014 LP Candidates, Delegates to National, LPWV Excomm
- A Candidate Training Seminar (Bruce Majors)
- Carla Howell will present "Who's Driving"
- The first (annual) LPWV Awards Ceremony
- A catered luncheon, and more!

Portions of the convention will be streamed live on the LPWV website and YouTube.

We originally planned to allow online voting to the membership and the Registered Libertarian Voters throughout the state, but encountered too many possible issues in validation of the voting body to comfortably proceed with this process in 2014. However, we are still developing the software and plan to launch the voting platform in WV in 2016, and will make it available to all LP state affiliates.

Finally, invitations to the convention were mailed to the 1,529 Registered Libertarian Voters throughout the state. We anticipate a 3% conversion from Registered LP Voter to Full LPWV Member, which would yield 46 new members through this effort.

MEMBERSHIP:

Membership within the LPWV remains low. We currently only have 34 active members, 14 recently lapsed (typically renew at the convention). However, with our new website, our statewide opt-ins are currently at 196 receiving our email blasts (newsletter / announcements)

and 25,899 prospects (these are people who have made an action on our website, facebook, twitter or YouTube accounts that brought them into our database. We anticipate conversion to membership at 0.5% over 2014 which will increase our membership an additional 129 members.

Our realistic membership objective is 50 Active Voting Members by the General Election.

FUND RAISING:

This has historically been and remains the weakest element of our team. The LPWV is operating on an extremely limited budget. To date, we have around \$2,300.00 in our account and the convention is costing us \$8.00 per paying member (due to keeping ticket prices low enough to still have attendees). Not factoring in any potential donations generated through the convention, we anticipate our post convention funds to be approximately \$1,900.00.

Average attendance at our live meetings was 4-5 in 2012-2013. Since launching this new method of meeting, our average attendance is 14.

Region 6 Report to the LNC March 2014

Illinois: by Matt Skopek, chair

We have 2,387 members. A member is someone who wants to join the party, takes the party pledge, and maintains a current address. We have 10 active chapters, 2 that are forming and 1 that is inactive. We have been noticing membership growth of about 1.5 new members a day.

Our biggest problem at the moment is getting volunteers to be active. We have lots of new members express interest in volunteering, which we then follow up with calls, letters and emails. However it's still a low participation rate.

We have made lots of improvements and updates to our website and are continuing to do so. Our ballot access lawsuit is still wending its way through the courts.

At our convention last September we chose candidates for all seven statewide offices in the November 2014 election, because our lawsuit challenging the full slate requirement hasn't yet been decided. They are:

Governor - Chad Grimm
Lieutenant Governor - Alex Cummings
Secretary of State - Chris Michel
Treasurer – Matthew Skopek
Comptroller - Julie Fox
Senator - Sharon Hansen
Attorney General - Ben Koyl

In addition, Daniel Banna will be running for state representative in the 53rd district.

Our 90-day petitioning period runs from March 25 to June 23. We are planning to collect 42,000 raw signatures in order to ensure 25,000 valid signatures after the challenge process. Our Political Director, Lex Green, has put together a petition drive and fund-raising plan which will guide our efforts. We are trying to raise \$13,500 for ballot access. We began fund-raising the second week of February and have raised \$1,775 as of Feb. 22. We will again need to ask the LNC for financial assistance.

Our next convention will be Sept. 12-14 in the same hotel we used last year in Bolingbrook.

Iowa: by Keith Laube, chair

We have 2,569 total members (ie. registered Libertarians) in our state chapter, and 171 voting (ie. dues paying) members. We have one active chapter and one forming. We notice continued interest in forming local groups at the county level. We are planning to have more county level meetings after the state convention. One recently established county chapter has met a few times.

Our next convention will be held March 22, 2014 in Des Moines, where we will be nominating candidates for the 2014 elections. Our current focus is trying to get more members to commit to

running for office. We had a 2nd candidate training session on February 22nd. We have a group of members that are actively meeting with a promising governor candidate and lieutenant governor candidate. We are planning to run 10 to 20 candidates and are in the process of getting commitment letters from more candidates.

To get on the ballot, we need varying number of signatures based on the office. The number of signatures is feasible to obtain. We need to get 2% of the vote for governor in 2014 to obtain "political party" status which would allow us to have primaries.

We are trying to increase registered Libertarian voters and members so we have a base of several thousand voters that we can reach out to. We need to get about 20,000 to 25,000 votes for governor to obtain 2% of the vote to retain ballot access. We are working with existing legislators and the Secretary of State Office to ensure that people are being offered the opportunity to register Libertarian in every county. An error in the state voter registration computer system has recently been corrected. The error incorrectly registered some people as non-party instead of their party. It is unknown how many libertarians this affected. The Secretary of State Office will be sending out notices to those whose voter registration came back as non-party during the past few years. We have mailed/e-mailed 2,600 libertarians to invite them to the state convention, join the state party and/or join the national party.

Nebraska: by Mike Knebel, co-chair

The Nebraska LP changed its leadership structure when State Chair Dave Hunt stepped down in late 2013. Gene Siadek took over duties as the Chair, and Scott Zimmerman and Mike Knebel assumed the duties of Co-Chairs. We have seen donations increase the last two quarters and have around \$2000 in the bank. This gives us the ability to help with the upcoming election. Our membership is approximately 5000 registered Libertarians in the state. Currently we have two active chapters under the LPNE: the Douglas County Party and the Western Nebraska Libertarians.

For the 2014 election we are fighting to maintain ballot access by supporting candidates in the state wide election that can garner the needed 5% of the vote. We have Mark Elworth Jr running for Governor and a paper candidate Andy Shambaugh running for the House in the Second Congressional District. With two weeks left until the filing deadline (March 1), we are still narrowing down candidates to run for the other state offices. Mark is making marijuana legislation his key issue, considering we are neighboring Colorado and they have had success in that area. We will also be informing the state that we are going to have an open primary for our party.

While we do not have a date yet for our state convention, we will be working with Tony Stiles at the Midwest Liberty Fest on May 31st.

Wisconsin: by Paul Ehlers, chair

We have about 175 members, with membership being determined by payment of dues. We have four active chapters. We are urging our Facebook "friends" to join the party. We have a mailing list of 700 people and are producing a Come to the Convention/Join the Party mailing. Our website is being revised, updated, and finalized as we speak.

All state-wide offices are up this year. Signatures need to be gathered between April 15 and June 2. We need 2000 signatures for each of the 5 state-wide races, 1000 for congress, 400 for state senate, and 200 for assembly. This year, the R's, D's and Constitution Party will each have their own column on the ballot, while we will be lumped in with the independents. If we get 1% in November we will have our own column on the ballot for 2016, but we will still need to gather the signatures. Although Joe Kexel got over 2% in his U.S. Senate race in 2012, only races in a gubernatorial election year count towards getting our own column.

Our biggest problem has been getting volunteers to go get signatures. This year we have contracted with Scott Kohlhaas to raise money and hire a professional signature gatherer. He already has raised \$20-25,000. We feel he will improve our ballot access situation, which the LNC is pushing us to do.

We have started a Liberty Coalition as a spin-off from the LP-WI Executive Committee to recruit candidates for the upcoming election. We have attracted significantly younger, more energetic libertarians. We are working with diverse groups (NORML, Renew Wisconsin) that share at least one liberty-minded principle with us. Our media coverage has mostly been in local papers. The Madison papers covered the RENEW Wisconsin press release.

The goal of the Liberty Coalition is to enable voters to see L's all over their ballots. On Feb. 17 we held a press conference in the rotunda of the state Capitol to announce the Liberty Coalition and our Candidate Bomb. We plan to seek candidates for all the open offices from state assembly and up. We are hoping to run 122 candidates: Governor, Lt Governor, Secretary, Treasurer, Attorney General, 8 for US congress, 93 for state assembly and 16 for state senate. In the past we focused on ballot access as the way to get candidates. For this election, we are focusing on running candidates as a way to get ballot access. Unfortunately there was no major media at our event. Only 5 independent journalists showed up, so we are trying to write letters to the editor and use social media to get the word out. We are asking people to refer themselves or someone else to run against the status quo.

About ten years ago, Ed Thompson ran for governor and got 10% of the vote. We were expecting him to increase voter turn-out, but it didn't happen and our hearts were broken. Apparently people who don't vote won't come out for a third party. So now we tell the truth, which is that we take votes from both D's and R's. We hope that by doing so we will move the pendulum back to liberty. We take as our example the socialists, who never got elected but managed to push the nation towards socialism.

Our next convention will be held on April 12, in Wausau, Wisconsin. This past year we had a booth at the Midwest Renewable Energy Fair and the Midwest Harvest Festival. The trend we notice is that practicality is finally trumping ideology.

Region 7 Report.

Alabama, Louisiana, Mississippi, Oklahoma, Texas.

Alabama.

The Libertarian Party of Alabama is petitioning to get on the ballot county by county. Where the petitioning succeeds, candidates may appear on the ballot for the November election for county offices and for offices in multi-county districts within the qualified counties. For example, the party has succeeded in Jefferson County, where it is recruiting candidates.

The LNC Executive Committee voted February 6 to spend \$12,500 to hire petitioners to qualify the party in the remaining counties. The Alabama L.P. will spend \$2,500 and a political action committee is spending \$10,000.

The state party is publishing "The Unofficial Newsletter of the Libertarian Party of Alabama," The Quill. The name is a reference to the porcupine logo.

The 2014 state convention on Saturday, May 10, will be held in Birmingham at the state party headquarters, 2330 Highland Avenue.

Alabama will send up to 13 delegates to the national convention.

CAMPUS ORGANIZING REPORT

This report will provide information concerning efforts to build and support Libertarian campus organizations. I shall provide an updated report at the LNC meeting in Charlotte should additional information become available.

- 1) I continue to respond to inquiries from people who want information about the LP campus outreach effort. I am usually able to respond within 24 hours of receiving an inquiry. I am pleased to note that the standard deviation of the response time has decreased somewhat recently, although there are still some times when I am unable to respond for 2-3 days.
- 2) I continue to work with the Advocates for Self-Government to provide material (e.g., "Operation Politically Homeless" kits) to campus organizations. (In the interest of full disclosure, please note that I am the chairman of the Board of Directors of the Advocates.)
- 3) I continue to work with various state and local LP organizations to assist their campus outreach efforts. For example, I continue to work with J.J. Summerall of the Libertarian Party of North Carolina to promote the LPNC on campuses in North Carolina. I am investigating opportunities for conducting campus organizing tours during the fall.
- 4) I continue to work closely with Students For Liberty to build libertarian groups at high schools and colleges. (I am a member of the Board of Advisors of SFL.) As part of this effort, members of the SFL board and I have found ways for the LP to use the many services available from SFL. We must be careful in so doing because we do not wish to jeopardize the 501c(3) status of SFL.

In addition, I serve as chair of the Student Libertarian Alumni Committee (SLAC). This organization assists SFL by promoting the organization among libertarians and helping to raise funds for SFL.

I addressed the International Students For Liberty Conference on Feb. 14 in Washington, DC, and arranged for the LP to have an outreach table at that event. (Arvin Vohra was responsible for organizing the table. Paul Frankel helped to staff the table, as did Carla Howell, Eric Dixon, and former LP vice chair Chuck Moulton.) I shall address the European Students For Liberty conference in Berlin, Germany, on March 16.

5) I continue to receive invitations to speak at high schools, colleges, and universities during the school year. For example, I gave a lecture entitled "Economic Fallacies" at James Madison University (Harrisonburg, Virginia) on Feb. 19; the event was sponsored by Madison Liberty.

- 6) I continue to work with Young Americans for Liberty (YAL) on programs of mutual interest. I gave an address at the YAL national conference in August. (According to Jeff Frazee, YAL executive director, I have a standing invitation to address YAL national conventions.)
- 7) As noted previously, several liberty-oriented organizations (e.g., Cato, Reason Foundation, Institute for Humane Studies, Foundation for Economics Education) work to coordinate their student outreach programs. I participate in meetings of representatives of these organizations when my schedule permits.
- 8) I am investigating options concerning advertising aimed at college-age students. In particular, I shall work with the campaign of Robert Sarvis in his campaign for the U.S. Senate in Virginia to advertise the Libertarian Party to students.
- 9) While the arrangements have not been finalized, I consider it likely that I shall conduct a workshop on campus organization at the LP national convention in Columbus.

EMPLOYMENT POLICY AND COMPENSATION COMMITTEE REPORT

Region 5S Representative, Libertarian National Committee Chair, Employment Policy and Compensation Committee

The members of the Employment Policy and Compensation Committee (EPCC) are Mark Hinkle, Jim Lark, and Bill Redpath. The members were appointed to the Committee by Geoff Neale on May 9, 2013.

The EPCC is working to prepare a revised employee manual. In a previous report, the EPCC established a goal of delivering the manual to the LNC no later than Dec. 31, 2013. However, given some of the issues raised by the Audit Committee last year and the desire to prepare a high-quality document that is in compliance with all applicable laws, it has taken much longer to prepare the revised manual than anticipated.

The EPCC recently distributed a message to staff members. The message informed the staff that the EPCC is available to discuss (on a confidential basis) the working environment or observed violations of the Policy Manual. Since the EPCC is specifically charged with the responsibility to be available to the staff for this purpose; we felt the staff members should be clearly informed of that availability.
