## **NEW BUSINESS WITHOUT PREVIOUS NOTICE**

### **SNOWDEN RESOLUTION**

***Mr. McMahon read aloud the following resolution for the LNC's consideration:<sup>2</sup>***

***Whereas, Edward Snowden did on June 5th, 2013, risk his own life, safety, and security to publicly expose the US Government's unlawful and unconstitutional domestic and mass surveillance programs;***

***Whereas, A US federal court held that the US Intelligence's mass surveillance program exposed by Mr. Snowden was illegal and possibly unconstitutional;***

***Whereas, Mr. Snowden tried to raise his ethical concerns on the NSA's mass surveillance program through internal channels but was ignored;***

***Whereas, Mr. Snowden, the Libertarian Party, and the American people, are aware of the brutal treatment by the US government of whistleblowers;***

***Whereas, The Espionage Act of 1917, which Mr. Snowden has been charged under, does not account for the illegal and abusive activities conducted by the US Government or its direct correlation to the alleged crimes Mr. Snowden has been charged with;***

***Whereas, The Libertarian Party has long held and defended the rights of all people to be free from unwarranted and unlawful government surveillance and spying; and***

**Whereas, The Libertarian Party Platform states “1.3 Privacy: Libertarians advocate individual privacy and government transparency. We support the rights recognized by the Fourth Amendment to be secure in our persons, homes, property, and communications. Protection from unreasonable search and seizure should include records held by third parties, such as email, medical, and library records.”; now therefore, be it**

**Resolved, That the Libertarian Party calls on President Joseph Biden to grant an immediate and unconditional Presidential pardon to the privacy advocate and political prisoner in exile, Mr. Edward Snowden; and**

**Resolved, That the Libertarian National Committee directs the Libertarian National Committee Chair to submit and publish a formal letter addressed to the President of the United States and sent to the White House and the US Justice Department calling for the immediate and unconditional Presidential pardon to the privacy advocate and political prisoner in exile, Mr. Edward Snowden.<sup>3</sup>**

## DEFEND THE GUARD RESOLUTION



*Mr. Clark read aloud the following resolution for the LNC's consideration:<sup>5</sup>*

***Whereas, Article I, Section 8 of the Constitution of the United States vests in the United States Congress the exclusive power to declare war;***

***Whereas, In spite of the clear language of the U.S. Constitution, vesting the power to declare war exclusively in the U.S. Congress, the U.S. Executive Branch has unconstitutionally assumed that power while the Congress has abdicated its constitutional duty;***

***Whereas, The Father of the Constitution, James Madison, wrote, "The Constitution supposes, what the History of all Governments demonstrates, that the Executive is the branch of power most interested in war, and most prone to it. It has accordingly with studied care vested the question of war to the Legislature.";***

***Whereas, Although the U.S. Congress has not declared war since 1942, the nation has since gone to war repeatedly at the whim of the Executive Branch; and***

***Whereas, When such unconstitutional actions are taken by the federal government, it is the proper role of the states themselves to take action to remedy such situations, as outlined in the Kentucky and Virginia Resolutions of 1798; now, therefore, be it***

***Resolved, That the Libertarian National Committee:***

***1. Calls upon the State Legislatures to enact legislation to prohibit the States' National Guard and any member thereof to be released from the state into active duty combat unless the U.S. Congress has declared war pursuant to Article I, § 8, Clause 15 of the U.S. Constitution, and only for the express and explicit purposes enumerated in the Constitution: to "execute the Laws of the Union," repel an invasion, or suppress an insurrection;***

***2. Calls upon the Legislatures and Governors of the States not to comply with any order from the federal government to release the State's National Guard into federal service unless the U.S. Congress has declared war pursuant to Article I, § 8, Clause 15 of the U.S. Constitution, and only for the express and explicit purposes enumerated in the Constitution: to "execute the Laws of the Union," repel an invasion, or suppress an insurrection; and***

**3. Further, calls upon the States to bring home said National Guard troops already so deployed to foreign conflicts immediately.<sup>6</sup>**

***Whereas, the Southern Poverty Law Center has defamed the Chair of the Libertarian Party and several other great members in an attempt to slow the progress of freedom,***

***Be it resolved, that the Libertarian National Committee condemns the Southern Poverty Law Center as irrational and repugnant.***

***WITHOUT OBJECTION, Mr. Ford moved to amend to add a phrase to the first clause as follows:***

**Be it resolved, that the Libertarian National Committee condemns the Southern Poverty Law Center as irrational and repugnant.**

**Mr. Nekhaila moved to postpone definitely until our next electronic meeting which **FAILED** by a show of hands.**

**Mr. Nekhaila moved to amend to add an additional whereas clause stating, “Whereas, the Libertarian National Committee rejects the false left/right paradigm and embraces its roots as being socially and economically libertarian.”**

**RESCIND AND EXPUNGE FROM MINUTES CENSURE OF JOSHUA SMITH**



*Ms. Harlos moved that the LNC rescind the January 2022 censure of Joshua Smith and direct the Secretary to expunge from the minutes. [20220529-05]*

The LNC heard from Parliamentarian Richard Brown on the parliamentary definition of “expungement” to allay concerns that this motion would have the effect of revising history, and he explained in concurrence with Ms. Harlos that this is a parliamentary procedure to express the strongest disapproval of an action.
