## NEW BUSINESS WITH PREVIOUS NOTICE

### JOINT FUNDRAISING AGREEMENT WITH RFK, JR. CAMPAIGN

Chair McArdle gave a public explanation of the proposed agreement.

***WITHOUT OBJECTION, Chair McArdle moved to go into Executive Session to discuss the details of creating a joint fund-raising committee with the Robert F. Kennedy Jr campaign with the caveat that some additional details about the joint-fundraising committee will be made public after the agreement is signed and the committee is created.***

Secretary Harlos stated that she does not consent to attend the Executive Session as she fully believe the proposed action would violate the Bylaws, and if passed, she intended upon filing an appeal with the Judicial Committee and did not wish to have any knowledge that an average member would not have.<sup>4</sup> It is noted the Mr. Darr also did not attend the Executive Session, but there was no reason articulated on the record whether this was intentional or for any specific reason or objection.

## EXECUTIVE SESSION

***WITHOUT OBJECTION,*** the Executive Committee went into Executive Session for the reasons given above with the rest of the LNC (minus those noted absent) attending.
